Report on the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the BetterHealth: A Planned Parenthood Partnership 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. (1) DESCRIPTION OF PLAN

The following description of the BetterHealth: A Planned Parenthood Partnership 401(k) Plan (“*Plan*”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

A. General

The Plan is a defined contribution plan covering substantially all employees of BetterHealth: A Planned Parenthood Partnership (“*BetterHealth*”). The Plan was adopted August 11, 2023. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (*ERISA*). All employees who have attained the age of 21 and have completed three months of service are eligible to participate in the Plan.

B. Contributions

The Plan provides for both employer and employee contributions. BetterHealth contributes a safe harbor contribution of 3% of each participant’s compensation on a per payroll basis, regardless of whether the participant elects to make salary deferrals. In addition, the Plan documents stipulate that BetterHealth may elect to make a discretionary matching contribution. The Employer may contribute a discretionary match of up to 4% of compensation, calculated on participant elective deferrals up to 6% of compensation, as determined each payroll period.

Eligible participants can elect to defer any amount of their salary up to the maximum allowable deferral. For plan years ended December 31, 2024 and 2023, the maximum allowable elective deferrals were \$23,000 and \$22,500, respectively. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

C. Participants Accounts

Each participant’s account is credited with the participant’s contribution, the Plan’s match, and allocation of the Plan’s earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

D. Vesting

Participants are immediately vested in their contributions, the safe harbor contributions, rollover contributions and actual earnings thereon. Vesting in the Organization contribution is based on years of continuous service. A participant with one year of service is 20% vested in the nonelective and additional matching employer contribution portion of the account. Each year, a participant gains another 20% vesting until the participant is 100% vested after the fifth year of credit service.

E. Participant Loans

The Plan permits participants to borrow funds against vested account balances. In general, the maximum amount that can be borrowed is the lesser of 50% of a participant’s vested interest or \$50,000, at a reasonable rate of interest. Loans are generally repaid within five years. Interest is charged at the prime rate plus 2% which is set upon the date the loan agreement is executed. Interest rates ranged from 4.24% to 9.50% for both the year ended December 31, 2024 and the period August 11, 2023 to December 31, 2023. The amounts outstanding as of December 31, 2024 and 2023 were \$90,528 and \$61,654, respectively. Participant loans deemed distributed were \$1,757 during the period August 11, 2023 to December 31, 2023.

F. Investment Options

Upon enrollment in the Plan, and at any time during the plan year, a participant may direct all future employee and employer contributions into any of the investment options available under the Plan.

G. Payment of Benefits

A participant's vested benefits will normally be distributed to the participant or the participant's beneficiary upon retirement, disability or death of the participant, by transfer to another qualified plan or individual retirement account, through a lump sum distribution or in installment payments.

In-service withdrawals of all or a portion of a participant's vested account balance may be made by participants who have attained the age of 59-1/2. Hardship withdrawals from a participant's deferral contribution accounts are permitted when certain criteria are met. In-service withdrawals of all or a portion of a participant's rollover account balance may be withdrawn at any time.

H. Administration

BetterHealth is the administrator of the Plan. Empower Retirement has been designated as the custodian and trustee of the Plan. Empower Retirement maintains individual participant account records and advises the Plan on other matters related to the operation of the Plan.

G. Forfeitures

Forfeitures resulting from the non-vested portions of participants' accounts who terminate prior to being fully vested are used to reduce future BetterHealth contributions. During the year ended December 31, 2024 and for the period August 11, 2023 to December 31, 2023, employer contributions were reduced by \$684 and \$2, respectively, from forfeited non-vested accounts.

(2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

BASIS OF ACCOUNTING

The financial statements of the Plan are prepared under the accrual basis of accounting.

INVESTMENT VALUATION AND INCOME RECOGNITION

The Plan's investments in mutual funds and collective investment trusts are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

USE OF ESTIMATES

The preparation of the financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

PAYMENT OF BENEFITS

Benefits are recorded when it has been determined that a distribution will be made.

OPERATING EXPENSES

BetterHealth pays costs associated with maintaining and administering the Plan.

(3) INVESTMENTS

The Plan's investments are held in a directed trust. There are several investment options available to the participants at the time of this report. Participant accounts are allocated based on the decisions of the individual participants. The following tables present the fair value of these investments which have been certified by the Plan's custodian and trustee:

(4) FAIR VALUE OF FINANCIAL INSTRUMENTS

The Plan utilized various methods to measure the fair value of its investments on a recurring basis. Generally accepted accounting principles establish a hierarchy that prioritizes inputs to valuation methods. The three levels of inputs are described below:

Level 1 – Unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.

Level 2 – Observable inputs other than quoted prices included in Level 1 that are observable for the asset or liability, either directly or indirectly. These inputs may include quoted prices for the identical instrument on an inactive market, prices for similar instruments, interest rates, prepayment speeds, credit risk, yield curves, default rates and similar data.

Level 3 – Unobservable inputs for the asset or liability, to the extent relevant observable inputs are not available, representing the Plan's own assumptions about the assumptions a market participant would use in valuing the asset or liability, and would be based on the best information available.

The inputs methodology used for valuing securities are not necessarily an indication of the risk associated with investing in those securities.

(5) COLECTIVE INVESTMENT TRUSTS

The plan has a collective investment trust that invests primarily in a diversified portfolio of investment contracts issued by insurance companies and other financial institutions, as well as high-quality fixed-income securities. The fund seeks to provide preservation of principal, liquidity, and current income consistent with stable principal value.

Collective investment trusts are valued at the net asset value per unit as a practical expedient for fair value, as reported by the fund's trustee. The net asset value is based on the fair value of the underlying assets in the trust, less liabilities, divided by the number of outstanding units. There are no redemption restrictions for participant transactions; however, the Plan may be required to provide notice (e.g., 12 months) prior to full withdrawal from the collective investment trust.

At December 31, 2024 and 2023, the Plan's investment in the collective investment trusts totaled \$11,347 and \$2,150, respectively.

(5) PLAN TERMINATION

Although it has not expressed any intent to do so, BetterHealth has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

(6) TAX STATUS

The Plan, established under a prototype plan to hold the Plan's assets, is qualified pursuant to the appropriate section of the Internal Revenue Code, and, accordingly, the Plan's net investment income is exempt from income taxes. Although the Plan has been amended, the Plan sponsor believes that the Plan continues to qualify and to operate as designed.

Management has reviewed the tax positions of its open tax year (2023) or expected to be taken in the Plan's 2024 tax return and has concluded that there are no uncertain tax positions that would require recognition in the financial statements.

(7) RISKS AND UNCERTAINTIES

The Plan invests in shares of registered investment companies which employ various investment strategies. The investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

(8) PARTY-IN-INTEREST TRANSACTIONS

Certain administrative costs of the Plan are paid by the employer/sponsor.

(9) RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

There were no material differences between the audited financial statements and the Form 5500 filed for the period August 11, 2023 (commencement of operations) to December 31, 2023.

(10) SUBSEQUENT EVENTS

Subsequent events after the statement of net assets available for benefits date through the date that the financial statements were available for issuance, October 13, 2025 have been evaluated in the preparation of the financial statements and management has determined that there were no subsequent events that would require disclosure or adjustment in the financial statements.
