Accounting estimates are an integral part of the financial statements prepared by management and are based on management’s knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected. The most sensitive estimate affecting the financial statements was:

The disclosure of the information certified the qualified institution, in Note 3 to the financial statements. We did not perform any auditing procedures with respect to such information, except for comparing such information with the related information included in the financial statements and supplemental schedule.

The disclosure of the measurement of fair value for each investment held by the Plan in Note 4 to the financial statements. The Plan followed the guidance of ASC 820, which requires that the Plan disclose how it determined the fair value of its investments by three levels of inputs. As described in Note 2 to the financial statements, the three levels of inputs are: 1) quoted prices in active markets, 2) significant observable inputs, and 3) significant unobservable inputs.

The disclosure of the party-in-interest transactions in Note 6 to the financial statements, which describes the relationship between the Plan and Empower Trust Company and the Plan's participants.

The financial statement disclosures are neutral, consistent, and clear.

Form 5500 Procedures

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditor's report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

Difficulties Encountered in Performing the Audit

We encountered no significant difficulties in dealing with management in performing and completing our audit.

Corrected and Uncorrected Misstatements

Professional standards require us to accumulate all misstatements identified during the audit, other than those that are clearly trivial, and communicate them to the appropriate level of management. Management has corrected all such misstatements. In addition, none of the misstatement detected as a result of the audit procedures and corrected by management were material, either individually or in the aggregate, to the financial statements taken as a whole. There were no uncorrected misstatements.

Reportable Findings

For purposes of this letter, a reportable finding is a matter that includes one or more of the following: (1) noncompliance or suspected noncompliance with laws and regulations, (2) a finding that in our professional judgment is significant and relevant to you regarding your responsibility to oversee the financial reporting process, and (3) an indication of internal control deficiencies identified during the audit that have not been previously communicated to management by other parties and that we determined are sufficiently important to merit management's attention.

We identified the following reportable findings that are considered significant and relevant to those charged with governance but are not considered deficiencies in internal controls:

Unallocated Forfeited Participant Accounts

During our audit, we noted that as of December 31, 2024, the Plan had accumulated \$102,970 of unallocated forfeited participant accounts that had not been utilized. The Plan document has established guidelines for the use of forfeited participant accounts. In addition, the Internal Revenue Code (“IRC”) requires that these forfeited accounts be used or reallocated to Plan participants in accordance with the terms of the Plan document in the Plan year they are incurred. The Company should use or reallocate these forfeited accounts as soon as possible. In addition, the Company should consider consultation with ERISA counsel to determine if an official correction is necessary to ensure the Plan remains in compliance with ERISA and IRC regulations.

Plan Sponsor not meeting fiduciary duties (board minutes)

During our audit, we noted that the Plan Sponsor did not have minutes documenting its fiduciary duties of plan oversight. ERISA sets standards of conduct for plan sponsors and looks for written evidence that the standards are met and that the Plan is being properly managed. We recommend Plan management implement a policy to document meetings and any important decisions or discussions held during the year.

Missing personnel files

During our audit, we were unable to locate personnel files for certain participants. Improper record retention could lead to incorrect eligibility determinations or withdrawal calculations. We recommend the Plan enhance its controls over the retention of employee personnel files for all participants. The files should be retained in a secure location and filed centrally, if necessary. Additionally, we suggest that Plan management conduct audits of the employee personnel files throughout the year to ensure they have been retained and can be easily located.

Disagreements with Management

For purposes of this letter, a disagreement with management is a disagreement on a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditor’s report. We are pleased to report that no such disagreements arose during the course of our audit.

Management Representations

We have requested certain representations from management that are included in the management representation letter dated October 10, 2025.

Management Consultations with Other Independent Accountants

In some cases, management may decide to consult with other accountants about auditing and accounting matters, similar to obtaining a “second opinion” on certain situations. If a consultation involves application of an accounting principle to the Plan’s financial statements or a determination of the type of auditor’s opinion that may be expressed on those statements, our professional standards require the consulting accountant to check with us to determine that the consultant has all the relevant facts. To our knowledge, there were no such consultations with other accountants.

Other Audit Findings or Issues

We generally discuss a variety of matters, including the application of accounting principles and auditing standards, with management each year prior to retention as the Plan’s auditors. However, these discussions occurred in the normal course of our professional relationship and our responses were not a condition to our retention.

OTHER MATTERS

Our responsibility for the ERISA-required supplemental schedule accompanying the financial statements is to perform adequate procedures to evaluate whether the form and content of the ERISA-required supplemental schedule, other than that agreed to or derived from the certified investment information, is presented in compliance with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, and whether the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).
