### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

**1. DESCRIPTION OF THE PLAN**

The following description of the Headwaters Salons, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

*General*

Headwaters Salons, LLC (the Company or Plan Sponsor) established the Plan effective on January 1, 2016 as part of a controlled group which includes four additional participating employers. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is a qualified defined contribution plan covering substantially all employees except employees covered by a collective bargaining agreement, non-resident aliens who do not receive U.S. source income or leased employees.

Employees not otherwise excluded become eligible to participate after being credited with 1,000 hours of service. Employees may enter the Plan on January 1st or July 1st coincident with or following the date of meeting the eligibility requirements.

Effective January 1, 2022, the Plan was restated pursuant to the cycle three restatement period and includes an addendum intended as a good faith effort to comply with the requirements of the Further Consolidated Appropriations Act, including the SECURE Act provisions, the Coronavirus, Aid, Relief and Economic Security (CARES) Act and the Consolidated Appropriations Act.

*Plan Administration*

The administration of the Plan is the responsibility of the Plan Sponsor. All money that is contributed to the Plan is held for the benefit of the participants.

*Contributions*

Participants can make pre-tax elective deferrals and post-tax Roth elective deferrals into the Plan. Participants may contribute up to 100% of defined earnings, as limited by §402(g) of the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing rollover distributions from certain other qualified retirement plans. There were no rollover contributions for the years ended December 31, 2024 or 2023. Participants direct the investment of their contributions into various investment options offered by the Plan.

A safe harbor matching contribution is made to eligible participants equal to 100% of elective deferrals that do not exceed 3% of compensation, plus 50% of the deferrals that exceed 3% but do not exceed 5% of compensation. The Company made safe harbor matching contributions of \$216,256 and \$215,731 for the years ended December 31, 2024 and 2023, respectively.

*Participant Accounts*

Each participant's account is credited with the participant's contributions, employer contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*Vesting*

Participants are immediately 100% vested in their voluntary deferral contributions and safe harbor contributions plus actual earnings thereon.

*Payment of Benefits*

On termination of service due to death, separation of service or attainment of normal retirement age, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. A mandatory distribution may be made if the account balance is less than \$5,000.

In addition, the Plan allows for in-service distributions to participants over the age of 59 1/2 from all fully vested sources.

*Forfeited Accounts*

Forfeitures, if any, are retained in the Plan and are to be used to reduce employer contributions or pay Plan expenses. Forfeitures available to be used were \$0 for the years ended December 31, 2024 and 2023.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

*Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting.

*Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein. Actual results could differ from those estimates.

*Investment Valuation and Income Recognition*

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*Plan Expenses*

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Certain other investment related administrative fees are paid by the Plan and included in net appreciation (depreciation) in fair value of investments. Participants may be charged distribution fees upon withdrawal of their accounts.

*Contributions*

Contributions from Plan participants and the safe harbor matching contributions from the Company are recorded in the year in which eligible compensation was paid.

*Benefit Payments*

Benefits are recorded when paid.

**3. INFORMATION CERTIFIED BY THE CUSTODIAN**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investment information disclosed in the accompanying financial statements and schedule including investments held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, dividends, and gains on sales of assets for the year then ended were obtained or derived from information supplied to the Plan administration and certified as complete and accurate by American Trust Company, the custodian.

Accordingly, as permitted under such election, the following information was not subjected to any auditing procedures performed by the independent public accountants, except for comparing such information certified by the custodian to information included in the Plan's financial statements and supplemental schedule:

**4. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under the "Fair Value Measurements" under FASB ASC 820 are described as follows:

Level 1 - inputs to the valuation methodology are unadjusted quoted market prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - inputs to the valuation methodology include (a) quoted market prices for similar assets or liabilities in active markets, (b) quoted prices for identical or similar assets or liabilities in inactive markets, (c) inputs other than quoted market prices that are observable for the asset or liability, or (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - inputs to the valuation methodology that are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

*Registered investment companies:* Valued at the daily closing price as reported by the Fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

*Money market:* Valued at fair value based on the quoted net asset value held by the Plan at year end.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. PARTY-IN-INTEREST TRANSACTIONS**

The Plan paid service provider fees of \$26,565 and \$12,325 to AT Retirement Services, LLC as of December 31, 2024 and 2023, respectively. The Plan paid investment advisor fees of \$17,428 and \$15,582 as of December 31, 2024 and 2023, respectively. The Plan paid audit fees of \$0 and \$25,000 as of December 31, 2024 and 2023, respectively. The 2022 and 2021 audits were paid by the Plan in 2023.

**6. TAX STATUS**

The Plan is a non-standardized pre-approved profit sharing plan, which obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan Sponsor believe the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service or Department of Labor. The Plan administrator has analyzed the tax positions taken or expected to be taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no such tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**7. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts and the assets will be distributed to participants in proportion to their respective account balances.

**8. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**9. DELINQUENT PARTICIPANT CONTRIBUTIONS**

The Company remitted certain participant contributions to the Plan later than expected by DOL Regulation 2510.3-102. Late contributions identified totaled \$0 and \$41,230 for the years ended December 31, 2024 and 2023, respectively. Late contributions identified totaled \$75,987 for the year ended December 31, 2022 and \$61,397 for the year ended December 31, 2021.

**10. SUBSEQUENT EVENTS**

Management has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued. Management determined there were no subsequent events that required reporting in the financial statements.
