1. *Description of Plan*

The following brief description of the Questex LLC 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

General

The Plan is a defined contribution plan under Section 401(a) of the Internal Revenue Code (“IRC”), covering substantially all employees of Questex LLC and its subsidiaries (the “Company”), who are age twenty-one or older. The Plan was initially effective May 9, 2005. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Prudential Bank & Trust, F.S.B. for Plan activity occurring through October 20, 2023, and Empower Trust Company, LLC for activity thereafter (together, the “Trustee”) serves as the trustee for the Plan and holds certain assets of the Plan and Empower Annuity Insurance Company (“Empower” or the “Insurance Company”) provides recordkeeping and holds certain assets of the Plan.

Eligibility

Eligible employees (as defined by the Plan), who are 21 years of age are eligible to participate in the Plan. Eligibility for employer contributions additionally requires completion of one year of service as defined by the Plan. The Plan has an automatic enrollment feature that resulted in eligible participants being enrolled in the Plan with an initial deferral percentage of six percent at the earliest entry date after being provided forty-five days notice of pending automatic enrollment. Participants who enter the plan through automatic enrollment will receive a one percent increase annually up to a deferral rate of ten percent.

Contributions

Participants may contribute up to 100% of their pre-tax and Roth annual compensation, as defined in the Plan, subject to certain limitations as allowed under Section 401(k) of the IRC, as amended. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company, at its discretion, may make a contribution which will be allocated among participants eligible to share in such contribution. For the year ended December 31, 2024, the Company made a discretionary matching contribution totaling \$279,979.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, the corresponding Company contribution, if any and an allocation of Plan earnings. Each participant’s account is charged with an allocation of administrative expenses. Allocations are based on the participant’s account balance as defined.

1. Description of Plan (continued)

Vesting

Participants are immediately vested in their salary deferral contributions plus actual earnings thereon. Vesting for employer contributions and associated earnings is based on years of continuous service. A participant's accounts attributable to the matching contributions, if any, become 100% vested after five years, or upon termination of employment by reason of death or disability, as defined by the Plan.

Payment of Benefits

On termination of service due to death, disability, retirement or separation from service, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or in the form of installments as specified in the Plan. Withdrawals from the Plan may also be made upon reaching age 59½, in addition to circumstances of financial hardship, in accordance with provisions specified in the Plan.

Plan Expenses

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Certain other expenses are paid by the Plan and are recorded in the accompanying statement of changes in net assets available for benefits as administrative expenses.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid in level payments through payroll deductions.

Forfeitures

Any balance in the employer contribution account of a participant who has separated from service, to which he or she is not entitled, shall be used to reduce Plan expenses or the employer's contribution. The Plan used \$35,664 of forfeited nonvested accounts to reduce the Plan's employer match for the year ended December 31, 2024. The Plan used \$1,734 of forfeited nonvested accounts to reduce the Plan's expenses for the year ended December 31, 2024. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$5,407 and \$21,140.

2. Summary of Significant Accounting Policies

Revenue Credit Account

The Plan and Empower Insurance Annuity Company of America (“Empower”) entered into a revenue sharing arrangement whereby a portion of the revenue earned by the custodian for certain funds is passed through to the Plan for payment of permitted Plan expenses. In order for the Plan to receive credits as a result of this revenue sharing arrangement, and to use this credit to pay for Plan expenses, the Plan created a Revenue Credit Account. The Revenue Credit Account is an account within the Plan that is used to record the redistribution of plan-generated fund revenue that exceeds the costs associated with plan administration. The Revenue Credit Account balance was \$31,890 and \$20,544 as of December 31, 2024 and 2023. During 2024, \$0 was used to reduce Plan expenses, and \$0 was allocated to participants from the Revenue Credit Account.

Basis of Accounting and Use of Estimates

The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”), which requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

3. Summary of Significant Accounting Policies *(continued)*

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value except for the guaranteed investment account, which is stated at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. The common/collective trusts are valued using NAV as a practical expedient. The practical expedient is not used when it is determined to be probable that a fund will sell the investment for an amount different than the reported NAV. Pooled separate accounts are reported at the value reported to the Plan by the insurance company, which represents the fair value of the underlying investments comprising the account.

The investment contract held by a defined contribution plan is reported at contract value, which is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount the participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Realized gains and losses from security transactions are reported on the average cost method. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of the Plan are paid by the Plan sponsor and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and certain other fees are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of value of investments.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is October 7, 2025.

5. Common/Collective Trusts and Pooled Separate Accounts

Wilmington Trust Collective Investment Trusts

The Plan offers common/collective trusts called the Collective Investment Trusts (“CITs”). These CITs include: the International Equity Fund Fee Class I1, the Mid Cap Growth Fund CI I1, and the Small Cap Growth Fund II Fee Class I1. Wilmington Trust, N.A. serves as the trustee of the CITs.

MFS Mid Cap Growth Fund CL I1

The MFS Mid Cap Growth Fund CL I1 is a collective investment fund. Massachusetts Financial Services Company serves as the trustee.

The unit value of the common/collective trusts is determined on a daily basis. Units are issued and redeemed at their unit value. Net investment income and realized and unrealized gains and losses on investments are not distributed to participants but are reflected in the unit value. The common/collective trusts have no unfunded commitments at December 31, 2024.

Pooled Separate Accounts

The Plan offers various pooled separate accounts as investment options under the Plan. The pooled separate accounts have different investment objectives, investment policies, and risks. The name of each pooled separate account corresponds to the name of the underlying fund in which it invests. When contributions or transfers are made to a pooled separate account, the pooled separate account purchases shares in the appropriate underlying fund. The Plan's pooled separate accounts include various asset classes which are: large cap, bond, and small cap. As of December 31, 2024 and 2023, these investments were valued using level 2 inputs.

6. Investment Contract with Insurance Company

Certain Plan assets are invested in the Evergreen Group Annuity Contract Guaranteed Income Fund, which is a fully benefit responsive investment contract with Empower. Empower maintains the contributions in a general account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Because the guaranteed investment contract is fully benefit responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

6. Investment Contract with Insurance Company (*continued*)

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to Plan's prohibition on competing investment options, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

PRIAC is contractually obligated to repay the principal and the specified interest that is guaranteed to the Plan. The credit risk of the issuer was evaluated by nationally recognized statistical rating agencies as follows: Moody's Investor Service (Aa3 as of July 2025), Standard and Poor's (AA- as of July 2025) and Fitch (AA- as of July 2025).

7. Party-in-Interest Transactions

The Evergreen Group Annuity Contract Guaranteed Income Fund is managed by Empower, the Plan's custodian. The Pooled Separate Accounts are managed by Empower, the Plan's custodian. Therefore, these transactions qualify as exempt-party-in-interest transactions. Notes receivable from participants also qualify as exempt-party-in-interest transactions. Additionally, certain investment offerings of the Plan pay a quarterly revenue credit to participants holding such investments, with such credit reported as other additions in the accompanying statement of changes in net assets available for benefits.

8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer accounts.

9. Tax Status

The Company adopted a prototype 401(k) profit sharing plan. The Internal Revenue Service has issued a letter, dated April 29, 2014, which states that the form of the prototype plan qualifies under the applicable provisions of the IRC. Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC.

9. Tax Status *(continued)*

U.S. GAAP require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

10. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
