Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Chiptech, Inc. 401(k) Profit Sharing Plan & Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Notes to Financial Statements

1. Description of Plan

The following description of Chiptech, Inc. (“the Company”) Profit Sharing Plan & Trust (“the Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

General. The Plan is a defined contribution plan covering substantially all full-time employees of the Company who have 90 days of continuous service and are age 18 or older. Date of eligible participation occurs immediately upon meeting all eligibility requirements.

The Plan was established on January 1, 1998, under Section 401(k) of the Internal Revenue Code, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions. Each year, participants may contribute up to 75% of pre-tax annual compensation or up to 75% after-tax to a Roth, as defined in the Plan, subject to a maximum of \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, respectively. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company makes discretionary matching contributions equal to 100% of the first 1% of the participant’s eligible compensation. The Company may also make additional profit-sharing contributions. No additional profit-sharing contributions were made during the years ending December 31, 2024 and 2023.

Participant Accounts. Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contribution and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting. Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company’s discretionary matching and profit-sharing contributions is based on years of continuous service. A participant is 100% vested after three years of credited service for the Company’s discretionary matching contributions and six years of credited service for the Company’s discretionary profit-sharing contributions plus actual earnings thereon.

Notes Receivable from Participants. Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Under the CARES Act, plan participants were allowed to borrow up to 100% of the vested balance or \$100,000, whichever was less. The loans are secured by the balance in the participant’s account and bear interest at rates ranging from 9.0% to 9.50%. Principal and interest are paid ratably through payroll deductions.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

Investment Options. Upon enrollment in the Plan, a participant may direct their contributions into any of the investment options offered under the terms of the investment contract. There are several different mutual funds and investment options available to the participants.

Payment of Benefits. On termination of service due to death, disability, or retirement, a participant may elect to receive a lump sum payment paid directly to the participant or rolled over to an IRA, a partial “ad-hoc” distribution, or installment distribution but only with respect to the participant’s required minimum distributions. In the event of death or total and permanent disability, a participant’s account becomes fully vested.

The non-vested portion of a terminated participant’s account is forfeited and is applied to reduce future employer contributions or pay administrative expenses of the Plan. In addition, a participant can elect to receive all or part of their vested account at any time after reaching the age of 59 ½ or if the participant rolled over funds into this Plan from another qualified retirement plan.

1. Description of Plan (Cont'd.)

Administrative Services. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee received compensation from the Plan. Administrative expenses for the trustee are paid directly by the Company.

2. Summary of Significant Accounting Policies

Basis of Accounting. The financial statements are prepared using the modified cash basis of accounting. Contributions and interest income are recognized when collected and administrative expenses and benefits are recognized when paid.

Investment contracts held by a defined-contribution plan are required to be reported at fair value. The Statements of Net Assets Available for Plan Benefits present the fair value of the investment contracts. The Statements of Changes in Net Assets Available for Plan Benefits are prepared on a contract value basis.

Estimates. The plan administrator uses estimates and assumptions in preparing those financial statements in accordance with the modified cash basis of accounting. Those estimates and assumptions affect the reported amounts and disclosures. Actual results could vary from the estimates that were used.

Investment Valuation and Income Recognition. Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Forfeited Accounts. At December 31, 2024 and 2023, there were \$2,505 and \$433, respectively, of forfeited non-vested accounts. These accounts can be used to reduce future employer contributions and fees. Forfeitures of \$-0- and \$-0- were used to reduce employer contributions for the years ending December 31, 2024 and 2023, respectively.

Subsequent Events. The Company has evaluated subsequent events through October 3, 2025, the date these financial statements were available to be issued. There were no subsequent events requiring disclosure after the Plan's termination and merger into the new plan.

3. Plan Termination

During 2024, the Company decided to merge the Plan into an unrelated plan subject to the provisions of the Plan document and applicable regulations under ERISA and the Internal Revenue Code. As part of the termination process, the funds from the current Plan were transferred into the new plan in January 2025 and the current Plan was terminated.

4. Income Tax Status

The Internal Revenue Service has determined and informed the Company by a letter dated August 31, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC").

Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

4. Income Tax Status (Cont'd.)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service.

The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2022.

5. Risks and Uncertainties

The Plan provides for various investment options in any combination of stocks, bonds, fixed income securities, mutual funds, and other investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Plan Benefits and the Statements of Changes in Net Assets Available for Plan Benefits. The Company manages the Plan's credit risk by offering participants diversified investment options.

6. Information Prepared and Certified by the Trustee

Mid Atlantic Trust Company, the Trustee, holds all of the Plan's investment assets and executes transactions in the assets.

8. Fair Value Measurements

The applicable guidance provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under the applicable guidance are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- a) Quoted prices for similar assets or liabilities in active markets;
- b) Quoted prices for identical or similar assets or liabilities in inactive markets;
- c) Inputs other than quoted prices that are observable for the asset or liability;
- d) Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Cash and Cash Equivalents: Valued at the closing price reported in the active market in which the fund is traded.

Registered Investment Companies: Valued at the closing price reported in the active market in which the fund is traded.

8. Fair Value Measurements (Cont'd.)

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
