Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of 403(b) Thrift Plan for Employees of Pinebrook Family Answers, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. - the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of 403(b) Thrift Plan for Employees of Pinebrook Family Answers and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about 403(b) Thrift Plan for Employees of Pinebrook Family Answers' ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about 403(b) Thrift Plan for Employees of Pinebrook Family Answers' ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedules Required by ERISA

The supplemental Schedule H, Line 4i - Schedule of Assets (Held at End of Year) and Schedule H, Line 4a – Schedule of Delinquent Participant Contributions as of or for the year ended December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including its' form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of Plan

The following description of the 403(b) Thrift Plan for Employees of Pinebrook Family Answers (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of Pinebrook Family Answers (the “Organization”). All employees of the Organization are eligible to contribute upon hire. Employees who have reached twenty-one years of age, and completed 1 year and 1,000 hours of service are eligible for any employer contribution. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Board of Directors is responsible for oversight of the Plan. The Finance Committee determines the appropriateness of the Plan’s investment offerings, monitors investment performance and reports to the Plan’s Board of Directors.

Contributions

Each year, participants may contribute a portion of their compensation, as defined in the Plan, subject to certain limitations under the Internal Revenue Code (IRC). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers), as well as designated Roth contributions.

The Organization makes matching contributions equal to 100% of the amount of eligible participants’ elective deferrals, up to 2% of the participants’ compensation. The Organization may make additional contributions at the discretion of the Board of Directors annually.

Participants direct the investment of contributions into various investment options offered by the Plan.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, any rollover contributions, and allocations of the Organization’s matching contribution, Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are vested immediately in their contributions plus earnings thereon. Participants hired prior to October 1, 2014 vested immediately in all contributions plus actual earnings thereon. For participants hired after October 1, 2014, vesting in Organization contributions are based on years of service. One year of service is defined as a period of twelve consecutive months of employment, with 1,000 hours of service. A participant becomes 100 percent vested after four years of credited service, as follows:

<u>Full Years of Service</u>	<u>Vesting Percentage</u>
Less than 2 Years	0%
2 Years	25%
3 Years	50%
4 Years or more	100%

In addition, regardless of the vesting schedule, participants shall become fully vested upon death or total and permanent disability.

Notes Receivable from Participants

Participants may borrow from their employee contribution accounts, except those attributable to Roth contributions, up to the lesser of \$50,000 or 50% of their vested non-Roth account balance. Only one loan may be outstanding at any one time. The loans are secured by the balance in the participant's account and bear interest at a specified market rate as determined periodically by the Plan administrator. Principal and interest is repaid ratably through monthly payroll deductions.

Payment of Benefits

The Plan allows participants to make in-service withdrawals at age 59½, at normal retirement age, and withdrawals from rollover contribution accounts. The Plan allows participants to make hardship withdrawals from salary reductions and rollover contribution accounts.

Investment Elections

Upon enrollment in the Plan, a participant may direct contributions in any of a number of investment options of Mutual of America Life Insurance Company.

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

2. Summary of Accounting Policies

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully-benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on the investments bought and sold as well as held during the years.

The Plan invests in the Mutual of America Interest Accumulation Account, an insurance company general account, the underlying substance of which is considered to be embedded in a guaranteed investment contract, as well as a TIAA investment contract. The contracts are fully benefit responsive ("FBR"). In accordance with accounting principles generally accepted in the United States of America, the insurance company investment contracts are reported at contract value. As a result, The Statement of Net Assets Available for Benefits presents the contract values of the guaranteed investment contracts.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Benefit Payments

Benefits are recorded when paid.

Forfeitures

Forfeited non-vested accounts totaled \$-0- as of December 31, 2024 and 2023. These accounts are to be used to reduce future employer contributions. During the years ended December 31, 2024 and 2023, forfeitures applied to employer contributions were \$-0- and \$138, respectively.

Plan Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) of fair value of investments.

3. Fair Value Measurements

Accounting principles generally accepted in the United States of America, establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820-10 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Investments classified within Level 3 whose fair value measurements consider several inputs may include Level 1 and/or Level 2 inputs as components of the overall fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Insurance Company Separate Accounts: Valued at the net asset values (NAV) of units held by the Plan based on the fair value of the underlying funds less account charges under the contracts, as determined by the issuer, Mutual of America Insurance Company. A group of the various separate accounts each invests in a single mutual fund valued daily at their published NAV and are Level 2 investments in the hierarchy table. The other group of accounts each invests in a variety of underlying investments that are valued using market quotations as well as pricing sources that may employ various pricing methods to value the investments. These accounts are not leveled as they do not meet the readily determinable fair value criteria. These separate accounts are registered investments that invest principally in equity securities, fixed-income instruments and short-term investments in accordance with each portfolio's investment objective. There are no restrictions on redemption of the accounts and there were no unfunded commitments.

Pooled Separate Accounts (TIAA Real Estate Account): The account generally invests in real estate properties and real estate related investments. The account's value is principally derived from the market value of the underlying real estate holdings or other real estate related investments and is valued at net asset values (NAV) of units held by the Plan.

Variable Annuities – Other: The variable annuities – other accounts are Level 1 investments and the fair market value per share is calculated at the NAV on a daily basis. Variable Annuity accounts are primarily valued using market quotations or prices obtained from independent pricing sources that may employ various pricing methods to value the investments including matrix pricing. The variable annuity account invest principally in equity securities, fixed-income instruments and short-term investments in accordance with each portfolio's investment objectives. Variable annuity accounts consist of eight investment portfolios within CREF and five TIAA Access portfolios. The investment options have audited financial statements. To the participant, these investments are similar to mutual funds until the participant annuitizes them. The participant has the option to annuitize these investments, but until that time occurs, the variable annuity investments act as mutual funds.

Fixed Annuity Contract - NFBR: The fixed annuity contract is considered a Level 3 investment by TIAA and consists of contracts within the TIAA Traditional Non Fully Benefit Responsive ("NFBR") Annuity. The TIAA Traditional Annuity contracts are reported at fair value. Fair value is determined using discounted cash flow model. The contracts are not available for sale or transfer on any securities exchange. Accordingly, transactions in similar investment instruments are not observable. For further discussion on how the contract value is determined, see Note 4.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

In determining the reasonableness of the methodology and unobservable inputs, plan management evaluates a variety of factors including review of existing contracts, economic conditions and overall credit ratings. Certain unobservable inputs are assessed through review of contract terms, such as duration or payout date, while others are substantiated utilizing available market data.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023.

(1) Certain investments that are measured at fair value using net asset value per share practical expedient are not required to be categorized in the fair value hierarchy. The Plan invests in Mutual of America separate accounts that are measured using the NAV practical expedient. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the amounts presented in the statements of net assets available for benefits.

Changes in Fair Value of Level 3 Assets

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another.

We evaluate the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits.

4. Fixed Annuity Contract

The Plan has an investment contract with TIAA. The TIAA Traditional Non-Benefit Responsive Annuity's primary objective is the guarantee of principal and a specified interest rate. TIAA maintains the contributions in a general account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value which approximates fair value. The fair value of Plan retirement investments in the TIAA Traditional Non Benefit-Responsive Annuity as of December 31, 2024 and 2023 is \$137,963 and \$141,178 respectively.

The contracts provide a guarantee of principal, a guaranteed minimum rate of interest (3% in 2024 and 2023) and additional interest as declared by TIAA on a year-by-year basis. Actual average crediting interest rates for 2024 and 2023 were 5.38% and 6.25%, respectively. Certain contracts contain liquidity restrictions on redemption which could impact the value realized upon exiting the contract. Participant transfers and withdrawals are limited with some contracts charging a withdrawal fee. Generally, participants may only make withdrawals in the form of a life annuity or in ten (10) year installments.

5. Insurance Company General Account

The Plan offers an Interest Accumulation Account option within the group annuity contract through Mutual of America Life Insurance Company. Mutual of America maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed by the Plan. The crediting interest rate is based on a formula established by the contract issuer. The contract account balance is reviewed on a daily basis and used to determine the applicable interest rate credit to only amounts held in the Interest Accumulation Account. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Mutual of America Life Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The contract value of Plan retirement investments in the Mutual of America investment contract at December 31, 2024 and 2023 is \$771,668 and \$973,380, respectively.

6. Insurance Company Investment Contracts

The Plan has an investment contract with TIAA. The TIAA Traditional Annuity is a guaranteed annuity backed by TIAA's claim-paying ability. The TIAA Traditional Annuity's primary objective is the guarantee of principal and a specified interest rate. TIAA maintains the contributions in a general account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by TIAA, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The contract value of Plan retirement investments in the TIAA investment contract at December 31, 2024 and 2023 is \$88,395 and \$103,641, respectively.

7. Information Certified by the Issuers

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, net appreciation (depreciation) in fair value of investments, interest and dividends for the years ended December 31, 2024 and 2023, and notes receivable from participants held at December 31, 2024 and 2023, were obtained or derived from information supplied to the Plan administrator who has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, and certified as complete and accurate by Mutual of America Life Insurance Company and TIAA, the issuers of the group funding agreements of the Plan.

8. Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA.

9. Tax Status

The Agency adopted a prototype non-standardized profit-sharing plan with a cash or deferred arrangement (CODA) which received an opinion letter from the Internal Revenue Service dated March 31, 2017, which stated that the form of the Plan is acceptable and in accordance with applicable section 403(b) of the Internal Revenue Code. The Plan has since been amended. The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more-likely-than-not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

10. Transactions with Parties in Interest

Certain routine plan administrative expenses are incurred and/or paid by the plan sponsor. Notes receivable from participants also qualify as exempt transactions with parties-in-interest. Certain plan investments are shares of funds managed by TIAA and Mutual of America Life Insurance Company. TIAA and Mutual of America Life Insurance Company are custodians as defined by the Plan and therefore these transactions qualify as party-in-interest transactions. Other than the aforementioned, the Plan has no agreements or transactions with parties in interest.

11. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risk such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the statement of net assets available for benefits

12. Subsequent Events

Management has evaluated subsequent events through October 2, 2025, the date on which the financial statements were available to be issued, and has determined that no material subsequent events exist that require recognition or disclosure.
