Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Bulley & Andrews 401(k) Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). NOTE 1 – DESCRIPTION OF PLAN:

The following description of the Bulley & Andrews (Bulley) 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. **General.** The Plan is a defined contribution plan covering all of Bulley's non-union employees. Employees are eligible to participate if they are twenty-one or older and have completed one month of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The trustees oversee governance of the Plan. The trustees determine the appropriateness of the Plan's investment offerings and monitors investment performance.
2. **Contributions.** Each year, participants may contribute pre-tax 401(k) or after-tax Roth contributions, up to \$23,000 of annual compensation, as defined in the Plan. Participants over 50 years of age may elect to contribute an additional \$7,500 in accordance with Internal Revenue Service regulations. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Bulley may contribute a discretionary percentage of each participant's elective deferral contributions.
3. **Company Match.** Beginning in June of 2023, after one year of service, Bulley will match an amount equal to fifty percent of a participant's contribution, up to \$6,000 annually.
4. **Participant Accounts.** Each participant's account is credited with the participant's contribution and Bulley's matching contribution plus allocation of Plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
5. **Vesting.** Participants are immediately vested in their contributions plus actual earnings thereon. Vesting on employer contributions plus actual earnings thereon is based on continuous years of service. A participant is 100 percent vested after six years of credited service.
6. **Investment Options.** Upon enrollment in the Plan, a participant may direct employee contributions in a variety of investment options with differing investment strategies. Participants may change their investment options at any time. All the Plan's assets are participant directed.
7. **Notes Receivable from Participants.** Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or fifty percent of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest is paid ratably through payroll deductions.

NOTE 1 – DESCRIPTION OF PLAN: (continued)

8. **Payment of Benefits.** Upon termination of service, a participant will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Participants may take distributions of their pre-tax deferrals after reaching age 59 ½, or if they have a financial hardship, as defined.

9. **Forfeited Accounts.** Forfeited nonvested accounts may first be used to reduce Plan expenses and any remaining forfeitures will reduce future employer contributions. Forfeited nonvested accounts totaled \$147,792 and \$121,760 at December 31, 2024 and 2023, respectively, available to reduce plan administrative expenses and future employer contributions.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES:

Basis of Accounting:

The Plan's financial statements are prepared using the accrual method of accounting.

Estimates:

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition:

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Registered investment companies' gains, net, include the Plan's gains and losses on mutual funds bought and sold as well as held during the year.

Payment of Benefits:

Benefits are recorded when paid.

Expenses:

Bulley absorbs the significant administrative expenses of the Plan.

NOTE 3 – FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

1. Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.
2. Level 2: Inputs to the valuation methodology include:
 - quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the assets or liabilities;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

3. Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement. The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered Investment Companies:

Registered investment companies' shares held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. Mutual funds are valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 3 – FAIR VALUE MEASUREMENTS: (continued)

Common/Collective Trust:

The Vanguard Retirement Savings Trust is a stable value fund offered by the Plan; it is valued at NAV, as a practical expedient, as determined by the managers of the trust, and is composed solely of investments in the Vanguard Retirement Savings Master Trust. The Vanguard Retirement Savings Master Trust invests in a pool of investment contracts issued by insurance companies and commercial banks and is valued based on contract value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The Common Collective Trust that was measured at NAV has not been classified in the fair value hierarchy. The fair value amounts presented in the tables above are intended to permit reconciliation of the fair value hierarchy to the amounts presented in the statements of net assets available for benefits.

NOTE 4 – INVESTMENTS:

The Plan's investment trustee certified that the amounts included in investments at fair value, notes receivable from participants, investment income, net, in the accompanying financial statements and supplementary schedule of assets held for investment are complete and accurate.

NOTE 5 – RELATED PARTY TRANSACTIONS:

Certain Plan investments are shares of mutual funds managed by The Vanguard Group, Inc., the investment trustee, and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to the investment trustee for investment management services were \$61,633 for the year ended December 31, 2024.

NOTE 6 – PLAN TERMINATION:

Although it has not expressed any intent to do so, Bulley has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 7 – TAX STATUS:

The Internal Revenue Service has determined and informed Bulley that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements.

NOTE 7 – TAX STATUS: (continued)

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 8 – RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
