Note 1. Description of Plan

The following description of the Rentokil Initial USA 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution retirement plan covering substantially all employees of Rentokil North America, Inc.; The Steritech Group, Inc.; Rentokil Initial, Inc.; Rentokil Initial Environmental Services, LLC; Residex, LLC; Connor's Termite and Pest Control, Inc.; SOLitude Lake Management, LLC; Vector Disease Acquisition, LLC; Medentex, LLC; EPS, LLC; and JP Pest Services, Inc. (collectively the "Company" or the employer), who have attained the age 18 with 30 days of service and are not an independent contractor. Vanguard Fiduciary Trust Company ("Vanguard") serves as the Plan's trustee. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Effective January 1, 2024, the Terminix Retirement Plan was merged into the Plan. Participant account balances of \$535,953,453 were transferred into the Plan related to the merger.

Contributions

Each year, participants may contribute up to 80% of annual compensation, as defined in the Plan, subject to Internal Revenue Code ("IRC"). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan also provides for automatic enrollment. Upon completion of 90 days of service, all newly eligible employees will automatically have 5% of his or her pay withheld on a pre-tax basis and deposited into the Plan, unless the employee elects to opt out. Participants may also contribute amounts representing distributions from other qualified plans and certain individual retirement accounts. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company's matching contribution was 50% of the participant's first 7% of compensation, up to \$345,000. The Company may also make a discretionary profit-sharing contribution to employees of Rentokil North America, Inc., SOLitude Lake Management, LLC, Vector Disease Acquisition, LLC, and The Steritech Group, Inc. There was no profit-sharing contribution made for the year ended December 31, 2024.

Investment Options

Participants direct the investment of their accounts into various investment options offered by the Plan. The Plan currently offers common collective trust funds and mutual funds as investment options for participants.

Participant Accounts

Each participant's account is credited with the participant's contributions, allocations of the Company's discretionary contributions and plan earnings (losses), and charged with benefit payments, distributions, and allocations of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The employer profit-sharing contribution is allocated to eligible participants according to the ratio each participant's compensation for the plan year bears to the total compensation of all participants for the plan year. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in their elective deferral contributions and rollover contributions plus actual earnings thereon. Participants are 100% vested in the Company's contribution portion of their accounts plus earnings thereon after 2 years of continuous service.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years or up to 15 years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at the current prime rate, as published in The Wall Street Journal, plus 1%. At December 31, 2024, outstanding loans bore interest rates ranging from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may be eligible to receive an amount equal to the value of the participant's vested interest in his or her account (except for his or her Grandfathered Money Purchase Account or Grandfathered Western Money Purchase Account) in either a lump-sum amount or in installments under a systematic withdrawal plan. A participant will receive either a lump-sum payment, installment payments under a systematic withdrawal plan, a Qualified Joint and Survivor (100%) Annuity, a Qualified Joint and Survivor (75%) Annuity, a Qualified Joint and Survivor (50%) Annuity, or a Qualified Life Annuity, if not married, equal to the value of his or her vested interest in his or her Grandfathered Money Purchase Account or Grandfathered Western Money Purchase Account. Hardship distributions are permitted upon demonstration of financial hardship. All fully vested balances are available for distribution after the participant reaches the normal or early retirement age, upon the date the participant becomes fully disabled, or upon death.

Forfeitures

Forfeitures are either used to pay Plan expenses or used to reduce Company contributions. Forfeited non-vested accounts totaled \$1,335,042 and \$1,693,208 at December 31, 2024 and 2023, respectively. During 2024, forfeited non-vested accounts of \$57,036 were used to pay Plan expenses and \$3,547,845 were used to reduce Company contributions.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates and assumptions.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when received. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits

Benefit payments are recorded upon distribution.

Administrative Expenses

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the Plan document. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan. Expenses relating to specific participant transactions are charged directly to the participant's account.

Subsequent Events

The Plan has evaluated subsequent events through September 8, 2025, the date the financial statements were available to be issued.

Note 3. Unaudited Information Certified by Trustee

The accompanying financial statements include the following unaudited information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, that was obtained from data prepared and certified to be complete and accurate by the Plan's trustee.

Note 4. Fair Value Measurements

Fair value, as defined under GAAP, is an exit price representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. GAAP establishes a three-tier fair value hierarchy which prioritizes the inputs used in measuring fair value. These tiers include:

- Level 1** Observable inputs such as quoted prices in active markets.
- Level 2** Inputs other than quoted prices in active markets that are either directly or indirectly observable.
- Level 3** Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement

requires judgment and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

There have been no changes in the methodologies used at December 31, 2024 and 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds

Mutual funds are publicly traded investments and are valued daily at the closing price reported on the active market on which the funds are traded.

Common Collective Trusts

These funds are valued at the net asset value (“NAV”) of units of the collective fund. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the funds will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. The common collective trust fund is not required to be classified within a level on the fair value hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Tax Status

The Internal Revenue Service (“IRS”) has determined and informed the plan sponsor by a letter dated November 15, 2017, that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan has been amended since receiving the determination letter; however, the plan administrator believes that the Plan is designed and being operated in compliance with the applicable provisions of the IRC. Therefore, the plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

Note 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 8. Exempt Party-In-Interest Transactions

Certain Plan investments are shares of mutual funds and collective trust funds managed by affiliates of the trustee as defined by the Plan, and therefore, these transactions qualify as exempt party-in-interest transactions. Total administrative fees paid to the trustee by the Plan were \$1,860,962 for the year ended December 31, 2024.
