Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matters - Supplemental Schedule Required by ERISA**

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

#### Note 1. Description of Plan

The following description of the MAXISIQ, Inc. 401(k) Plan (the Plan) provides only general information. A complete description of the Plan is contained in the Plan Document which governs the operation of the Plan.

##### General

The Plan is a defined contribution plan established for employees of MAXISIQ, Inc. (the Company or Plan Sponsor). The Plan was amended during 2024 to include employees of Five Insights and NCI. Almost all employees are eligible to participate in the Plan after attainment of age eighteen. Employees covered by a collective bargaining agreement, leased employees and non-resident aliens with no U.S. income are excluded from participation in the Plan. Employees can enter the Plan on the first day of the month after becoming eligible and begin making deferral contributions and receiving employer contributions at that time. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan's investments were held with Nationwide Trust Company (Nationwide), the Plan's custodian, for the period January 1, 2023 to December 31, 2023. Fidelity Management Trust Company (Fidelity) became the Plan's Trustee effective January 1, 2024.

The Secure 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans which became or becomes effective in 2023, 2024 and beyond.

##### Contributions

Participant contributions are determined by each individual participant. Participants may contribute from their eligible compensation subject to the limits established by the Internal Revenue Code (\$23,000 for 2024 and \$22,500 for 2023). Participants who are age 50 or older may make additional catch-up contributions up to the maximum amount of \$7,500 for 2024 and 2023. Participant pre-tax rollover contributions are also allowed. Participants elect to have their contributions and Company safe harbor contributions invested in various investment options offered by the Plan's custodian/trustee. Participants may also elect all or a portion of their deferral contributions as after-tax Roth contributions.

The Company made safe harbor matching contributions of 100% of salary deferrals up to the first 3% of plan compensation plus 50% of salary deferrals up to the next 2% of plan compensation. Safe harbor matching contributions made totaled \$768,356 and \$690,695 for the years ended December 31, 2024 and 2023, respectively. Employee deferral contributions totaled \$1,646,507 and \$1,337,195 for the years ended December 31, 2024 and 2023, respectively. Rollover contributions totaled \$167,849 and \$311,429 for the years ended December 31, 2024 and 2023, respectively.

The Company may also elect to make non-elective discretionary contributions (employer discretionary contributions). To share in an employer discretionary contribution, a participant must have 1,000 or more hours of service for the Plan year and be employed on the last day of the Plan year. Employer discretionary contributions are allocated to participants using a permitted disparity allocation formula as defined in the Plan documents. There were no employer discretionary contributions for the years ended December 31, 2024 and 2023.

### Note 1. Description of Plan (Concluded)

#### Participant Accounts

Each participant's account is credited with the participant's and Company safe harbor contributions, allocation of net Plan earnings or losses, and is charged with benefit payments and allocation of administrative expenses, where applicable. Allocation of plan earnings is based on the proportion of each participant's account balance as it relates to all participant account balances in that investment type. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their 401(k) elective deferral and rollover contributions to the Plan. Participants are also fully vested in employer safe harbor matching contributions. Vesting in employer discretionary contributions is based on years of service. At December 31, 2024 and 2023 the vesting schedule for employer discretionary contributions is as follows:

#### Payment of Benefits

The Plan provides for benefit payments upon termination, death, disability or normal retirement based on the vested balance in the participant's account. In-service withdrawals such as age 59 1/2, hardship, active military and qualified reservist are also permitted if certain conditions are met as outlined in the Plan Document. Benefit payments are recorded when paid. There were no significant benefits payable to terminated participants who have withdrawn from the Plan as of December 31, 2024 and 2023.

#### Notes Receivable from Participants

Participants may borrow up to one-half of their vested account balance up to a maximum of \$50,000. The notes are secured by a portion of the participant's vested account balance and bear interest at a reasonable rate, which is commensurate with local prevailing rates, as determined by the Plan Administrator. Notes are generally repaid within five years.

#### Administrative Expenses

The Company pays for specific administrative costs of the Plan, and the remaining administrative costs of the Plan are paid from the assets of the Plan and allocated to the Plan participants. Investment related expenses are included in net appreciation of fair value of investments.

#### Forfeitures

A participant who terminates and has vested in the employer non-elective discretionary contributions retains the vested portion and the nonvested portion is forfeited when vested amounts are distributed. Forfeitures may be used to offset administrative expenses and employer contributions. Forfeitures applied to offset administrative expenses and employer contributions were \$0 for both of the years ended December 31, 2024 and 2023. Forfeitures available to offset administrative expenses and employer contributions were \$10 and \$0 at December 31, 2024 and 2023, respectively.

### Note 2. **Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The Plan's financial statements are prepared on the accrual basis in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP).

#### **Use of Estimates**

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

The Plan's investments in mutual funds and participant-directed brokerage accounts are measured at fair value using quoted market prices. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

### Note 3. **Plan Tax Status**

The Plan has adopted a prototype plan, designed by Fidelity, effective January 1, 2024. The prototype plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the form of the prototype plan, as then designed, is acceptable for use by employers for the benefit of their employees under Internal Revenue Code (IRC) Section 401. The prototype plan has been amended since receiving its latest determination letter. The Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize an adjustment to taxable income if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The Plan sponsor has analyzed the tax positions taken by the Plan, and is not aware of any uncertain tax positions that would require an adjustment to taxable income or disclosure in the financial statements as of December 31, 2024 and 2023. The Plan is subject to routine audits by taxing jurisdictions; however, there are no audits in progress for any tax period.

### Note 4. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification Topic 820, *Fair Value Measurement* (ASC 820), establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of inputs other than quoted prices in an active market that are observable; and Level 3 inputs are unobservable and significant to the fair value measurement, and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

There have been no changes in the methodologies used at December 31, 2024 and 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

The fair value of money market funds, mutual funds and participant-directed brokerage accounts are measured at fair value based on quoted prices in active markets for identical assets (Level 1). These investments are valued at the daily closing price as reported by the fund. These funds held by the Plan are open-ended funds that are registered with the SEC. These funds are required to publish their daily fair value and to transact at that price.

The funds held by the Plan are deemed to be actively traded. Level 1 investments at December 31, 2024 and 2023 totaled \$18,401,444 and \$15,643,009, respectively.

### Note 5. Information Certified by Plan Custodian/Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Nationwide Trust Company, the Plan Custodian from January 1, 2023 to December 31, 2023, and Fidelity, the Plan Trustee from January 1, 2024 to December 31, 2024, have certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate as of and for the years ended December 31:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**Note 7. Administration of Plan Assets**

Certain administrative functions are performed by officers or employees of the Company. No such officers or employees receive compensation from the Plan. All administrative expenses are paid by the Company or the Plan.

**Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 9. Exempt Party-In-Interest Transactions**

Certain Plan investments are in funds and accounts that are managed by Nationwide, Fidelity or their subsidiaries and affiliates. Processing fees for notes receivable from participants and distribution are paid to Nationwide or Fidelity by participants. The Plan paid for third party record keeping fees and investment advisory fees. The Plan also issues notes receivable to participants which are secured by the vested balance of the participants' accounts. Certain management fees in the form of an expense ratio charged to each investment option are paid by the Plan and deducted from earnings on investments. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

**Note 10. Subsequent Events**

The Plan has evaluated events and transactions through October 3, 2025, the date that the financial statements were available to be issued, and has determined that no events or transactions occurred subsequent to December 31, 2024 that requires recognition or disclosure in these financial statements.
