## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator  
Trideum Corporation Employee Stock Ownership Plan

### **Opinion**

We have performed audits of the financial statements of Trideum Corporation Employee Stock Ownership Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of Trideum Corporation Employee Stock Ownership Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America.

### **Basis for Opinion**

The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including its form and content, is presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedule is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

## **1. DESCRIPTION OF THE PLAN**

The following description of the Trideum Corporation (the Company or Sponsor) Employee Stock Ownership Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for complete information.

### **General**

The Company established the Plan effective as of January 1, 2020. As of January 1, 2020, the Plan was amended and operates, in relevant part, as a leveraged employee stock ownership plan (ESOP) and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986 (IRC), as amended, and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan is administered by Trideum Corporation. The Company has authority to control and manage the operation and administration of the Plan and has all powers necessary to enable it to carry its duties. The Company is responsible for oversight of the Plan. Van Sullivan, the Company's Chief Executive Officer, is the Plan Administrator. GreatBanc Trust Company is the Plan's Trustee.

The Plan purchased Company common stock using the proceeds of a borrowing from the Company (see Note 5) and holds the common stock in a trust (the Trust) established under the Plan. The borrowing is to be repaid over a period of 30 years by fully deductible Sponsor contributions to the Trust. As the Plan makes each payment of principal and interest, an appropriate percentage of stock will be allocated to eligible employees' accounts in accordance with applicable regulations under the IRC.

The borrowing is collateralized by the unallocated shares of common stock. The Sponsor has no rights against shares of common stock once they are allocated under the provisions of the ESOP. Accordingly, the financial statements of the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, present separately the assets and liabilities, and changes therein pertaining to:

1. The accounts of employees with vested rights in allocated common stock (allocated), and
2. Common stock not yet allocated to employees (unallocated).

### **Eligibility**

There is no entry service requirement, but the age requirement is 21. Participants who do not have at least 1,000 hours of service during a Plan year are generally not eligible for an allocation of Company contributions for the year.

### **Contributions**

The Company's Board of Directors determines the form (either in Company stock or cash) and amount of employer contributions. During any year in which the Company has elected to be treated as a "Subchapter S Corporation," the Trust may also receive its share of any distributed earnings (S Corporation Distributions) paid to the Company's stockholders.

**Payments of Benefits**

Distributions on account of death, disability or retirement are made in a lump sum or annual installments in the Plan year following the event. The method of payment will either be cash or stock distribution as required by the Plan Document.

**Administrative Expenses**

As provided in the Plan agreement, administrative expenses may be paid either by the Plan or by the Company. Normal brokerage charges that are included in the cost of securities purchased (or charged to proceeds in the case of sales) will be paid by the Plan. The Company will pay all expenses in connection with the design, establishment or termination of the Plan. The Trust will pay all costs of administering the Plan and Trust unless those expenses are paid by the Company.

**Voting Rights**

All Company stock held by the Trust will be voted by the Trustee on behalf of the collective best interest of Plan participants and beneficiaries in accordance with the Employee Benefits Administration Committee. However, each participant is entitled to direct the voting of any voting shares of Company stock allocated to his or her account with respect to any vote required for the approval or disapproval of certain events as defined in the Plan Document. The Trustee will vote any unallocated shares held by the Trust as well as any allocated shares for which a participant has failed to give timely voting direction.

**Participant Accounts**

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account can be credited with an allocation of (1) the Company's contributions, (2) Company matched funds as directed from the 401(k) plan, (3) Plan earnings or losses based on changes in the price of the Company stock, and (4) forfeitures of terminated participant's nonvested accounts. Only those participants who are eligible employees of the Company as of the last day of the Plan year will receive an allocation. Allocations are based on a participant's eligible compensation or account balances, as defined in the Plan Document. Plan earnings are allocated to each participant's account based on the ratio of the participant's account balance.

**Vesting**

Employees entering the Plan on or after January 1, 2020, vest in the Company's contributions and related earnings at a rate of 20% per year after one year of service and are fully vested after six years. Employees are also fully vested upon reaching the normal retirement date, upon death of the participant, or total and permanent disability as defined by the Plan Document.

**Put Option**

Under federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the current appraised value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of a put option is to ensure that the participant has the ability to ultimately obtain cash.

**Diversification**

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company common stock into investments, which are more diversified. Participants who are at least age 55 with a minimum of 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of post-1986 shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%. Participants who elect to diversify receive a cash distribution. Participants eligible to diversify make their election after year end based on the number of shares of the employer's stock held in their account at year end.

**Forfeitures**

Plan forfeitures are allocated to each participant's account based upon the relation of the participant's compensation to total compensation for the Plan year. Forfeitures allocated to participants during the year ended December 31, 2024, is \$16,877.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Allocations**

The financial statements of the Plan present separately the assets and liabilities, and changes therein, pertaining to (1) the accounts of employees with rights in allocated stock (allocated) and (2) stock not yet allocated to employees (unallocated), including shares that are committed to be released. Shares are released from collateral and become allocated generally in the period in which debt service is actually paid.

**Investment Valuation and Income Recognition**

The shares of Company common stock are reported at fair value. See Note 4 for a discussion of the fair value measurements. Dividend income is accrued on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis. Realized gains and losses from security transactions are reported on the average cost method. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits**

Benefits are recorded when paid.

**4. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are described as follows:

- Level 1 Fair Value Measurements – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Fair Value Measurements – Inputs to the valuation methodology include: (1) quoted prices for similar assets or liabilities in active markets; (2) quoted prices for identical or similar assets or liabilities in inactive markets; (3) inputs other than quoted prices that are observable for the net asset or liability; (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Fair Value Market Measurements – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The valuation process involves the selection of an appraiser under contract for a term of three years with the right to cancel such contract at any time. Plan management accumulates the data for the appraiser from historical and projected financial information of the Company. The appraiser prepares a report of estimated per share value that a participant will receive upon distribution, which Plan management, along with the ESOP Trustee, reviews in detail, discusses and approves.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## **5. LOAN PAYABLE**

On July 24, 2024, the Plan entered into a loan agreement with the Company for \$5,000,000. The proceeds of the loan were used to purchase common stock of the Company. Unallocated shares are collateral for the loan. Shares are released from the collateral and allocated to participants as payments of principal and interest are made.

The number of shares released in any year will be the number of shares held as collateral, times the ratio of the current year's principal and interest payments, divided by the total of this year's principal and interest payments, plus all future years' principal and interest payments. This resulted in 2,548.96 shares being released and allocated in the Plan year ended December 31, 2024.

The agreement provides for the loan to be repaid over 30 years. The fair value of the note payable as of December 31, 2024, was \$4,797,795, determined by using interest rates currently available for issuance of debt with similar terms, maturity dates and nonperformance risk. For the year ended December 31, 2024, the loan interest rate was 4.61%.

## **6. RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

The Plan invests in Company common stock guaranteed by the Company. This is a related party and party-in-interest transaction. As described in Note 1, the Company pays the expenses of the Plan. The Plan has a number of service providers. Such parties are parties-in-interest under ERISA.

Principal Financial Group provides recordkeeping services for the Plan, and therefore qualifies as a party-in-interest. As described in Note 1, fees related to the Plan's operations were paid by the Sponsor directly to Principal Financial Group during 2024.

## **7. RISKS AND UNCERTAINTIES**

The Plan investments consist primarily of the Company's common stock, which is exposed to various risks, such as interest rate, market and credit risks, as well as valuation assumptions based on earnings, cash flows and other such techniques. Due to the level of risk associated with the investment in the common stock and to uncertainties inherent in estimates and assumptions, it is at least reasonably possible that changes in the value of the common stock will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

## **8. PLAN TERMINATION**

The Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon termination of the Plan, the Employee Benefits Administration Committee directs the Trustee to pay all liabilities and expenses of the ESOP and to sell shares of financed common stock held as collateral to the extent it determines such sale to be necessary in order to repay the loan.

Subsequently, the interest of each participant in the Trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the IRC.

**9. TAX STATUS**

The Internal Revenue Service has determined and informed the Company by a letter dated December 10, 2014, that the Plan is qualified, and the Trust established under the Plan is tax-exempt, under the appropriate sections of the IRC. The Plan has been amended since receiving the determination letter; however, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified, and the related Trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.
