Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Note 1 - DESCRIPTION OF PLAN

The following description of the Johnson-Barrow, Inc. 401(k) Profit Sharing Plan and Trust ("the plan") provides only general information. Participants should refer to the plan document or Summary Plan Description for a more complete description of the plan's provisions, which are available from the plan administrator.

GENERAL

The plan is a defined contribution 401(k) plan covering all full-time employees of Johnson-Barrow, Inc., JB Oregon, Inc., and JB Inland Northwest, Inc. (collectively the "company"). To be eligible, employees must be age twenty-one or older. Union employees and non-resident aliens are not eligible to participate in the plan. The plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

PLAN MERGER

Although it has not expressed any intent to do so, the company has the right under the plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA. On February 2, 2025, subsequent to the end of the plan year, the Johnson-Barrow, Inc. 401(k) Profit Sharing Plan and Trust was merged into the Ambient Enterprises 401(k) plan. As a result of the merger, all assets and liabilities of the Johnson-Barrow, Inc. 401(k) Profit Sharing Plan and Trust were transferred into the Ambient Enterprises 401(k) plan, and all participant account balances were transferred on a fully vested basis. The merger was undertaken to streamline plan administration and enhance benefits offered to participants. No significant changes to participants' rights or benefits resulted from the merger. The plan transfer was in process as of year-end, while the effective date of the Ambient Enterprises 401(k) plan is January 1, 2025. Due to these factors, the total asset transfer in progress is reported as cash as of December 31, 2024. Notes receivable from participants' transfer was not in process as of December 31, as such the notes receivable balances are reported as plan receivables as of year-end. Notes receivable from participants were transferred subsequent to year-end. As the plan was merged rather than terminated subsequent to year-end, the plan has not and will not account for activities through the liquidation basis of accounting.

CONTRIBUTIONS

Each year, participants may contribute a percentage of eligible annual compensation as pre-tax or Roth contributions, following their first 30 days of employment, as defined in the plan agreement. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Additionally, participants age 50 or older, who are making contributions to the plan, are allowed to make catch-up contributions. Participants direct the investment of all contributions into various investment options offered by the plan.

The plan includes an auto-enrollment feature. All employees are automatically enrolled in the plan on the first day of the month coinciding with or following the date eligibility requirements are satisfied at a contribution rate of 5%.

The company may make safe harbor matching contributions equal to 100% of the participants' contributions up to 3% of the participant's eligible compensation, plus 50% of the participant's contributions between 3% and 5% of the participant's eligible compensation as defined in the plan

agreement. The company made safe harbor matching contributions of \$839,919 and \$761,820 for the years ended December 31, 2024 and 2023, respectively. The company may also make a discretionary profit sharing contribution to the plan. There was no profit sharing contributions for the years ended December 31, 2024 and 2023.

Contributions are subject to certain Internal Revenue Code ("IRC") limitations.

PARTICIPANT INVESTMENT ACCOUNT OPTIONS

The plan offered various mutual funds and a stable value common collective trust as investment options for participants. Each investment option had its own investment strategy, which could be obtained through the prospectus of the respective fund. Participants could change their investment options daily. There was no nonparticipant directed investments.

PARTICIPANT ACCOUNTS

Each participant's account is credited with the participant's contribution and allocations of (a) the company's matching contributions, as well as profit sharing contributions and (b) plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

VESTING

Participants are immediately vested in their contributions, safe harbor contributions, and rollover contributions plus actual earnings thereon. A participant becomes 20% vested in employer matching and profit sharing contributions after two years of service and vests ratably thereafter until 100% vested after 6 years of credited service.

NOTES RECEIVABLE FROM PARTICIPANTS

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions.

PAYMENT OF BENEFITS

On termination of service due to death, disability or retirement, a participant or the designated beneficiary will receive a lump sum amount equal to the value of the participant's vested interest in his or her account. For termination of service due to death, disability or retirement, a participant will receive an automatic benefit payment for the value of the vested interest in his or her account as a cash lump sum for vested benefits less than \$1,000.

HARDSHIP AND IN-SERVICE WITHDRAWALS

Participants are permitted to withdraw, in a single sum, the vested portion of their account balance under certain conditions. These conditions include unreimbursed medical expenses, the purchase of the participant's principal residence, the payment of post-secondary education tuition, the payment of funeral expenses or casualty losses or to prevent eviction or foreclosure from the participant's principal residence.

Participants that have reached age 59 ½ may elect to withdraw all or a portion of their entire vested account balance while they are still employed by the company.

FORFEITED ACCOUNTS

Forfeitures of nonvested company contributions are used to pay any plan administrative expenses or reduce employer matching contributions. Forfeitures of \$0 were available at December 31, 2024 and 2023. Forfeitures of \$1,266 and \$46,445 were used during the years ended December 31, 2024 and 2023, respectively.

Note 2 - SUMMARY OF ACCOUNTING POLICIES

BASIS OF ACCOUNTING

The financial statements of the plan are prepared using the accrual method of accounting.

USE OF ESTIMATES

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

INVESTMENT VALUATION AND INCOME RECOGNITION

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan's trustees determine the plan's valuation policies utilizing information provided by the investment custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold, as well as held during the year.

CONTRIBUTIONS

Contributions from plan participants and the matching contributions from the company are recorded in the year in which the employee contributions are withheld from compensation.

NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

EXCESS CONTRIBUTIONS PAYABLE

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Code are recorded as a liability with a corresponding increase to corrective distributions. The plan distributed the excess contributions to the applicable participants prior to March 15 of the following year.

PAYMENT OF BENEFITS

Benefits are recorded when paid.

ADMINISTRATIVE EXPENSE

Certain expenses of the plan are paid by the company and are not included in the statement of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

SUBSEQUENT EVENTS

The plan has evaluated subsequent events through October 13, 2025, which is the date the financial statements were available to be issued. No other significant matters were identified for disclosure during this evaluation.

Note 3 - INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ascensus Trust Company (formerly Newport Trust Company), the trustee of the plan, has certified that the following data included in the accompanying financial statements and supplemental schedules are complete and accurate with respect to investments:

- Asset valuation at transfer (see Note 1)
- Investments at fair value
- Notes receivable from participants
- Dividends
- Net appreciation (depreciation) in fair value of investments
- Interest income on notes receivable from participants

The plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.

Note 4 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value ("NAV") and to transact at that price. The mutual funds held by the plan are deemed to be actively traded.

Stable value common collective trust: A stable value fund that is composed primarily of fully benefit-responsive investment contracts is valued at the NAV of units of the bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. If the plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

Note 5 - RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Plan assets are held in accounts managed by Ascensus Trust Company (formerly Newport Trust Company) and investment advising was performed by Gallagher Fiduciary Advisors, LLC. Fees charged by these companies are included in administrative expenses in the accompanying financial statements and qualify as party-in-interest transactions. The plan sponsor pays directly any other fees related to the plan's operations.

Note 6 - TAX STATUS

The company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the plan has been amended since adopting the pre-approved plan document, the plan administrator believes that the plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and therefore, believes the plan is qualified.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7 - RISKS, UNCERTAINTIES AND CONCENTRATIONS

The plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Market risks include global events which could impact the value of investment securities, such as tariff impositions or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

At December 31, 2023, approximately 16% of the plan's investments were invested in T. Rowe Retirement 2050.

Note 8 - DELINQUENT PARTICIPANT CONTRIBUTIONS

Defined contribution plans are required to remit employee contributions to the plan as soon as they can be reasonably segregated from the employer's general assets. While the company remitted all employee contributions to the plan, contributions of \$193,495 were not remitted within the required time period collectively for the years ended December 31, 2023 and 2022. The calculation of potential lost earnings on the late remittances for the prior years were corrected in 2024.
