### Independent Auditor's Report

#### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

I have performed audits of the financial statements of Partners Pension Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), my audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

#### Opinion

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

I conducted my audits in accordance with auditing standards generally accepted in the United States of America (GAAS). My responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of my report. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

I am required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that I identified during the audit.

## Notes to Financial Statements December 31, 2024 and 2023

---

### 1. Description of the Plan

The following description of Partners Pension Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

*General* — The Plan is a profit sharing plan sponsored by The Hospice and Palliative Care Group, Inc. dba The HomeCare Partners (the "Company" or "Employer"). The Plan includes all full time and part time employees of the Company and participating employers. Eligible employees are allowed to enter the Plan upon completing one year and 1,000 hours of eligible service, as defined. The one year and 1,000 hours of eligible service requirement was waived for any eligible employee who was also eligible under the Employer's SEP-IRA plan as of December 31, 2021. Per diem employees, as defined, and interns are not eligible to participate in the Plan.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). CPI Qualified Plan Consultants, Inc. ("CPI") is the Plan's recordkeeper. Matrix Trust Company is the custodian of the Plan's investments.

*Contributions* — Each year, the Employer may make a discretionary profit sharing contribution to all eligible participants, subject to a vesting schedule. For 2024, the Employer declared a profit sharing contribution of 4.5% of eligible compensation, as defined, paid on a bi-weekly basis to eligible participants. Employer profit sharing contributions amounted to \$644,453 for 2024, of which \$8,416 was funded from forfeited nonvested accounts.

Participant elective deferrals are not permitted. Eligible participants may contribute amounts representing distributions from other eligible qualified plans on a pre-tax basis and amounts from traditional rollover IRAs, as defined.

All contributions are subject to certain Internal Revenue Code ("IRC") limitations. Participants direct all contributions into various investment options available under the Plan including a stable value account. The various Schwab Target Date Index Funds are the default investments used when a participant has not made an investment election for all or any portion of their accounts.

*Participant Accounts* — Individual accounts are maintained for each Plan participant. Each participant's account is credited with any Employer Profit Sharing contribution, and Plan earnings or losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participant loans are not permitted.

*Vesting* — Vesting in the Employers profit sharing contribution portion of their accounts is based on years of service. A participant is 100% vested after three years of service (cliff vest), as defined. Participants are always fully vested in any rollover contributions.

*Forfeitures* — Forfeited nonvested accounts may be used to pay administrative expenses of the Plan and reduce any discretionary profit sharing contributions. During 2024, new forfeited non-vested accounts totaled \$9,534 and \$1,129 were used to pay administrative fees.

**1. Description of the Plan (continued)**

*Payment of Benefits and Withdrawals* – Upon termination of service due to retirement, death, or disability, a participant may elect to receive the value of the participant's vested interest in his or her account, in the form of a lump-sum, as defined by the Plan. Partial withdrawals are generally permitted for minimum distributions, as defined. Participant consent is required for distributions in excess of \$7,000. Effective January 1, 2025, in-service distributions will be permitted to eligible participants age 59.5 and older.

**2. Summary of Significant Accounting Policies**

*Basis of Accounting* — The financial statements of the Plan are prepared using the accrual basis of accounting under accounting principles accepted in the United States of America.

*Investment Valuation and Income Recognition* — Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*Payment of Benefits* – Benefit are recorded when paid.

*Administrative Expenses* – Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment-related expenses are included in net appreciation of fair value of investments.

*Use of Estimates* — The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*Market Risk Factors* — The Plan invests in various investment securities. Investment securities are exposed to risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

*Subsequent Events* — Plan management has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

### 3. Investment Valuation and Income Recognition

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

- Level 1 – Unadjusted quoted prices in active markets for identical, unrestricted assets or liabilities that are accessible at the measurement date.
- Level 2 – Quoted prices for similar assets or liabilities in active markets or quoted prices for identical or similar assets or liabilities in markets that are not active. This level also includes inputs other than quoted prices that are observable, either directly or indirectly, for substantially the full term through corroboration with observable, independent market data. This includes investments valued at quoted prices adjusted for legal or contractual restrictions specific to the security.
- Level 3 – Pricing inputs are unobservable for the asset or liability. That is, inputs that reflect the reporting entity’s own assumptions about the assumptions that market participants would use in pricing the asset or liability.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value as of December 31, 2024 and 2023:

*Mutual Funds* — Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**4. Related-Party and Party-In-Interest Transactions**

Certain employees and/or officers of the Company or its affiliates perform administrative services to the Plan at no cost to the Plan.

**5. Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**6. Tax Status**

The Plan adopted a pre-approved plan document sponsored by Actuarial Consulting Services, Inc. Actuarial Consulting Services, Inc. (“ACSI”) received an opinion letter from the Internal Revenue Service, dated June 30, 2020, which states that the prototype document satisfies the applicable provisions of the Internal Revenue Code (“IRC”). The Plan has not received a determination letter specific to the Plan itself; however, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan’s financial statements.

As of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**7. Certified Investment Information**

The Company, acting in its capacity as the Plan administrator, has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. The following is a summary of the unaudited information regarding the Plan as of December 31, 2024, and 2023, and for the year ended December 31, 2024, included in the Plan’s financial statements and supplemental schedule, that was prepared by or derived from information prepared by Matrix Trust Company and furnished to the Company. The Company has obtained certifications from Matrix Trust Company as of December 31, 2024, and 2023, and for the year ended December 31, 2024, that such information is complete and accurate.
