Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The Neighborhood Recycling Corporation 403(b) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Opinion

1. Plan description:

The following description of The Neighborhood Recycling Corporation 403(b) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General:

The Plan was established on January 1, 2004. The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Neighborhood Recycling Corporation D/B/A Eureka Recycling (the Organization) established the Plan to provide employees with a systematic means of savings and investing for the future.

Eligibility:

Employees of the Organization are generally eligible to make elective deferrals on their date of hire unless they are part of an excluded class as defined by the Plan. Excluded employees include students, non-resident aliens, employees who are eligible to contribute to certain other employee benefit plans, and employees who work fewer than 20 hours a week. Employees are eligible for employer matching contributions after 1,000 hours of service and at such time, the entry date is immediate. The Plan also allows for non-elective contributions after the participant has reached 500 hours of service in a six-month period. If the employee does not meet the service hours during the time period, the employee is subject to the 1,000 hours requirement over 24 months of service. Non-elective contributions entry date is the first day of each month. Subsequent to year end, effective January 1, 2025 the Plan was amended so that the entry date is immediate for non-elective contributions.

Plan contributions:

Participants may contribute from 1% to 100% of their eligible wages by means of payroll deductions, subject to certain discrimination tests prescribed by the Internal Revenue Code and other limitations specified in the Plan. Contributions from employees are recorded in the period in which the Organization makes the payroll deductions.

The Organization may make discretionary employer matching and/or non-elective contributions to the Plan on behalf of all eligible employees. The amount and frequency of the employer contribution is determined by the Board of Directors of the Organization. There were no employer matching contributions made to the Plan for the years ended December 31, 2024 and 2023.

The Plan is also subject to three collective bargaining agreements as follows:

The first collective bargaining agreement, which is in effect through November 6, 2027 was updated to specify there would be no required employer contributions to the Plan beginning May 1, 2023.

For the second collective bargaining agreement, after one year of employment, all employees covered by the collective bargaining agreement are entitled to a minimum contribution of 1%. The agreement is in effect through September 1, 2025. As of the date of these financial statements, negotiations are in process for an updated agreement.

For the third collective bargaining agreement, after one year of employment, all employees will become eligible for employer contributions and are entitled to a minimum contribution of 2% in 2023, 3% in the beginning of 2024 and 4% starting on May 6, 2024.

1. Plan description (continued):

Participant accounts:

Each participant's account is credited with the participant's contributions, allocations of the employer contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

Participants are vested in their contributions and actual earnings immediately. Participants are vested in the Organization's discretionary matching contributions and non-elective contributions and actual earnings on a four year graded scale: 25%, 50%, 75%, and 100%. All eligible employees prior to August 15, 2018, are 100% vested.

Payment of benefits:

Upon retirement, disability or death, a participant or beneficiary may elect to receive either a lump-sum or, in annual installments, an amount equal to the value of the participant's vested interest in his or her account. Upon termination, other than by retirement, disability or death, a participant becomes eligible to receive the current value of the participant's vested account in a lump-sum.

The Plan makes involuntary distributions of terminated employees whose vested Plan balances do not exceed \$5,000.

Notes receivable from participants:

Participants may borrow from their fund accounts a minimum of \$1,000 to a maximum equal to the lesser of \$50,000 or 50% of their account balance. A participant may only have one loan outstanding. All loans are to be amortized over a reasonable period of time, generally not to exceed five years. Principal and interest is paid ratably through weekly payroll deductions. Loans are secured by the balance in the participant's account and bear interest charged at a rate to be fixed by the Plan Administrator. In determining the interest rate, the Plan Administrator takes into consideration interest rates currently being charged on similar commercial loans.

Hardship withdrawals:

Hardship withdrawals by participants are permitted in certain situations.

Investment options:

Upon enrollment in the Plan, participants direct the investment of their contributions and the Organization's contributions into various investment account options offered by the Plan.

1. Plan description (continued):

Participant investment rollovers:

Participants are allowed to transfer or rollover funds into the Plan from other qualified plans.

Investment valuation and income recognition:

Investments are reported at fair value and are all participant directed. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment adviser and custodian. See Note 4 regarding fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

2. Summary of significant accounting policies:

Use of estimates:

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires management to make estimates and assumptions that affect the reported amounts of certain assets, liabilities, and disclosures. Accordingly, the actual amounts could differ from those estimates.

Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If participants fail to make payments when they are due under the terms of the loan, the loan is considered to be in default and treated as a distribution based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Benefits paid to participants:

Benefits paid to participants are recorded when paid.

Administrative expenses:

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements. Fees related to the administration of notes receivable from participants and direct investment related expenses are charged directly to the participant's account and are included in administrative expenses. Indirect investment related expenses are included in net depreciation/appreciation of fair value of investments.

Concentrations:

At December 31, 2024 and 2023, approximately 35% and 44% of investments were held in two and three funds, respectively.

Subsequent events:

The Organization evaluated subsequent events through October 13, 2025, the date on which the financial statements were available to be issued.

3. Information certified by Matrix Trust Company:

The following is a summary of the Plan’s asset information as of and for the years ended December 31, 2024 and 2023, included throughout the Plan’s financial statements and supplemental schedule, that was prepared by or derived from information provided by the custodian and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the custodian that information provided to the Plan Administrator by the custodian related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan’s independent auditors not to perform any auditing procedures with respect to information related to the following assets as of December 31:

Matrix Trust Company also certified to the completeness and accuracy of the \$91,233 and \$318,910 of net appreciation in fair value of investments and \$288,748 and \$119,596 of interest and dividends related to the aforementioned assets for the years ended December 31, 2024 and 2023, respectively.

4. Fair value measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

4. Fair value measurements (continued):

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There were no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money market fund: Valued at the daily closing price as reported by the fund sponsor from an actively traded exchange.

5. Tax status: _____

The Organization has adopted a pre-approved volume submitter plan document that has received an opinion from the Internal Revenue Service dated March 31, 2017, stating that the form of the pre-approved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since adopting the pre-approved plan document, the Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. Plan management evaluated the Plan's tax positions and concluded that the Plan had taken no uncertain tax positions that require adjustment to the financial statements to comply with the provisions of this guidance. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Plan termination: _____

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

7. Risks and uncertainties: _____

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The Neighborhood Recycling Corporation 403(b) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

1. Plan description:

The following description of The Neighborhood Recycling Corporation 403(b) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General:

The Plan was established on January 1, 2004. The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Neighborhood Recycling Corporation D/B/A Eureka Recycling (the Organization) established the Plan to provide employees with a systematic means of savings and investing for the future.

Eligibility:

Employees of the Organization are generally eligible to make elective deferrals on their date of hire unless they are part of an excluded class as defined by the Plan. Excluded employees include students, non-resident aliens, employees who are eligible to contribute to certain other employee benefit plans, and employees who work fewer than 20 hours a week. Employees are eligible for employer matching contributions after 1,000 hours of service and at such time, the entry date is immediate. The Plan also allows for non-elective contributions after the participant has reached 500 hours of service in a six-month period. If the employee does not meet the service hours during the time period, the employee is subject to the 1,000 hours requirement over 24 months of service. Non-elective contributions entry date is the first day of each month. Subsequent to year end, effective January 1, 2025 the Plan was amended so that the entry date is immediate for non-elective contributions.

Plan contributions:

Participants may contribute from 1% to 100% of their eligible wages by means of payroll deductions, subject to certain discrimination tests prescribed by the Internal Revenue Code and other limitations specified in the Plan. Contributions from employees are recorded in the period in which the Organization makes the payroll deductions.

The Organization may make discretionary employer matching and/or non-elective contributions to the Plan on behalf of all eligible employees. The amount and frequency of the employer contribution is determined by the Board of Directors of the Organization. There were no employer matching contributions made to the Plan for the years ended December 31, 2024 and 2023.

The Plan is also subject to three collective bargaining agreements as follows:

The first collective bargaining agreement, which is in effect through November 6, 2027 was updated to specify there would be no required employer contributions to the Plan beginning May 1, 2023.

For the second collective bargaining agreement, after one year of employment, all employees covered by the collective bargaining agreement are entitled to a minimum contribution of 1%. The agreement is in effect through September 1, 2025. As of the date of these financial statements, negotiations are in process for an updated agreement.

For the third collective bargaining agreement, after one year of employment, all employees will become eligible for employer contributions and are entitled to a minimum contribution of 2% in 2023, 3% in the beginning of 2024 and 4% starting on May 6, 2024.

1. Plan description (continued):

Participant accounts:

Each participant's account is credited with the participant's contributions, allocations of the employer contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

Participants are vested in their contributions and actual earnings immediately. Participants are vested in the Organization's discretionary matching contributions and non-elective contributions and actual earnings on a four year graded scale: 25%, 50%, 75%, and 100%. All eligible employees prior to August 15, 2018, are 100% vested.

Payment of benefits:

Upon retirement, disability or death, a participant or beneficiary may elect to receive either a lump-sum or, in annual installments, an amount equal to the value of the participant's vested interest in his or her account. Upon termination, other than by retirement, disability or death, a participant becomes eligible to receive the current value of the participant's vested account in a lump-sum.

The Plan makes involuntary distributions of terminated employees whose vested Plan balances do not exceed \$5,000.

Notes receivable from participants:

Participants may borrow from their fund accounts a minimum of \$1,000 to a maximum equal to the lesser of \$50,000 or 50% of their account balance. A participant may only have one loan outstanding. All loans are to be amortized over a reasonable period of time, generally not to exceed five years. Principal and interest is paid ratably through weekly payroll deductions. Loans are secured by the balance in the participant's account and bear interest charged at a rate to be fixed by the Plan Administrator. In determining the interest rate, the Plan Administrator takes into consideration interest rates currently being charged on similar commercial loans.

Hardship withdrawals:

Hardship withdrawals by participants are permitted in certain situations.

Investment options:

Upon enrollment in the Plan, participants direct the investment of their contributions and the Organization's contributions into various investment account options offered by the Plan.

1. Plan description (continued):

Participant investment rollovers:

Participants are allowed to transfer or rollover funds into the Plan from other qualified plans.

Investment valuation and income recognition:

Investments are reported at fair value and are all participant directed. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment adviser and custodian. See Note 4 regarding fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

2. Summary of significant accounting policies:

Use of estimates:

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires management to make estimates and assumptions that affect the reported amounts of certain assets, liabilities, and disclosures. Accordingly, the actual amounts could differ from those estimates.

Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If participants fail to make payments when they are due under the terms of the loan, the loan is considered to be in default and treated as a distribution based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Benefits paid to participants:

Benefits paid to participants are recorded when paid.

Administrative expenses:

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements. Fees related to the administration of notes receivable from participants and direct investment related expenses are charged directly to the participant's account and are included in administrative expenses. Indirect investment related expenses are included in net depreciation/appreciation of fair value of investments.

Concentrations:

At December 31, 2024 and 2023, approximately 35% and 44% of investments were held in two and three funds, respectively.

Subsequent events:

The Organization evaluated subsequent events through October 13, 2025, the date on which the financial statements were available to be issued.

3. Information certified by Matrix Trust Company:

The following is a summary of the Plan’s asset information as of and for the years ended December 31, 2024 and 2023, included throughout the Plan’s financial statements and supplemental schedule, that was prepared by or derived from information provided by the custodian and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the custodian that information provided to the Plan Administrator by the custodian related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan’s independent auditors not to perform any auditing procedures with respect to information related to the following assets as of December 31:

Matrix Trust Company also certified to the completeness and accuracy of the \$91,233 and \$318,910 of net appreciation in fair value of investments and \$288,748 and \$119,596 of interest and dividends related to the aforementioned assets for the years ended December 31, 2024 and 2023, respectively.

4. Fair value measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

4. Fair value measurements (continued):

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There were no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money market fund: Valued at the daily closing price as reported by the fund sponsor from an actively traded exchange.

5. Tax status: _____

The Organization has adopted a pre-approved volume submitter plan document that has received an opinion from the Internal Revenue Service dated March 31, 2017, stating that the form of the pre-approved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since adopting the pre-approved plan document, the Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. Plan management evaluated the Plan's tax positions and concluded that the Plan had taken no uncertain tax positions that require adjustment to the financial statements to comply with the provisions of this guidance. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Plan termination: _____

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

7. Risks and uncertainties: _____

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
