## REPORT OF INDEPENDENT PUBLIC ACCOUNTANTS

To the Participants and Plan Administrator of the

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed an audit of the financial statements of the CRISP Shared Services, Inc. 403(b) Retirement Readiness Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

**1. DESCRIPTION OF THE PLAN**

The following brief description of the CRISP Shared Services Inc. 403(b) Retirement Readiness Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**General**

The Plan was created on January 1, 2021 and is a defined contribution 403(b) plan, which provides retirement, death and disability benefits for employees of CRISP Shared Services, Inc. (the Employer). The Plan was amended and restated on February 1, 2024. Subsequent to year end, the Plan was amended and restated on January 1, 2025.

**Recent Legislation**

The Setting Every Community Up for Retirement Enhancement (SECURE) Act 2.0 was signed into the 2023 Consolidations Appropriations Act under the Securing a Strong Retirement Act on December 29, 2022, with retirement provisions designed to increase retirement savings, facilitate access to retirement savings, encourage employees to save for retirement, and lower employers' cost of offering and funding retirement plans. The Plan's management and those charged with governance have a policy to incorporate these legislative changes in its Plan document by the prescribed deadlines.

**Contributions**

All employees who work for the Employer who are not excluded employees, as defined by the Plan document, are eligible to participate in the Plan upon hire. Eligible employees may elect to contribute through regular payroll deductions from 1% to 100% of their annual compensation in pre-tax and Roth contributions subject to Internal Revenue Code (IRC) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also rollover distributions from other qualified defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 2% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The deferral rate increases annually by 1% up to a maximum of 6% of compensation.

**Contributions (continued)**

After completing one year of service during which at least 1,000 hours of service are credited, a participant is eligible to receive employer contributions. Discretionary contributions may be made for each Plan Year in an amount determined by the Employer. Discretionary contributions are subject to the vesting percentages. Under the terms of the Plan, the Employer also makes matching contributions of 50% of the first 4% of eligible compensation that a participant contributes to the Plan.

Upon enrollment, a participant may direct contributions into any of the Plan's investment options. Participants may change their investment options for future contributions as well as transfer existing account balances within the Plan's investment options at any time.

**Participant Accounts**

Each participant's account is credited with the participant's contribution, allocations of the Employer's contribution and Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, or specific transactions as defined. The participant is entitled to a benefit that cannot exceed their vested account.

**Vesting**

Participants are immediately vested in their voluntary contributions when made. Vesting in non-elective and matching contributions are vested based on the following schedule:

**Payment of Benefits**

Participants or their beneficiaries are eligible for distributions in the form of lump sum benefits upon termination, retirement, or death. Participants who are still actively employed are eligible for distribution after reaching age 59½. In the event of hardship, as defined in the Plan document, participants may withdraw some or all of their vested account balance. Participants with vested balance less than \$5,000 will have an automatic distribution. If the amount of the distribution exceeds \$1,000 (including any rollover contribution), the distribution will be directly rolled over to an Individual Retirement Arrangement (IRA).

**Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Notes are secured by the balance in the participants accounts. Note repayments are made by payroll deduction. Notes bear interest at prime rate plus 1%.

**Forfeited Accounts**

Forfeitures represent the non-vested portion of a terminated participant's matching contributions. These amounts are used to reduce future employer contributions to the Plan and to offset Plan administrative expenses. During the year ended December 31, 2024, \$61,037 were used to reduce employer contributions. As of December 31, 2024 and 2023, forfeited amounts were \$42,151 and \$57,613, respectively.

**Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right to discontinue its contributions and to terminate the Plan subject to the provisions of ERISA. If the Plan is terminated, all participants would become 100% vested in their accounts.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Employer determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and insurance company. See Note 4 for discussion of fair value measurements.

**Investment Valuation and Income Recognition (continued)**

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/(depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document; thus, no allowance for credit losses has been recorded as of December 31, 2024 and 2023.

**Contributions**

Employee and Employer contributions are recorded in the period that the Employer makes payroll deductions from the participant's earnings.

**Payment of Benefits**

Benefit payments to participants are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account balance and are included in administrative expenses. Investment related expenses are included in the net appreciation/(depreciation) of fair value of investments.

**Subsequent Events**

The Plan's management evaluated subsequent events and transactions through October 1, 2025, the date these financial statements were available for issue, and have determined that no material subsequent events have occurred that would affect the information presented or require additional disclosure.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

**4. FAIR VALUE MEASUREMENTS (continued)**

The following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used as of December 31, 2024.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are reported at Level 1.

**5. INSURANCE COMPANY ANNUITY CONTRACTS**

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (Principal), who serves as the service agent for this contract. The portfolio of the contract is fully guaranteed by the entire general account assets of Principal. A composite crediting rate contractually guaranteed by Principal Life is credited to account balances. The net crediting rate is after the deduction of 1.25% for fees for administrative and recordkeeping services provided to the plan. Currently, this net crediting rate is a 2.70% effective annual rate, until November 30, 2025. The rate will be reset December 1, 2025, and semiannually thereafter. The contract cannot be terminated before the scheduled maturity date.

**5. INSURANCE COMPANY ANNUITY CONTRACTS (continued)**

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Such events include the following:

1. Amendments to the Plan documents (including complete or partial Plan termination or merger with another Plan);
2. Changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions;
3. Bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan;
4. The failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA; and/or
5. Premature termination of the contract.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines;
2. A breach of material obligation under the contract;
3. A material misrepresentation; and/or
4. A material amendment to the agreements without the consent of the issuer.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the insurance company annuity contracts as of December 31, 2024 was \$3,363.

**6. RELATED-PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS**

Certain Plan investments are managed by Principal Trust Company, the custodian of the Plan, and therefore, these transactions qualify as party-in-interest transactions.

**7. TAX STATUS**

The Plan was designed using a volume submitter plan document which received an opinion letter from the Internal Revenue Service (IRS) dated March 31, 2017 stating that the volume submitter plan document was in compliance with the applicable requirements of the Internal Revenue Code (the Code).

Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**8. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate risk, market risk and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such change could materially affect participants' account balances and the amount reported in the statement of net assets available for benefits.
