Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements conform with the Plan's provisions, including maintaining sufficient records with respect to each of the participants to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audits of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements are free from material misstatement, whether due to fraud or error and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance. Therefore, it is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users made on the basis of these financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter — Supplemental Schedule Required by ERISA

The supplemental *Schedule H Line 4i Schedule of Assets (Held at Year End)* as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS
DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF THE PLAN

The following description of the Alpha 401(k) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan designed to provide retirement benefits for employees of Alpha, Inc. (the “Sponsor”) who are eligible to participate. Substantially all employees who are age 18 and older who have completed two months of service, except non-resident aliens and union employees, are eligible to participate in the Plan. The Plan became effective January 1, 2002, and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”) and the Internal Revenue Code (“IRC”).

Contributions

Employees eligible to participate in the Plan (“participants”) may contribute a portion of their compensation, as defined, to the Plan under a salary deferral arrangement on either a pre-tax or after-tax basis, subject to the limit prescribed by the IRC, which is adjusted annually by the Internal Revenue Service (“IRS”). Participants may also make rollover contributions to the Plan, representing distributions from other qualified retirement plans or accounts. Participants who do not elect otherwise are automatically enrolled in the Plan with a salary deferral of 1% of eligible compensation. Additionally, participants who do not elect otherwise have their contribution deferral percentage automatically increased by 1% annually up to 4% of eligible compensation.

The Sponsor makes safe-harbor matching contributions equal to 100% of participants’ deferrals, not to exceed 6% of compensation.

Investment options

The Plan’s assets are held by Ascensus Trust Company (the “Custodian”), the custodian of the Plan’s assets. Under an arrangement with the Custodian and upon enrollment in the Plan, participants may direct all contributions in any whole percentage increments to any of the available funds. Participants may change their allocation among the various investment options at any time.

Participant accounts

Each participant’s account is credited with the participant’s contributions and any Sponsor contributions made on his or her behalf, as well as the earnings thereon, and are charged with distributions to the participant and allocations of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately 100% vested in the portion of their account attributable to their contributions and the Sponsor’s safe harbor contributions, plus earnings thereon.

Notes receivable from participants

Participants may borrow funds from their investment account balances, subject to certain limitations as detailed in the Plan document. The minimum loan amount is \$1,000, and the maximum is the lesser of \$50,000 or 50% of the vested interest in the participant’s account. The loans are secured by the balance in the participant’s account and principal and interest are paid ratably through monthly payroll deductions. Interest rates ranged, from 4.50% to 9.50% as of December 31, 2024, and from 4.25% to 9.50% as of December 31, 2023. Loans must be repaid within five years, and participants are allowed to have no more than two loans outstanding at a time.

Payment of benefits

Upon termination of employment, attainment of retirement age, as defined by the Plan, or for reasons of death or disability, participants may withdraw the vested portion of their account in the form of a lump sum or in partial installments. Participants still employed with the Sponsor may withdraw all or a portion of their account balance attributable to their salary deferral contributions and actual earnings thereon upon attainment of age 59½ or for reasons of a financial hardship, as allowed under the IRC. A participant whose

vested account balance does not exceed \$1,000 will receive a lump sum distribution of their vested account balance as soon as administratively feasible following termination. A participant whose vested account balance exceeds \$1,000 but does not exceed \$7,000 will have their vested account balance rolled over into an individual retirement account outside of the Plan in their name as soon as administratively feasible following termination of employment.

Administrative expenses

Administrative expenses charged to the Plan include transaction fees relating to certain participant-initiated transactions, as well as recordkeeping fees.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The accompanying financial statements are prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America.

Payment of benefits

Benefits are recorded when paid.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Interest income is recorded when earned. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are recorded as distributions based upon the Plan's provisions.

Expenses

Certain expenses incurred maintaining the Plan are paid directly by the Sponsor and are excluded from these financial statements. Investment related expenses are included in net appreciation/depreciation of fair value of investments.

Subsequent events

The Sponsor has evaluated subsequent events through October 13, 2025, the date that the financial statements were available to be issued.

3. INFORMATION CERTIFIED BY THE CUSTODIAN (UNAUDITED)

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by the Custodian, except for comparing such information certified by the Custodian to information included in the Plan's financial statements and supplemental schedule. The following information included in the Plan's financial statements was prepared and certified to as complete and accurate by the Custodian as of December 31, 2024 and 2023, and for the year ended December 31, 2024 :

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2

Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used during the year ended December 31, 2024.

- Mutual funds: Valued at the net asset value (“NAV”) of shares held by the Plan at year end. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- Participant-directed brokerage: Accounts primarily consist of mutual funds and common stocks that are valued on the basis of readily determinable market prices.
- Collective trusts: Valued at the NAV of units of the collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Sponsor believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. RELATED PARTY TRANSACTIONS

The Sponsor incurs costs on behalf of the Plan for recordkeeping, administration, and insurance and also provides services to the Plan at no cost.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants or their beneficiaries would receive the balances of their accounts under the terms of the Plan document.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. INCOME TAX STATUS

The Plan uses a prototype plan document sponsored by the Ascensus LLC who was informed by the IRS by a letter dated June 30, 2020, that the prototype plan is designed in accordance with the applicable sections of the IRC. Though the Plan has not received a determination from the IRS, the plan administrator believes that the Plan, as amended, is designed and is being operated in accordance with the applicable sections of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are no audits for any tax periods in progress, and the plan administrator believes that the Plan is no longer subject to income tax examinations for years prior to 2021.

10. PLAN AMENDMENTS

Effective January 1, 2024, the Sponsor increased the threshold for forced distributions of terminated participants from \$5,000 to \$7,000 as permitted under the SECURE 2.0 Act.

Effective January 1, 2024, the Sponsor implemented a change to hardship distribution requirements, allowing participants to self-certify hardship amounts, as permitted under the SECURE 2.0 Act.
