Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matter—Supplemental Schedule Required by ERISA**

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of BLVD Residential Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**A. General**

The Plan was established January 1, 1988 to provide retirement benefits to eligible employees of BLVD Residential Inc., formerly known as R.W. Zukin Corp. (the “Company”). The Plan was most recently amended and restated effective March 31, 2023. The plan administrator believes the Plan is designed and operated in compliance with applicable requirements of the Internal Revenue Code (the “Code”) and provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**B. Administration and Expenses**

Matrix Trust Company, is the trustee and custodian of the Plan. Vestwell Trust, is the third-party administrator and recordkeeper of the Plan and is responsible for maintaining participant records.

Participant accounts are charged asset based fees for record keeping and other administrative costs. Investment management fees include revenue sharing payments from Plan investment funds that are credited to participants who are invested in these funds. Fees for certain participant elective transactions are charged directly to participant accounts. Other costs of administering the Plan are paid for by the Company.

**C. Eligibility**

The Plan explicitly excludes nonresident aliens, collectively bargained employees, and temporary, part time and seasonal employees whose regularly scheduled service is less than 1,000 hours per year. Substantially all other employees of the Company who have attained age 21 are eligible to participate. Employees may enter the Plan on the first day of the month following attainment of eligibility.

**D. Participant Contributions**

Participants may elect to make pre-tax and/or Roth after-tax contributions to the Plan. Contributions are limited to applicable Code limits. Participants of age 50 or older may make additional catch-up contributions subject to annual Code limits. Participants who make pre-tax contributions to the Plan receive an equivalent reduction in taxable compensation.

**E. Employer Contributions**

The Company makes safe harbor matching contributions equal to 100% of the first 3% and 50% of the next 2% of eligible compensation deferred by each participant. The Plan permits additional matching and nonelective contributions at the Company’s discretion. No additional discretionary employer contributions were made in 2024.

**F. Vesting**

A participant is fully vested immediately as to voluntary contributions, rollover contributions and safe harbor matching contributions. A participant's vested percentage in accounts attributable to Company discretionary contributions, if any, is determined under a schedule that provides for full vesting after six years of credited service. Forfeitures of terminated participants' non-vested accounts may be used to reduce Company contributions or used to pay Plan expenses. During 2024, approximately \$1,500 in forfeitures were utilized to fund employer contributions to the Plan. The forfeiture account balance was \$0 as of December 31, 2024.

**G. Participant Accounts**

Each participant's account is credited with the participant's contributions, rollovers, Company contributions, and an allocation of Plan earnings or losses and expenses. Participants direct the investment of their accounts among a diversified group of investment funds provided under the Plan.

**H. Payment of Benefits**

Normal retirement age under the Plan is age 65. The Plan provides early retirement to participants at age 55 who have completed their 6th year of participation. Participants are eligible for benefits upon attainment of age 59½, retirement, disability, or termination of service. Benefits are payable in a lump sum or installments. The Plan provides for mandatory distribution of accounts that are valued at \$5,000 or less. Hardship distributions are permitted from participant elective deferral accounts under limited circumstances on approval by the plan administrator. Benefits are recorded when paid.

**I. Notes Receivable from Participants**

The Plan allows participants to borrow a minimum of \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance. A loan is secured by a participant's vested account balance, bears interest at a fixed rate commensurate with rates charged by commercial lenders for similar types of loans, and must be repaid to the Plan within a five-year period, unless a loan is used for the purchase of a principal residence, in which case the maximum repayment period may be extended. Notes receivable from participants at December 31, 2024 carry interest rates between 8.75% and 9.50%.

Notes are measured at their unpaid principal balance plus accrued interest. Delinquent notes are recorded as a distribution based on the terms of the Plan document.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**A. Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**B. Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

**C. Investment Valuation and Income Recognition**

Plan investments are stated at fair value for all investments. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of investments are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Mutual fund capital gains distributions are included in dividends and interest. Net appreciation includes gains and losses on investments bought and sold as well as held during the year.

**D. Risks and Uncertainties**

Investments are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with investments, it is at least reasonably possible that changes in value of investments will occur in the near term and such changes could materially affect participant accounts and amounts reported in the financial statements.

**NOTE 3 - TAX STATUS**

The Company adopted a prototype plan that has received a favorable opinion letter from the Internal Revenue Service stating that the form of the Plan meets requirements for tax-exempt status. The Company believes the Plan is operated in accordance with and qualifies under applicable requirements of the Code and related state statutes and the trust, which forms a part of the Plan, is exempt from federal income and state franchise taxes.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 4 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. The accounts of participants affected by a partial or complete termination of the Plan are non-forfeitable and will be determined as of the termination date.

**NOTE 5 - PARTY-IN-INTEREST TRANSACTIONS**

Loans distributed to participants of the Plan are considered party-in-interest transactions by ERISA. There are no investments issued by Matrix Trust Company that are considered party-in-interest under ERISA regulations.

**NOTE 6 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule of assets (held at end of year) including investments held at December 31,

2024, net appreciation of investments and investment income for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by the custodian and trustee of the Plan, Matrix Trust Company.

**NOTE 7 - FAIR VALUE MEASUREMENTS**

Accounting guidance on measuring fair value establishes a hierarchy which prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. Under the fair value hierarchy Level 1 inputs are quoted prices for identical assets in an active market. Level 2 inputs are quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data. Level 3 inputs are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability. Plan investments included in the fair value hierarchy consist of mutual, exchange traded and money market funds which are valued at closing market prices, deemed to be actively traded and are thereby valued based on Level 1 inputs.
