Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Silver Cross Management Services Organization 401(k) Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024, and the related notes to the financial statements.

Note 1. Description of Plan

The following description of the Silver Cross Management Services Organization 401(k) Plan (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by Silver Cross Health System, Inc. (Company) for the benefit of its employees. Employees are immediately eligible for deferrals upon their date of hire. Employees are eligible for safe harbor matching contributions upon completion of one thousand hours of service. Premier Suburban Medical Group (PSMG) also participates in the Plan as a related employer. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA), as amended by subsequent legislation. Fidelity Management Trust Company is the trustee of the Plan.

Contributions

The Plan permits eligible employees through a salary deferral election to make annual contributions up to 100% of their eligible compensation subject to the limitations of the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. The participants may change their investment options daily. The Plan includes an auto enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan at 3% of eligible compensation unless they affirmatively elect not to participate. These contributions are invested in a designated target date fund based on participant age until changed by the participant. The Plan allows rollover contributions from other qualified plans.

The Company makes matching contributions equal to 100% of employees' salary deferral amounts on the first 4% of employees' compensation contributions. The Company may make additional discretionary contributions based on eligible plan compensation. During the years ended December 31, 2024 and 2023, the Company made no discretionary contributions.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's contributions and plan earnings (losses) and is charged with an allocation of administrative expenses (losses). Plan earnings are allocated to participants' accounts in direct proportion to their respective account balances, based on the performance of participants' investment selections. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

Participants are immediately fully vested in participant, rollover and employer nondiscretionary matching contributions plus the actual earnings (losses) thereon.

Notes Receivable From Participants

Participants may borrow a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their account balance. These loans are secured by the balance in the participant's account and bear an interest rate (range from 5.75% to 9.50% as of December 31, 2024) as determined by the

Company based on prevailing interest rates. Loans are repayable through payroll deductions over a period not to exceed 5 years, except for loans to purchase a principal residence, which are repayable up to 15 years.

Payment of Benefits

Upon termination of service due to death, disability or retirement, retirement, a participant may elect to receive either a lump-sum or installment payments. Benefits are recorded when paid.

Reclassifications

Certain reclassifications have been made to the 2023 financial statements to conform to the 2024 financial statement presentation. These reclassifications had no effect on changes in net assets available for benefits.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the modified cash basis, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States (GAAP). Contributions are recorded when received and expenses are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis and dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based on the terms of the plan document.

Administrative Expenses

Administrative expenses may be paid by the Company, Plan or the participants, as defined in the plan service agreement. Additionally, certain employees of the Company provide administrative and trustee services to the Plan and are not reimbursed by the Plan for such services.

Note 3. Certification of Plan Trustee

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedules is complete and accurate:

- Investments, at fair value, and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income components and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information and notes receivable from participants included in the accompanying supplemental schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedules.

Note 4. Related-Party and Party-in-Interest Transactions

Certain plan investments are shares of registered investment companies managed by the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

The amount of trustee and record-keeping fees collected from participant accounts is used to offset plan expenses. The Plan has a revenue-sharing agreement whereby certain investment managers return a portion of the investment fees to the recordkeeper and these revenue sharing payments are then credited to participant accounts based on their investment options. Such payments are not material to the Plan. Qualified reimbursable Plan expenses in excess of revenue sharing payments are reported as administrative expense net of revenue sharing on the statement of changes of in net assets available for benefits.

Note 5. Fair Value Measurements

Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets, quoted market prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. There have been no changes in the methodologies used at December 31, 2024.

Registered investment companies and self-directed brokerage are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1).

Common or collective trust funds are valued at net asset value (NAV) of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the funds less their liability. This practical expedient is not used when it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV. There are no participant redemption restrictions for these investments, and participant redemptions are allowed daily. A redemption notice period is applicable only at the plan level. There were no unfunded commitments at December 31, 2024 and 2023.

Fair values of publicly traded common and preferred stocks, registered investment companies, U.S. government securities and corporate bonds contained in self-directed brokerage accounts are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1). Investments in self-directed brokerage accounts consisting of money market funds and certificates of deposit are valued at cost, which approximates fair value (Level 1 inputs).

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

Note 7. Tax Status

The Plan adopted a nonstandardized pre-approved profit sharing plan sponsored by FMR, LLC. The Internal Revenue Service (IRS) has determined and informed Fidelity Management in a letter dated June 30, 2020, that the Plan is qualified and tax exempt under the appropriate sections of the Internal Revenue Code (IRC). The Plan has been amended since Fidelity Management received the opinion letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

The modified cash basis of accounting requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9. Delinquent Participant Contributions

The Company made late contributions totaling \$962 during the plan year ended December 31, 2023. The Company will utilize the Department of Labor Voluntary Fiduciary Corrections Program calculator to determine lost earnings to self-correct these delinquent contributions. The lost earnings were contributed during the 2024 plan year.

Note 10. Subsequent Events

Subsequent events have been evaluated through October 8, 2025, which is the date the financial statements were available to be issued.
