### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the accompanying financial statements of Health Holdings, LLC 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.



## NOTES TO FINANCIAL STATEMENTS

---

### NOTE 1. DESCRIPTION OF THE PLAN

---

The following description of the Health Holdings, LLC 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan covering substantially all employees of Heath Holdings Company, LLC, Palm Medical Center Tampa, LLC, and Strategic Medical Group TX, PLLC (collectively the "Company", "Plan Sponsor", or "Employer") who have completed 90 days of service and attained the age of 21 years. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### *Contributions*

Each year, participants may contribute up to 100% of their pre-tax and/or after-tax basis annual compensation, as defined in the Plan, up to the statutory maximum. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans, as rollover contributions. The Company may make discretionary matching contributions. For the year ended December 31, 2024, the Company did not make discretionary matching contributions into the Plan. In addition, the Company may elect to make a qualified non-elective employer contribution to the Plan. For the year ended December 31, 2024, the Company did not make any qualified non-elective employer contributions into the Plan. In order to share in matching or employer contributions, participants must have at least 1,000 hours of service during the Plan year and be employed on the last day of the Plan year.

#### *Participant Accounts*

Each participant's account is credited with the participant's contribution, an allocation of the Employer's contribution and earnings from participant directed investments, net of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### *Vesting*

Participants are immediately vested in their contributions, matching and Employer contributions, plus actual earnings thereon. As participants are immediately vested in all amounts in their account, there are no forfeitures.

#### *Investment Options*

Upon enrollment in the Plan, a participant may direct the investment of their contributions to various investment options offered by the Plan. The Plan allows participants to change their investment options daily.

---

---

***Notes Receivable from Participants***

A participant may borrow from their fund account a minimum of \$1,000 up to a maximum equal to the lesser of 50% of a participant's vested account balance or \$50,000. Participants may only have one loan outstanding at a time. Notes receivable from participants range from one to five years, except in the case of a loan for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear an interest rate commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest is paid ratably through payroll deductions.

***Plan Administration***

The Plan is administered by the Company. The Plan's assets are maintained by its Custodian, Equitable Financial Life Insurance Company ("Custodian" or "Equitable").

***Payment of Benefits***

On termination of service due to termination of employment, death, disability, or retirement, a participant or their beneficiary may elect to receive the vested portion in the participant's account in a lump sum distribution if the balance does not exceed \$5,000. If the participant's balance exceeds \$5,000 then the participant may receive a lump sum distribution or partial distributions. Types of in-service withdrawals available under the Plan are withdrawals after attaining 59 ½ years of age and hardship withdrawals.

***Plan Termination***

Although it has not expressed any intent to do so, the Company has the right under Plan provisions to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would remain 100% vested in their matching and Employer contributions.

**NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

---

***Basis of Accounting***

The financial statements of the Plan are prepared using the accrual method of accounting.

***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value. The Plan's investments in pooled separate accounts are stated at the net asset value as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments less its liabilities. The guaranteed interest account is included in the financial statements at fair value, which approximates contract value as reported to the Plan by the Custodian.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

**NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

---

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

***Benefit Payments***

Benefits are recorded when paid.

***Plan Expenses***

Certain administrative functions are performed by employees of the Company. No such employees receive compensation from the Plan. Certain administrative expenses, such as professional fees, are paid directly by the Company. Plan expenses are recorded when incurred.

***Party-In-Interest Transactions***

Plan investments are managed by Equitable. Equitable is the custodian as defined by the Plan and therefore, these transactions qualify as party-in-interest transactions. The Plan also has notes receivable from participants that qualify as party-in-interest transactions.

***Risk and Uncertainties***

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

***Concentrations***

All of the Plan's investment assets are held by its custodian, Equitable, located in New York, New York.

***Use of Estimates in the Preparation of Financial Statements***

The preparation of financial statements, in conformity with accounting principles generally accepted in the United States of America, requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**NOTE 3. INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIAN (UNAUDITED)**

For the year ended December 31, 2024, the Plan's investments (including gains and losses on investments bought and sold, as well as held during the Plan year) appreciated in value by \$243,524. In addition, interest relating to the Plan's investments and interest on notes receivable from participants amounted to \$3,056 and \$5,338, respectively. At December 31, 2024 and 2023, the interest rates on notes receivable from participants ranged from 4.25% to 9.50% and 4.25% to 9.25%, respectively.

---

**NOTE 4. FAIR VALUE MEASUREMENTS**

---

Generally accepted accounting principles require the Plan to report its investments at estimated fair value on a recurring basis. Fair value is measured by a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

- Level 1** Inputs to the valuation methodology are unadjusted quoted market prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2** Inputs to the valuation methodology include:
- quoted prices for similar assets or liabilities in active markets;
  - quoted prices for identical or similar assets or liabilities in inactive markets;
  - inputs other than quoted prices that are observable for the asset or liability;
  - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**NOTE 4. FAIR VALUE MEASUREMENTS (Continued)**

**Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A description of the valuation methodologies the Plan uses for assets measured at fair value is included in Note 2. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The methodologies may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5. EXCESS CONTRIBUTIONS PAYABLE**

---

The Plan failed the discrimination test for the year ended December 31, 2024, resulting in excess contributions amounting to \$66,205. The excess contributions are recorded as liabilities in the accompanying statements of net assets available for benefits and were subsequently disbursed to participants in 2025, except for \$7,928 which was reimbursed to a participant during 2024. The excess contributions during 2024 are recorded as a reduction of participant contributions in the accompanying statement of changes in net assets available for benefits.

---

**NOTE 6. NONEXEMPT PARTY-IN-INTEREST TRANSACTIONS**

---

During 2024 and 2023, there were unintentional delays by the Company in submitting employee contributions and loan repayments to the Custodian of \$152,568 and \$466, respectively. The Company submitted the delayed contributions and loan repayments in the same period of the unintentional delays. Lost earnings for both years, which were not significant to the financial statements, were submitted during 2025. These late remittances are reported in the Form 5500 as a nonexempt prohibited transaction.

---

**NOTE 7. INCOME TAX STATUS**

---

The Plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

The Plan assesses its tax positions in accordance with “*Accounting for Uncertainties in Income Taxes*” as prescribed by the Accounting Standards Codification, which provides guidance for financial statement recognition and measurement of uncertain tax positions taken or expected to be taken in a tax return for open tax years (generally a period of three years from the later of each return’s due date or the date filed) that remain subject to examination by the Plan’s major tax jurisdictions.

The Plan assesses its tax positions and determines whether it has any material unrecognized liabilities for uncertain tax positions. The Plan records these liabilities to the extent it deems them more likely than not to be incurred. Interest and penalties related to uncertain tax positions, if any, would be classified as a component of income tax expense.

The Plan believes that it does not have any significant uncertain tax positions requiring recognition or measurement in the accompanying financial statements.
