The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of National DCP 401(k) Profit Sharing Plan and Trust (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan is a defined contribution plan established for the benefit of the employees of National DCP, LLC (the "Company," "Sponsor," or "Employer").

General

The Plan is sponsored by the Company and is a profit-sharing plan under Internal Revenue Code (the "IRC") Section 401(a) and includes a cash or deferred arrangement that is intended to qualify under IRC Section 401(k). The Plan is established and maintained for the exclusive benefit of eligible employees and their beneficiaries. The Plan covers all employees of the Sponsor who have completed 90 days of service and are age 18 or older except for collectively bargained employees, non-resident aliens who receive no compensation from the Company which constitutes U.S. source income and leased employees. The Plan is subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

On June 1, 2024, the Company changed the recordkeeper, custodian and trustee for the Plan from John Hancock Trust Company, LLC ("John Hancock") to Voya Retirement Insurance and Annuity Company ("Voya").

Contributions

Participants may elect to contribute any percentage of their eligible compensation, not to exceed annual limitations as provided by the IRC. Participants may also rollover amounts representing distributions from other qualified defined benefit or contribution plans. The Plan also allows for Roth contributions. The Plan offers an automatic deferral and escalation election. Under this feature, upon satisfaction of eligibility requirements, participants will be automatically enrolled in the Plan with a deferral of 3% of compensation. The automatic deferral will increase each year by 1% of the participant's compensation up to a maximum of 6%, unless the participant designates otherwise under a salary reduction agreement.

The Plan qualifies as a safe harbor plan. Based upon the safe harbor provisions, the Sponsor will make a safe harbor matching contribution equal to 100% of the first 1% of the employee's compensation plus 50% of the next 5% of compensation. In addition, the Sponsor may elect to make matching contributions under the Plan. This Sponsor match is discretionary and is limited to 4% of a participant's compensation. A participant must complete one year of service, as defined, and generally be employed with the Sponsor on the last day of the Plan year to be eligible for the Sponsor's discretionary contribution. Additional profit-sharing amounts may be contributed at the option of the Company's Board of Directors (the "Board") and are invested in a portfolio of investments as directed by the Company. For the year ended December 31, 2024, the Company did not make a profit sharing contribution to the Plan. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

Vesting

Participants are immediately vested in their voluntary contributions plus the allocation of Plan earnings on those contributions at the time of allocation. Participants vest in the Company contributions as follows: 20% after one year, 40% after two years, 60% after three years, 80% after four years and 100% after five years. Each participant shall be 100% vested in his or her Company account upon death or disability. A participant's vested interest in the participant's safe harbor matching contributions shall be 0% until the participant has completed two years of vesting service, at which time the participant's vested interest in the safe harbor matching contributions shall be 100%.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contribution and (b) Plan earnings and charged with an allocation of administrative expenses and withdrawals. Allocations are based on participant deferral contributions, compensation, or account balances, as applicable and pursuant to the terms of the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$450,369 and \$201,072, respectively. These accounts will be used to reduce plan expenses and future employer contributions. In 2024, employer contributions were reduced by \$148,280 and no plan expenses were reduced from forfeited nonvested accounts.

Notes Receivable from Participants

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the vested balance in the participant's account. For loans originated prior to June 1, 2024, notes bear interest at the prime rate plus 1%. Loans originated on or after June 1, 2024 bear interest at the prime rate plus 2%. Note terms are up to five years, except for notes used to fund the purchase of a principal residence, for which the note may be repaid over a reasonable period that may exceed five years but may not extend beyond 10 years. Principal and interest are paid ratably through payroll deductions. A participant may only have one loan outstanding from the Plan at any time.

Benefit Payments

Upon retirement, death, disability, termination of service, financial hardship, or the attainment of age 59½, the participant will receive a lump sum distribution of his or her vested account balance as soon as administratively practicable following the date the request for distribution is made or is otherwise due. The participant may request an alternative payment schedule as specified in the Plan document. Generally, participants must begin receiving period benefit payments by April 1st of the calendar year following the calendar year in which they attain age 73 or such later age as may be allowed by law under the terms of the Plan.

Reclassification

Certain prior period amounts have been reclassified for consistency with the current year presentation. This reclassification had no effect on the reported net assets or changes in net assets as of and for the year ended December 31, 2023.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein

and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan provides for investment options such as, but not limited to, a variety of investment securities. Investment securities in general are exposed to various risks, such as interest rate, market volatility, and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Investment Valuation and Income Recognition

Investments are reported at fair value and contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). Contract value represents contributions made under the contract, plus interest at the contract rate, less withdrawals and administrative expenses. The Sponsor's Board determines the Plan's valuation policies utilizing information provided by the investment advisors.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned daily and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees paid by the Plan include recordkeeping fees and investment advisor fees. Investment related expenses are included in net appreciation in fair value of investments.

Benefit Payments

Benefit payments are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants represent loans to participants and are measured at the unpaid principal balance plus any accrued and unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Subsequent Events

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through October 13, 2025, the date the financial statements were available to be issued.

NOTE 3 - CERTIFIED INVESTMENTS

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") *Rules and Regulations for Reporting and Disclosure under ERISA*.

Accordingly, John Hancock and Voya, qualified institutions and trustees of the Plan have certified the investment information detailed below and included in the accompanying financial statements and ERISA-required supplemental schedule are complete and accurate:

- Investments, at fair value and contract value and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net investment income and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

NOTE 4 - FAIR VALUE OF MEASUREMENTS

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. No changes have been made in investment methodology at December 31, 2024 and 2023.

Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different estimate of fair value at the reporting date.

NOTE 5 - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan has a fully benefit-responsive investment contract with Massachusetts Mutual Life Insurance Company ("MassMutual"), which maintains the contract within a pooled separate account. Contributions are deposited into the account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The objective of the contract is to provide a stable, low-risk investment option offering competitive yields, allowing participants to earn current income while preserving principal.

Under the terms of the contract, MassMutual is contractually obligated to repay principal plus interest at crediting rates that are periodically reset but not less than 0%. The contract is designed to permit participant-initiated withdrawals and transfers at contract value, provided such transactions are allowed by the Plan.

The investment contract meets the fully benefit-responsive investment contract criteria, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because it represents the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Certain events may limit the ability of the Plan to transact at Contract Value. Such events include, but may not be limited to, the following: (1) the complete or partial termination of the Plan; and (2) the establishment or activation of, or material change in any Plan investment fund, or an amendment to the Plan or a change in the administration or operation of the Plan, including the removal of a group of employees from Plan coverage as a result of the sale or liquidation of a subsidiary or a division or as a result of group layoffs or

early retirement programs. However, the Plan Administrator believes the occurrence of such events that would also limit the Plan's ability to transact at contract value with participants is not probable.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their Company contributions.

NOTE 7 - TAX STATUS

The Plan operates under a John Hancock sponsored volume submitter profit-sharing plan during the year. The volume submitter profit-sharing plan has received an advisory letter from the IRS dated June 30, 2020 stating that the form of the volume submitter plan is qualified under Section 401(a) of the IRC and, therefore, the related trust is tax-exempt. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with applicable requirements of the IRC. The Plan Administrator believes the Plan is qualified and the related trust is tax exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires the Company to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements and has determined that there are no such tax positions as of December 31, 2024 and 2023. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 - PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Sponsor and certain others. Certain Plan investments are managed by Voya; therefore, these transactions qualify as party-in-interest transactions. Actual fees incurred by the Plan for record keeping and custodial service during 2024 are included within administrative expenses and also qualify as party-in-interest transactions. The Plan also held notes receivable from participants which qualify as party-in-interest transactions.
