We have performed audits of the accompanying financial statements of D & B Supply Co. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits (modified cash basis) for the years then ended and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of D & B Supply Co. 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended stating that the certified investment information, as described in Note 10 to the financial statements, is complete and accurate.

Opinion

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of D & B Supply Co. 401(k) Profit Sharing Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Basis of Accounting

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. The financial statements and supplemental schedule are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to that matter.

Emphasis of Matter

The accompanying financial statements have been prepared assuming that the Plan will continue as a going concern. As discussed in Note 3 to the financial statements, the Administrative Committee of D & B Supply, LLC, the D & B Supply, Co. 401(k) Profit Sharing Plan's sponsor, voted to merge the Plan, which indicates that the Plan is not a going concern. The financial statements do not include any adjustments that might be necessary upon merging. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2; this includes determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about D & B Supply Co. 401(k) Profit Sharing Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

1. DESCRIPTION OF PLAN

The following description of D & B Supply Co. ("Company") 401(k) Profit Sharing Plan ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General. The Plan is a defined contribution plan covering all full-time employees of the Company who have completed two months of service and are age twenty-one or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions. Amounts contributed to the Plan consist of employee deferrals, Company matching contributions, and Company discretionary contributions. The Plan was amended as of July 15, 2019 to include an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate of 4% of the participants' qualified wages with an increase of 1% up to a maximum of 8% scheduled to occur each June 1 of the following year. Contributions are to be automatically invested in a designated balanced fund until changed by the participant. The Plan was further amended July 15, 2020 to include a provision whereby all Plan participants who were enrolled prior to the July 15, 2019 amendment are now eligible to receive a 1% automatic deferral increase up to a maximum of 8%. The date of the increase was also changed from June 1 to January 1 starting January 1, 2021. The Company makes matching contributions to the participants' account in an amount equal to 50% of the participants' deferral contribution, but not in excess of 4% of the participants' qualified wages. Employee contributions for the years ending December 31, 2024 and 2023 are subject to statutory deferral limits of \$23,000 and \$22,500, respectively. Employees aged 50 and over are eligible to make additional catch-up deferral contributions for the years ending December 31, 2024 and 2023 of \$7,500. No Company discretionary contribution was made in 2024 or 2023.

Participants' Accounts. Each participant's account is credited with the salary deferral elected, the Company's matching contribution, an allocation of the Company's discretionary contribution, Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participants' earnings, contributions, or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting. Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service with the Company as follows:

Payment of Benefits. Upon termination of service, a participant may elect to receive a lump sum amount equal to the vested value of his or her account, or annuity payments.

Investment Options. Upon enrollment in the Plan, a participant may direct employee and employer contributions in a combination of investment options. Participants may contact the Plan record keeper directly over the internet and change their investment selections.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Investments

Management fees and operating expenses charged to the Plan for investments in the registered investment companies funds, the common collective trusts, and the investment contract are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Administrative Expenses

Certain administrative functions are performed by officers and employees of the Company, No such officer or employee received compensation from the Plan. In addition, certain administrative expenses are paid directly by the Company, and are not reflected in these financial statements.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Basis of Accounting

The financial statements of the Plan are prepared on the modified cash basis. Under that basis, revenues and contributions are recognized when received rather than when earned, and expenses are recognized when paid rather than when incurred. Accordingly the statements are not intended to present net assets available for benefits or changes in net assets available for Plan benefits in conformity with accounting principles generally accepted in the United States of America.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

Use of Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies. See Note 9 for discussion of fair value measurements.

Purchase and sales of securities are recorded on the modified cash basis. Dividends are recorded when received. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year. Capital gain distributions and dividends are included with net change in fair value of investments.

Payment of Benefits

Benefits are recorded when paid.

Events Occurring After Reporting Date

The plan administrator has evaluated events and transactions that occurred between December 31, 2024 and October 10, 2025, which is the date that the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

3. PLAN TERMINATION

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts. In July 2025, the Plan Sponsor merged the plan into Mid-States Multiple Employer 401(k) Plan.

4. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

5. GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan entered into a fully benefit-responsive investment contract with American United Life Insurance Company. American United Life Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

5. GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY (CONT'D)

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attributed for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statements of net assets available for benefits at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023 was \$1,206,994 and \$1,045,349, respectively. The crediting interest rates are set by American United Life Insurance Company using a process similar to that used by banks or other insurance companies for similar products. Such rates are reviewed and reset quarterly. The crediting rates as of December 31, 2024 and 2023 were 2.5% and 1.75%, respectively.

Contract value, as reported to the Plan by American United Life Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events may limit the Plan's ability to transact at contract value. Such events include but may not be limited to the following: (1) the complete or partial termination of the Plan or (2) the establishment or activation of, or material change in, any Plan investment fund, or an amendment to the Plan or change in the administration or operation of the Plan, including the removal of a group of employees from Plan coverage as a result of the sale or liquidation of a subsidiary or division or as a result of group layoffs or early retirement programs. The Plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with Plan participants or the issuer, is probable.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

6. FORFEITED NONVESTED ACCOUNTS

Forfeitures of \$54,351 and \$46,579 were used to reduce Company contributions and pay administrative expenses in 2024 and 2023, respectively. The balances of forfeited accounts available to pay administrative expenses or reduce Company contributions as of December 31, 2024 and 2023 were \$0 and \$0, respectively.

7. TAX STATUS

The Plan was amended and restated on May 1, 2022 to comply with Cycle 3 requirements. The Plan restatement is a Volume Submitter Plan. The Volume Submitter Plan, adopted May 1, 2022, obtained its latest determination letter on August 19, 2020, in which the Internal Revenue Service stated that the Plan as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, the Plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

8. RELATED PARTY TRANSACTIONS

Because the Plan invests in a guaranteed investment contract with American United Life Insurance Company and American United Life Insurance Company is a custodian and provides recordkeeping services to the Plan, it is defined as a party-in-interest. Recordkeeping fees paid by the Plan to American United Life Insurance Company amounted to \$3,056 and \$7,282 for the years ended December 31, 2024 and 2023, respectively.

9. FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were used only when Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented, and there were no changes in the methods used to measure fair value at December 31, 2024 and 2023.
