NOTES TO FINANCIAL STATEMENTS
YEARS ENDED DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following description of the Regal Rexnord 401(k) Plan (the “Plan”), formerly known as the Altra Industrial Motion Corp. 401(k) Savings Plan, is provided for general information purposes only. More complete information regarding the Plan’s provisions may be found in the Plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

Effective December 31, 2023, the TB Woods, Inc. 401(k) Savings Plan (“TB Woods Plan”) merged into the Plan; as a result of this merger, the Plan acquired \$14,151,544 of investments at fair value, \$4,352,642 of investment at contract value and \$308,583 of participant notes.

On December 29, 2023, the TB Wood's Plan trustee executed liquidation trades and registration transactions. Liquidation trades totaled \$14,010,426 and are presented as due from broker on the statements of net assets available for benefits. Registration transactions for transfers in-kind totaled \$4,493,760, of which, \$141,118 and \$4,352,642 are presented in investments at fair value and investment at contract value in the statements of net assets available for benefits, respectively.

Effective January 1, 2024, the Plan changed recordkeeper, trustee and custodian from Fidelity Management Trust Company (“Fidelity”) to Empower Retirement (“Empower”); as a result of the change in service provider, liquidation trades of \$232,547,525 were presented as due from broker at December 31, 2023. Registration transactions for transfers in-kind totaled \$24,386,788, of which, \$6,164,905 and \$18,221,883 are presented in investments at fair value and investment at contract value in the statements of net assets available for benefits, respectively.

General

The Plan is a defined contribution plan covering US based employees of adopting employers of Regal Rexnord Corporation (the “Company”) and not covered by other qualified plans. An employee is eligible to participate in the elective deferral and Company matching feature of the Plan as of the date of employment, unless the employee is a collectively bargained employee, for which eligibility is in effect per the applicable collective bargaining agreement. Plan management is responsible for oversight of the Plan. The Plan’s retirement committee determines the appropriateness of the Plan’s investment offerings and monitors investment performance. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Contributions

Contributions to the Plan are made by both the Company and participants. Each year, participants may elect to defer up to 100% of their eligible compensation, as defined in the Plan, on a pretax and/or after-tax Roth basis, subject to Internal Revenue Service (“IRS”) limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

Effective January 1, 2024, the Plan implemented an Automatic Enrollment feature as allowed pursuant to the Pension Protection Act of 2006. This auto enrollment is applicable to all employees newly eligible to participate in the Plan who are not subject to a separate union agreement. These participants are auto enrolled for a 3% payroll deferral. These contributions are defaulted in the Vanguard Target Retirement funds based on the employee's age absent an investment fund election.

Effective January 1, 2024, participating non-union employees receive a safe harbor matching contributions equal to 100% of the first 2% of the participant’s eligible compensation contributed to the Plan and 50% of the next 4% of the participant’s eligible compensation contributed to the Plan. The Company did not make a discretionary contribution to non-union employees for the plan year ended December 31, 2024. Contributions to union employees, including

automatic and matching payments, are made pursuant to the collective bargaining agreements with the Union of which the Union employee is a member.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions and (b) plan earnings or losses and charged with an allocation of administrative expenses. The Company's contribution will apply only to a participant's applicable contributions that do not exceed a dollar amount or percentage of eligible compensation that is uniformly determined by the Company for all eligible participants. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately fully vested in their contributions plus actual earnings thereon. Non-union employees eligible to participate in the Plan prior to January 1, 2024 are immediately fully vested in all non-elective Company contributions and safe harbor matching contributions and fully vested in all discretionary Company matching contributions after one year of service. Non-union employees eligible to participate in the Plan after December 31, 2023 are subject to a two-year cliff vesting for company contributions. In the event of death or permanent disability, a participant's employer contribution account becomes fully vested.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans must be fully repaid within five years or within ten years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 10.50% as of December 31, 2024 and 4.25% to 9.50% as of December 31, 2023, which are commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant is entitled to receive a lump-sum amount equal to the participant's vested interest in his or her account. For termination of service due to other reasons, a participant may elect to defer payment until normal retirement age, provided the participant's vested balance is greater than \$7,000, or receive a single lump-sum payment or direct rollover to an IRA as soon as reasonably practicable following termination of employment.

Forfeitures

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$129,810 and \$55,765, respectively. Forfeited non-vested amounts can be used to reduce plan expenses and the Company's contribution obligations to the Plan. During 2024, \$179,258 was used to reduce the Plan's expenses and company contribution obligations

2. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisers, trustee, and insurance company. See Note 4 for discussion of fair value measurements. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

3. CERTIFIED INVESTMENTS

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity and Metropolitan Life Insurance Company ("MetLife") have certified the following December 31, 2023 data included in the accompanying financial statements. Empower and Metropolitan Life Insurance Company ("MetLife"), have certified the following December 31, 2024 data included in the accompanying financial statements and supplemental schedules as complete and accurate:

- Investments at fair value, investments at contract value, due from broker and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023;
- Investment income and interest income on notes receivable, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024;
- Schedule H, line 4(i) - schedule of assets (held at end of year) as of December 31, 2024.

4. FAIR VALUE MEASUREMENTS

In accordance with the Financial Accounting Standards Board's statement on Fair Value Measurements, the Plan classifies its investments into Level 1, which refers to securities valued using quoted prices from active markets for identical assets, Level 2, which refers to securities not traded on an active market but for which observable market inputs are readily available, and Level 3, which refers to securities valued based on significant unobservable inputs. Common collective trust funds are valued based on the net asset value (“NAV”) provided by the administrator of the fund as a practical expedient to estimate fair value. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. Investments in units of collective trust funds and short-term investment funds, comprised of cash and money market funds, are valued at their respective published market prices as reported by the funds daily. At December 31, 2024 and 2023, the Plan's portfolio investments were classified as follows based on fair values:

6. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan's guaranteed interest contract is a fully benefit-responsive investment contract with MetLife. MetLife maintains the contributions in a separate account used solely to satisfy the claims of the contract holder. The account is credited with participant contributions and earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The Guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

As described in Note 2 the guaranteed interest contract is included in the financial statements at contract value as reported to the Plan by MetLife. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The average crediting interest rate is set quarterly.

Certain events limit the ability of the Plan to transact at contract value with MetLife. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Company or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

8. TAX STATUS

The pre-approved Plan has obtained an opinion letter dated November 14, 2022, in which the IRS stated that the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (the “Code”). The Plan administrator timely adopted the pre-approved plan. Although there have been amendments to the Plan since this opinion letter, the plan administrator believes that the Plan is currently being operated in accordance with the Code and, therefore, believes that the Plan was qualified as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain tax position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants’ account balances and the amounts reported on the statements of net assets available for benefits.

10. RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Prior to January 2, 2024, certain plan investments were managed by an affiliate of Fidelity. Fidelity was the trustee as defined by the Plan, and, therefore, these transactions qualified as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments. Notes receivable from participants are also exempt party-in-interest transactions.

Fidelity provided certain administrative services to the Plan pursuant to a Master Plan Services Agreement (“MSA”) between the Company and Fidelity. Fidelity received revenue from mutual fund service providers for services Fidelity provides to the funds. This revenue was used to offset certain amounts owed to Fidelity for its administrative services to the Plan.

If the revenue received by Fidelity from such mutual fund service providers exceeded the amount owed under the MSA, Fidelity remitted the excess to the Plan’s trust on a quarterly basis. Such amounts may be applied to pay plan administrative expenses or allocated to the accounts of the participants. During 2024, \$27,723 was remitted to the Plan’s trust and is included in other income on the statement of changes in net assets available for benefits. The Plan or plan sponsor may make a payment to Fidelity for administrative expenses not covered by revenue sharing. During the year ended December 31, 2024, no direct payments were made to the third-party administrator that were not covered by revenue sharing.

After January 1, 2024, Fees paid by the Plan for investment management and recordkeeping service by Empower are included as a reduction of the return earned by each fund. These transactions are not considered prohibited transactions by statutory exemption under ERISA regulations.

11. SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.
