Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

**NOTE 1: DESCRIPTION OF THE PLAN**

The following brief description of the Mays Housecall Home Health, Inc. 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more comprehensive description of the Plan’s provisions.

**General**

The Plan is a defined contribution plan covering all of the permanent employees of Mays Housecall Home Health, Inc. and its related sister companies, Mays Home Health TX, LLC, Mays Plus, Inc., Mays Hospice Care, Inc., Mays Home Health TX, LLC, Health Watch Health Care, LLC, Health Watch Health Care KS, LLC, HWatch Health Care TX, LLC, Central Pyramid Accounting, Inc., Skyline Care Clinics of TX, LLC, Skyline Wellness Management Services of TX, LLC and all other subsidiaries and otherwise related companies. (collectively, referred to herein as the “Company”) who have attained 18 years of age and completed one year of service (working at least 1,000 hours). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

**Contributions**

Each year, participants may contribute up to 90% of pretax annual compensation, as defined in the Plan or contributions can be made after-tax in the form of a Roth contribution. Annual employee contributions are limited under the Internal Revenue Code. Additionally, participants age 50 and above may make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company, at its discretion, may match up to 6% of compensation that a participant contributes to the Plan. All funding is made pursuant to DOL regulations.

**Participant Accounts**

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contribution and (b) Plan earnings. The benefit to which a participant is entitled is the participant’s vested account.

**NOTE 1: DESCRIPTION OF THE PLAN (Continued)**

**Vesting**

Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the Company's matching portion of their accounts, plus actual earnings thereon is based on years of continuous service. A participant is 20% vested after two year of service, 40% after three, 60% after four, 80% after five and is vested 100% after six years of credited service. Forfeited balances of terminated participants' nonvested accounts may be used to reduce future Company contributions.

**Forfeitures**

When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account, as defined by the Plan, represents a forfeiture. Forfeitures are used to reduce the Company's matching contributions for the Plan year. However, if a participant is re-employed and fulfills certain requirements, as defined by the Plan, that participant's account will be reinstated. As of December 31, 2024, forfeited nonvested accounts amounted to \$195,220. For the year ended December 31, 2024, Company matching contributions were not reduced from forfeited nonvested accounts.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts. The minimum loan is \$1,000 and the maximum amount is the lesser of one-half of the participant's account balance or \$50,000. Loan terms are no more than five years unless such loan is for the purchase of a participant's primary residence, in which case the repayment period may not exceed ten years. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with prevailing local rates. As of December 31, 2024 interest rates range from 4.25% to 9.50%. Principal and interest are paid through monthly payroll deductions.

**Payment of Benefits**

On termination of service due to death, disability, retirement, termination of employment or other reasons, a participant is paid in a lump-sum amount equal to the value of the participant's vested interest in his or her account.

**Plan Termination**

Although it has not expressed any interest to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become vested 100% in their accounts.

**Administrative Expenses**

Plan administrative costs are mostly paid by the Company in accordance with the Plan. Additional fees are charged for participants who elect to obtain a participant loan or take distributions. These fees are deducted directly from the participant's account.

**NOTE 2: SUMMARY OF ACCOUNTING POLICIES**

**Basis of Accounting**

The Plan uses the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

**Investment Valuation and Income Recognition**

The Plan's investments are stated at fair market value based on quoted market prices. Loans to participants are valued at cost, which approximates fair value. Purchases and sales of securities are recorded on the trade date, and interest and dividend income are recorded on the accrual basis. Net appreciation (depreciation) in the value of investments includes the change in market value of all plan investments (those bought, sold and held during the year), realized and unrealized gains, and amounts reinvested in the pooled funds. This information is subject to the trustee certification.

**Payment of Benefits**

Plan benefits are recorded when paid, and not when the event giving rise to the payment occurs. Consequently, lump sum payments due to terminated employees which remain unpaid at the end of a plan year are not recorded as liabilities of the Plan.

**Use of Estimates**

The preparation of financial statements requires the plan administrator to make estimates and assumptions which affect certain reported amounts and disclosures. Examples of estimates used by the plan administrator which affect reported amounts might include the calculation of accrued interest and the valuation of investments in situations where quoted market prices are not available. Actual results could differ from those estimates.

**Risks and Uncertainties**

The Plan provides for various investment options in any combination of stocks, bonds, fixed income securities, mutual funds and other investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for plan benefits.

**NOTE 3: TAX STATUS**

The Plan obtained its latest opinion letter dated June 30, 2020, in which the Internal Revenue Service stated the Plan, as then amended, was in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examination for years ending prior to December 31, 2021.

**NOTE 4: FAIR VALUE MEASUREMENTS**

FASB ASC 820-10, *Fair Value Measurements – Overall*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurement).

The three levels of the fair value hierarchy under FASB ASC 820-10 are described below:

**Level 1**

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

**Level 2**

Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

**Level 3**

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the quoted net asset value of shares held by the Plan at year end as certified by the trustees.

The preceding methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
