## Independent Auditor's Report

To the Plan Administrator of The Crown Capital Fund, LLC 401(k) Plan

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed an audit of the financial statements of The Crown Capital Fund, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). **1. Description of Plan**

The following description of the The Crown Capital Fund, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

*General*

The Plan is a defined contribution plan established effective January 1, 2004, as restated January 1, 2024. The Plan covers all employees, excluding non-resident aliens and union employees, of The Crown Capital Fund, LLC (the Company or Employer) who have completed six months of service and are age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Retirement Plan Committee is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

*Contributions*

Each year, participants may contribute a percentage of pretax annual compensation, as defined in the plan document, up to the maximum limits of the Internal Revenue Code (IRC). Participants also may designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company contributes a safe harbor contribution annually equal to 4% of eligible compensation. Additional profit sharing amounts may be contributed at the option of the Retirement Plan Committee. For the year ended December 31, 2024, there were no profit sharing contributions to the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

*Participant accounts*

Each participant's account is credited with the participant's contributions, allocations of the Company's contributions and an allocation of the Plan's earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**1. Description of Plan (Continued)**

*Vesting*

Participants are vested immediately in their contributions and safe harbor contributions plus actual earnings thereon. Vesting in the Company's profit sharing contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after three years of credited service.

*Notes receivable from participants*

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined monthly, is set at 1 percent above the prime rate, as defined. Principal and interest are paid ratably through payroll deductions. Terms range up to five years or greater for the purchase of a primary residence.

*Payment of benefits*

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. If a terminated participant's vested balance is less than or equal to \$5,000, the amount may be automatically distributed in the form of lump sum cash payment or IRA, depending on the balance. In addition, the Plan allows for hardship distributions if certain criteria are met.

*Forfeited accounts*

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$27,882 and \$23,140, respectively. These accounts will be used to reduce future employer contributions or to pay plan administrative expenses. During 2024, no amounts were applied to plan activities from forfeited nonvested accounts.

**2. Summary of Accounting Policies**

*Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting. The Plan follows accounting standards set by the Financial Accounting Standards Board (FASB). The FASB sets accounting principles generally accepted in the United States of America.

*Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Retirement Plan Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company, as applicable. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred.

*Contributions*

Contributions from Plan participants and matching contributions paid to the Plan are recorded in the year in which the employee contributions are withheld from compensation.

Employer discretionary profit sharing contributions are recorded when such contributions are authorized by the Retirement Plan Committee.

*Payment of Benefits*

Benefits are recorded when paid.

*Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

*Subsequent Events*

Subsequent events were evaluated through October 13, 2025, the date the financial statements were available to be issued.

**3. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurement*, are described as follows:

Level 1 - Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation technique include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled separate accounts:* Valued based upon the unit values of such pooled accounts held by the Plan at year end. Unit values are based on the fair value of the underlying assets of the fund derived from inputs principally from or corroborated by observable market data by correlation or other means, although are not based upon quoted market prices in an active market. The underlying investments of the pooled separate accounts consist of mutual funds, each of which follows a separate investment strategy. Due to the nature of these pooled accounts, there are no unfunded commitments or redemption restrictions.

*Investments measured at net asset value:* Consisting of common-collective trusts, valued at the net asset value (NAV) of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

#### 4. Receivable from Merged Plans

On December 31, 2023, Aero Mist 401(k) Plan legally merged with the Plan pursuant to a board-approved plan amendment. As of year-end, the transfer of net assets totaling \$1,011,143 from the Aero Mist 401(k) Plan had not yet occurred. Accordingly, the Plan has recorded a receivable in the amount of \$1,011,143 representing the assets due from the merged plan. The transfer was completed on January 16, 2024, and the receivable was settled in full.

On December 31, 2023, CCI-AWE assets from the ADP TotalSource Retirement Savings Plan legally merged with the Plan pursuant to a board-approved plan amendment. As of year-end, the transfer of net assets totaling \$1,166,066 from the ADP TotalSource Retirement Savings Plan had not yet occurred. Accordingly, the Plan has recorded a receivable in the amount of \$1,166,006 representing the assets due from the merged plan. The transfer was completed on January 18, 2024, and the receivable was settled in full.

On December 31, 2023, CCI-Climashield, LLC assets from the ADP TotalSource Retirement Savings Plan legally merged with the Plan pursuant to a board-approved plan amendment. As of year-end, the transfer of net assets totaling \$72,176 from the ADP TotalSource Retirement Savings Plan had not yet occurred. Accordingly, the Plan has recorded a receivable in the amount of \$72,176 representing the assets due from the merged plan. The transfer was completed on January 26, 2024, and the receivable was settled in full.

On December 31, 2023, Concept 2001, Inc. 401(k) Plan legally merged with the Plan pursuant to a board-approved plan amendment. As of year-end, the transfer of net assets totaling \$1,918,469 from the Concept 2001, Inc. 401(k) Plan had not yet occurred. Accordingly, the Plan has recorded a receivable in the amount of \$1,918,469 representing the assets due from the merged plan. The transfer was completed on January 24, 2024, and the receivable was settled in full.

On December 31, 2023, CCI-ATX, LLC Savings and Profit Sharing Plan legally merged with the Plan pursuant to a board-approved plan amendment. As of year-end, the transfer of net assets totaling \$6,496,761 from the CCI-ATX, LLC Savings and Profit Sharing Plan had not yet occurred. Accordingly, the Plan has recorded a receivable in the amount of \$6,496,761 representing the assets due from the merged plan. The transfer was completed on February 1, 2024, and the receivable was settled in full.

On December 31, 2023, the JR Thompson Company 401(k) Profit Sharing Plan & Trust legally merged with the Plan pursuant to a board-approved plan amendment. As of year-end, the transfer of net assets totaling \$8,470,071 from the JR Thompson Company 401(k) Profit Sharing Plan & Trust had not yet occurred. Accordingly, the Plan has recorded a receivable in the amount of \$8,470,071 representing the assets due from the merged plan. The transfer was completed on February 9, 2024, and the receivable was settled in full.

On December 31, 2023, H&W Marketing 401(k) & Profit Sharing Plan legally merged with the Plan pursuant to a board-approved plan amendment. As of year-end, the transfer of net assets totaling \$241,408 from the H&W Marketing 401(k) & Profit Sharing Plan had not yet occurred. Accordingly, the Plan has recorded a receivable in the amount of \$241,408 representing the assets due from the merged plan. The transfer was completed on February 16, 2024, and the receivable was settled in full.

On December 31, 2023, Nova Marketing Services Retirement Savings Plan legally merged with the Plan pursuant to a board-approved plan amendment. As of year-end, the transfer of net assets totaling \$1,218,571 from the Nova Marketing Services Retirement Savings Plan had not yet occurred. Accordingly, the Plan has recorded a receivable in the amount of \$1,218,571 representing the assets due from the merged plan. The transfer was completed on February 29, 2024, and the receivable was settled in full.

#### **5. Information Certified by Trustee and Custodian**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Empower Trust Company, LLC, the current Trustee of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying Statement of Net Assets Available for Benefits and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reported in the Statement of Changes in Net Assets Available for Benefits for the period from January 3, 2024 through December 31, 2024. John Hancock Life Insurance Company (U.S.A.), the previous Custodian of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying Statement of Net Assets Available for Benefits as of December 31, 2023, and the related investment activity and interest income on notes receivable from participants reported in the Statement of Changes in Net Assets Available for Benefits for the period from January 1, 2024 through January 3, 2024.

#### **6. Related-Party and Party In Interest Transactions**

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan. These parties may include investment advisory, recordkeeping and accounting services.

**6. Related-Party and Party In Interest Transactions (Continued)**

Certain fees incurred by the Plan are paid through an expense account which receives deposits as a result of a revenue sharing agreement with Empower Trust Company, LLC. Empower Trust Company, LLC receives revenue from investment fund service providers for services Empower Trust Company, LLC provides to the funds. If the revenue received by Empower Trust Company, LLC from such investment fund service providers exceeds the amount owed for its services, Empower Trust Company, LLC remits the excess to the Plan's trust on a quarterly basis. This revenue may be used to pay qualified expenses of the Plan.

Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party in interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

**7. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

**8. Tax Status**

The Plan adopted a pre-approved plan offered by Prime Pensions Inc. The pre-approved plan received an IRS Opinion Letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the IRS Opinion Letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified, and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

**10. Delinquent Participant Contributions**

For the year ended December 31, 2024, the Company did not remit certain participant contributions to the Plan on a timely basis as defined by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Untimely remittances identified on the Schedule of Delinquent Participant Contributions, which totaled \$39,423, were not corrected in 2024. Additionally, the Company will compensate participants for lost earnings resulting from the delay in contributions.
