Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Sonny's Enterprises, LLC 401(k) Profit Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the statements or information regarding assets so held are prepared and certified to by the qualified institution, in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from the qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report:

Basis for Opinion

NOTES TO FINANCIAL STATEMENTS

Note 1 – Description of Plan

The following description of the Sonny's Enterprises, LLC 401(k) Profit Plan (the Plan), provides only general information. The Plan has since been amended and restated throughout the years to include adopting employers and to comply with certain tax legislation. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General and eligibility

The Plan was established on January 1, 2006, as a defined contribution plan. The Plan is available to eligible employees of Sonny's Enterprises, LLC, Carwash Services of the Southeast, LLC, DSM Industries, Inc., Sonny's Car Wash Services West, LLC, Sonny's Car Wash Services of Texas, LLC, Harrell's Car Wash Systems, LLC., Sonny's Car Wash Services of Florida, LLC, SLAM Marketing, LLC, Sonny's Water Systems, LLC, Sonny's Car Wash Services Northeast, LLC, PECO Wash Holdings, LLC, Sonny's Vacuum Systems, LLC, Sonny's HFI Holdings, LLC (collectively, the Sponsors or Employers). Eligible employees may enter the Plan at the beginning of each calendar quarter after completing 30 days of credited service and have reached age eighteen (18), as defined by the Plan document.

Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company and Principal Life Insurance Company (collectively, Principal) (the Custodian) serves as the Plan's Custodian, processes participant transactions, maintains participant records, holds the Plan's investment assets, executes investment transactions and provides recordkeeping services to the Plan. The Plan is administered by designated management of the Sponsors.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may voluntarily contribute up to 100% of their annual compensation, as defined in the Plan, within the limits prescribed by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined-benefit or contribution plans (rollover). Participants may make Roth 401(k) elective deferrals in accordance with the Plan's provisions.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan after meeting the Plan's service and eligibility requirements unless they affirmatively elect not to participate in the Plan. Until a change request is made, automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions are invested in a designated fund. Participants may direct the investment of their contributions into various investment options offered by the Plan.

The Plan's provisions provide for the Employers to make discretionary contributions and/or qualified non-elective contributions to the Plan. For the year ended December 31, 2024, the Sponsors made discretionary contributions equal to 50% of a participant's elective deferrals up to 5% of the participant's eligible compensation, as defined.

Contributions are subject to certain IRS limitations.

Participant accounts

Each participant's account is credited with the participant's contributions and an allocation of: (a) the Employers' contributions (if any) and (b) Plan earnings or losses thereon. Participants are charged with his or her withdrawals and administrative expenses. Allocations are based on participant earnings or losses, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options offered by the Plan.

Note 1 – Description of Plan, Continued

Vesting

Participants are immediately vested in their individual contributions plus actual earnings or losses thereon. Participants are 100% vested in their Employers' discretionary matching contribution portion of their account (if any), plus any earnings or losses thereon after one year of credited service. Vesting in Employers discretionary contributions (if any) portion of their account, plus earnings or losses thereon, is based on years of credited service in accordance with a one-year vesting requirement using a custom vesting schedule, as defined. A participant will receive credit for a year of service if the participant completes at least 1,000 hours of service during a Plan year. Regardless of years of service, participants become 100% vested upon reaching normal retirement age (65), becoming disabled, death or termination of the Plan.

Forfeitures

Forfeited nonvested accounts may be used to offset certain Plan administrative expenses or reduce the Employers' future contributions. For the year ended December 31, 2024, forfeitures utilized to offset certain Plan administrative expenses or reduce the Employers' contributions totaled \$24,384. Unallocated forfeited amounts available to be utilized in future periods at December 31, 2024 and 2023, totaled \$59,239 and \$24,433, respectively.

Payment of benefits

On termination of service due to death, disability, or normal retirement age (65), a participant with a vested account balance in excess of \$5,000 will receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum distribution within a reasonable period of time. A participant who terminates employment with a vested account balance of \$5,000 or less will receive an involuntary cash-out distribution, subject to the automatic rollover provisions as outlined in the Plan. Funds may also be accessed prior to the date they become distributable by way of a financial hardship withdrawal. Hardship withdrawals are allowable in accordance with the then current IRS guidelines. In-service distributions may not be made from Roth elective deferral accounts for hardship withdrawals.

Notes receivable from participants

Plan participants may borrow from their accounts between \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the participant's vested account balance. Loan terms range from one (1) to five (5) years unless the loan is used to acquire the principal residence of the participant. Loans are secured by the balance in a participant's account and bear a reasonable rate of interest. Principal and interest are paid ratably through regular payroll deductions and remitted to the Custodian. Any delinquent notes receivable from participants are recorded as distributions.

Plan administration

The Employers are the Plan Administrator, and, as such, controls and manages the operations of the Plan. Principal serves as the Custodian of the Plan, provides recordkeeping services to process and maintain participant records, holds the Plan's investment assets and executes investment transactions. Fees from covered service providers of the Plan are in compliance with the Department of Labor's (DOL) regulations regarding ERISA Section 408(b)(2).

Note 2 – Summary of Significant Accounting Policies

Basis of accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Note 2 – Summary of Significant Accounting Policies, Continued

Investment valuation and income recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the Plan's advisors and the Plan's Custodian.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of estimates

The preparation of financial statements in accordance with U.S. GAAP requires the Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates, and those differences could be material.

Risks and uncertainties

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate risk, market risk, and credit risk. Due to the level of risk associated with certain investment securities, including the uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in such risks in the near-term would materially affect participant account balances and the amounts reported in the financial statements.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and included as administrative expenses when incurred. Any delinquent notes receivable from participants are reclassified as distributions based on the terms of the Plan document. No allowance for credit losses has been recorded at December 31, 2024 and 2023.

Payment of benefits

The Plan records benefits when paid.

Plan expenses

The Plan has classified certain administrative expenses as an expense rather than as a reduction of investment income. Substantially all administrative expenses for maintaining the Plan are paid by the Employers and are not reflected in these financial statements. Certain expenses paid by the Plan consist of recordkeeping, custodian, and third party administrator fees. Certain participant directed transactions such as loan processing and withdrawal fees are charged directly to the participant's account.

Uncertain tax positions

U.S. GAAP requires Plan management to assess its uncertain tax positions for the likelihood they would be overturned upon examination by the IRS. In accordance with this guidance, the Plan Administrator has determined it does not have any positions at December 31, 2024, that it would be unable to substantiate.

Note 3 – Certified Investment Information

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, The Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company and Principal Life Insurance Company, qualified institutions, have certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental information is complete and accurate:

- Investments and notes receivable from participants as shown on the statements of net assets available for benefits as of December 31, 2024 and 2023;
- Net investment activity and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024; and
- Investment information included in the Schedule H, Line – 4i Schedule of Assets (held at end of year) as of December 31, 2024, as shown on the ERISA-required supplemental information.

At the request of the Plan's Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related investment information included in the financial statements, including the disclosures related to the investments to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP, and in the ERISA-required supplemental information, including assessing whether the supplemental information is in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 4 – Fair Value Measurements

Accounting guidance provides a framework for measuring fair value and establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

Level 1	Unadjusted quoted prices for identical, unrestricted assets or liabilities in active markets that a plan has the ability to access.
Level 2	Quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means for substantially the full term of the assets or liabilities.
Level 3	Significant unobservable inputs.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used at December 31, 2024 and 2023. During the year ended December 31, 2024, there were no transfers of financial instruments into or out of Level 3.

Note 4 – Fair Value Measurements, Continued

The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds – are valued at the daily quoted closing price as reported by the fund. Mutual funds held by the Plan are open-ended funds that are traded on national exchanges. These funds are required to publish their daily net asset value (NAV) and transact that price. The mutual funds are deemed to be actively traded.

Pooled separate accounts – valued at net asset value (NAV) based upon the units of such pooled separate accounts held by the Plan at year-end multiplied by the respective unit value. The unit values of the pooled separate accounts are based upon significant observable inputs but are not based upon quoted market prices in an active market and are therefore considered Level 2 investments within the fair value hierarchy.

Collective investment trusts (CITs) – valued at the NAV of units held in the CIT. The NAV, as provided by the trustee of the CITs, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments of the CITs, less their liabilities. This practical expedient is not used when it is determined to be probable that the CITs will sell for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily at NAV. There are no unfunded commitments related to these investments. These are direct filing entities.

The preceding methods described may produce a fair value calculation which may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 – Fully Benefit-Responsive Investment Contract

The Plan invests in a Guaranteed Option Account (GOA) which is a fully benefit-responsive investment contract (FBRIC) issued by Principal Life Insurance Company (PLIC or the issuer). PLIC maintains the contributions in a general account. PLIC is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The crediting interest rate is based on a formula agreed upon with PLIC but may not be less than zero. Such interest rates are reviewed on a quarterly basis for resetting. There are no reserves against contract value for credit risk of PLIC or otherwise. The Plan's ability to receive amounts due is dependent on PLIC's ability to meet its financial obligations. PLIC's ability to meet its contractual obligations may be affected by future economic and regulatory developments. The contract value of the GOA at December 31, 2024 and 2023, was \$1,467,487 and \$1,710,138, respectively.

Certain events limit the Plan's ability to transact at contract value with PLIC. Such events include the following: (a) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Sponsors or other Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Sponsors do not believe that there are any events that would limit the Plan's ability to transact at contract value with Plan participants, or the issuer are probable of occurring.

The terms of the FBRIC does not permit PLIC to terminate the agreement prior to the scheduled maturity date. Based on ongoing credit evaluations of its FBRIC, Plan management does not expect payment defaults or delinquencies and has not recorded an allowance for credit losses for these investments as of December 31, 2024 and 2023.

Note 6 – Refunds Payable for Excess Contributions

During 2024 and 2023, the Plan received contributions from participants in excess of Plan and IRS limitations totaling \$188,166 and \$181,423, respectively. Such amounts were refunded to participants in each subsequent year with a liability and corresponding reduction of contributions recorded in the year the excess contributions were received.

Note 7 – Plan Termination

Although it has not expressed any intent to do so, the Employers have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in the Employers' contribution portion of their accounts.

Note 8 – Tax Status

The Plan uses a non-standardized pre-approved profit sharing plan with CODA plan document sponsored by Principal Life Insurance Company. Principal Life Insurance Company received an opinion letter from the IRS, dated June 30, 2020, which states that the prototype document, as then designed, satisfies the applicable provisions of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS. The Plan has been amended since receiving the opinion letter, however, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

Note 8 – Tax Status, Continued

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.

Note 9 – Party-In-Interest Transactions

Parties-in-interest are defined under the Department of Labor Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Employers and certain others. Certain Plan investments are managed, administered, and/or issued by Principal and its affiliate PLIC. Principal is the Plan's Custodian and recordkeeper. Such transactions with Principal and PLIC are exempt from prohibited transaction rules under ERISA.

Certain administrative functions are performed by officers and employees of the Sponsors. No officer or employee receives compensation from the Plan for these services.

Fees incurred by the Plan for investment advisory services are included in net appreciation in fair value of investments, which were not covered by revenue sharing. The Plan also made direct payments to service providers which were not covered by revenue sharing.

Note 10 – Delinquent Participant Contributions

For the year ended December 31, 2024, the Sponsors were untimely in remitting certain participant contributions and loan repayments totaling \$2,075. Late remittances of participant contributions constitute a prohibited transaction under ERISA section 406, regardless of materiality. As of the date of this report, Plan management is working with its third-party administrator to correct these delinquent participant contributions and reimburse the Plan for lost earnings.

Note 11 – Reconciliation of Financial Statements to Form 5500

Note 12 – Subsequent Events

Effective, January 1, 2025, the Plan was amended to define a long-term, part-time employee as an employee who is not a bargaining employee or nonresident alien and works at least 500 hours of service in two consecutive specified twelve-month periods, beginning on the date of hire and eligible to participate in the Plan.

The Plan evaluated events occurring subsequent to December 31, 2024 through October 8, 2025, the date the financial statements were available to be issued, for events that should be recorded in the financial statements or disclosed in the footnotes thereto.
