No new accounting policies were adopted and the application of existing policies was not changed during 2024. We noted no

transactions entered into by the Plan during the year for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the financial statements in the proper period.

Accounting estimates are an integral part of the financial statements prepared by management and are based on management's knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected. The most sensitive estimates affecting the financial statements were:

Management's estimate of the Plan's investment valuation and income recognition is based on the estimated fair value as determined by Fidelity as more fully described in the Notes to the Plan's financial statements. We evaluated the methods, assumptions, and data used to develop the Plan's investment valuation and income recognition in determining that it is reasonable in relation to the financial statements taken as a whole.

The financial statement disclosures are neutral, consistent, and clear.

Form 5500 Procedures

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditor's report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

Difficulties Encountered in Performing the Audit

We encountered no significant difficulties in dealing with management in performing and completing our audit.

Corrected and Uncorrected Misstatements

Professional standards require us to accumulate all misstatements identified during the audit, other than those that are clearly trivial, and communicate them to the appropriate level of management. No corrected and uncorrected misstatements were detected as a result of our audit procedures.

Disagreements with Management

For purposes of this letter, a disagreement with management is a disagreement on a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditor's report. We are pleased to report that no such disagreements arose during the course of our audit.

Management Representations

We have requested certain representations from management that are included in the management representation letter dated October 13, 2025.

Management Consultations with Other Independent Accountants

In some cases, management may decide to consult with other accountants about auditing and accounting matters, similar to obtaining a “second opinion” on certain situations. If a consultation involves application of an accounting principle to the Plan’s financial statements or a determination of the type of auditor’s opinion that may be expressed on those statements, our professional standards require the consulting accountant to check with us to determine that the consultant has all the relevant facts. To our knowledge, there were no such consultations with other accountants.

Other Audit Findings or Issues

We generally discuss a variety of matters, including the application of accounting principles and auditing standards, with management each year prior to retention as the Plan’s auditors. However, these discussions occurred in the normal course of our professional relationship and our responses were not a condition to our retention.

Other Matters

1. DESCRIPTION OF THE PLAN

The following brief description of FARO Services, Inc. 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General—The Plan is a voluntary contributory plan for the employees of FARO Services, Inc. (the “Company”). The Plan became effective on November 30, 1993. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 and is administered by the Company.

Eligibility—Any employee who has completed one year of continuous service and has attained age 21 is eligible to participate in the Plan at the next enrollment date. Enrollment dates are the first date of the month following the attainment of eligibility.

Contributions—A participant may elect to make a voluntary tax-deferred contribution of their annual compensation up to the maximum permitted under Section 402(g) of the Internal Revenue Code (IRC) adjusted annually.

The Company may, at its sole discretion for each plan year, make discretionary matching contributions to the Plan. For the year ended December 31, 2024, the Company did not make a discretionary matching contribution.

Upon enrollment, a participant may direct employee and employer contributions into any of the Plan’s investment options.

Participant Accounts—Each participant’s account is credited, by fund, for the participant’s contributions and allocations of the Company’s discretionary contributions. Earnings or losses of the Plan are allocated to individual participants accounts based on the participants account balances in the appropriate fund. Participants direct their discretionary employer matching and participant contributions into any of the available investment options. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Notes Receivable from Participants—The Plan permits participants to borrow funds under limited circumstances up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are collateralized by participant investments and are repaid within five years (for the purchase of a primary residence, the repayment term may be in excess of five years) at an interest rate determined by the trustee. Principal and interest are paid ratably through payroll deductions.

Benefits Paid to Participants or Beneficiaries—On termination of service due to death, disability or retirement a participant may receive a lump-sum amount equal to the value of the participant’s vested interest in their account. Distributions may be made as soon as administratively feasible at the participant’s or beneficiary’s request.

December 31, 2024 and 2023

For terminations due to other reasons, if the benefits are less than \$1,000, the participant will automatically receive the value of their vested account balance in one lump sum payment. For benefits that are greater than \$1,000 and less than \$5,000, the participant will have the option for either a cash payment or rollover into a Fidelity IRA. For benefits that are greater than \$5,000, a participant is entitled to receive their vested account balance or may leave their vested account balance in the plan.

Vesting—Participants are immediately 100% vested in their voluntary contributions and the Company’s discretionary employer matching contribution.

Termination—Although it has not expressed any intent to do so, the Company has the right to discontinue contributions and terminate the Plan. In the event of termination, participants will become 100% vested in their accounts, and all unallocated amounts shall be allocated to the accounts of all participants.

2. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting—The accompanying financial statements have been prepared on the accrual basis of accounting.

Benefits Paid to Participants or Beneficiaries—Benefits paid to participants or beneficiaries are recorded when paid. There are no amounts payable to participants who had elected to withdraw from the Plan at December 31, 2024 and 2023. Account balances, less than \$5,000, will be disbursed automatically if the terminated participant does not elect to roll the funds into another retirement account within 30 days.

Excess Contributions Payable—Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to contributions. The Plan returned the 2024 excess contributions to the applicable participants prior to March 15, 2025.

Administrative Expenses—Certain expenses, primarily advisory fees, of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Use of Estimates—The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition—The Plan’s investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussions of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants—Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses as they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable from participants that are deemed to be in default are reduced and a benefit payment is recorded.

Forfeitures—Amounts forfeited by participants will be used first to reduce future employer contributions. Any matching employer contributions attributable to excess contributions, plus any income or loss is forfeited by those participants with excess contributions. The balance, if any, will be used to offset the employer’s plan administrative expenses. Forfeitures totaled \$0 in 2024. During 2024, \$0 from the forfeiture account was utilized to reduce 2024 employer contributions. During 2024, \$222 was utilized to offset forfeiture record keeping fees. At December 31, 2024, forfeitures in the amount of \$8,316, were available for reduction of future employer contributions.

Subsequent Events—The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued and has determined that there were no transactions or events that required disclosure through the evaluation date.

3. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money Market Fund: Valued at quoted net asset value (NAV) of shares held by the Plan at year end.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

5. FEDERAL INCOME TAX

On March 31, 2014, the IRS stated that the volume submitter plan adopted by the Plan, as then designed, qualifies under the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however there are currently no audits for any tax periods in progress.

6. RELATED-PARTY TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by Fidelity, the Plan's trustee, and affiliates of Fidelity. Therefore, these transactions qualify as party-in-interest transactions. The trustee and affiliates of Fidelity maintain and manage the mutual funds in the Plan for which they receive management fees which result in a reduction of earnings

from investments. All of these transactions are exempt from the prohibited rules of the Employee Retirement Income Security Act of 1974.

7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
