## INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee and participants of the

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the financial statements of the Converge Technology Solutions US 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements (the financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). ### 1. Description of Plan

The following description of the Converge Technology Solutions US 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document, copies of which are available from the plan administrator, for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering all employees of Converge Acquisition, LLC (the Company), who have completed one month of service and have attained the age of 18 as defined in the Plan document except for those employees who are members of a collective bargaining agreement, residents of Puerto Rico, or nonresident aliens. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was amended and restated effective April 1, 2024 to allow for In-Plan Roth rollovers and hardship withdrawals for In-Plan Roth rollover contributions originating from pre-tax 401(k) contributions. Effective January 1, 2025, the Plan was amended to allow for In-Plan Roth rollovers of matching contributions.

In April 2025, Converge Technology Solutions US was acquired by H.I.G. Capital and operates as Mainline Information Systems, DBA Peller Technologies. As a result of the acquisition, the Converge Technology Solutions US 401k plan will merge with Mainline Information Systems, LLC 401k Plan, effective January 1, 2026; however, the plan merger has not been finalized as of October 7, 2025.

#### Contributions

Each participant may make pre-tax contributions and/or after-tax Roth contributions of up to 95% of eligible compensation, as defined by the Plan document, not to exceed a maximum of \$23,000 in 2024, plus up to an additional \$7,500 for participants who have reached at least 50 years of age by the end of the Plan year. Upon satisfying the eligibility requirements, participants are automatically enrolled in the Plan at 3% of eligible compensation, unless the employee elects otherwise. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). The Company may elect to make a discretionary matching contribution. The Company elected to make a discretionary matching contribution of 25% of each participant's contribution to the Plan, up to a maximum of 6% of the participant's total eligible compensation for the year ended December 31, 2024.

#### Participant Accounts

Each participant's account is credited with the participant's contributions, rollovers, the Company's contributions, and earnings and losses on the investments in their account, and is charged with certain administrative expenses. Upon enrollment in the Plan, a participant may direct any contributions to any of the investment options offered by the Plan. Participants may

change their investment options on a daily basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Vesting**

Participants are fully vested in their contributions and rollovers plus actual earnings and losses thereon. Vesting in the Company contributions portion of their accounts is based on years of continuous service. A participant vests 33% per year and is fully vested after three years of credited service.

All amounts become fully vested upon the participant's attainment of normal retirement age, disability or death. Participants who previously participated in predecessor plans may be subject to different vesting schedules.

### **Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the vested balance of their account. A participant may have two notes outstanding at any time. The notes are secured by the balance in the participant's account and bear a reasonable rate of interest. During 2024, notes had fixed rates ranging from 4.25% to 9.50% for the term of the note, not to exceed five years unless used for the purchase of the participant's primary residence. Principal and interest are paid through payroll deductions. All notes must be repaid immediately after termination of employment.

### **Payment of Benefits**

At the time of death, disability, termination of service, or retirement, the participant or their beneficiary may elect to receive a payment of the vested interest in their account in a lump-sum distribution or series of distribution payments. The participant's contributions may also be withdrawn in certain hardship situations. In-service withdrawals of all or part of the participant's vested account, are also permitted for participants who have attained age 59½. If a participant terminates employment and has an account balance less than \$7,000, the participant will automatically receive a lump-sum payment equal to the value of their account.

### **Forfeited Accounts**

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$17,455 and \$23,487, respectively. Forfeitures may be used to pay Plan administrative expenses or to offset employer contributions. During 2024, the Company elected to use forfeitures totaling approximately \$33,701 to pay the discretionary matching contribution.

### Administrative Expenses

The Plan document permits certain administrative expenses to be paid by the Plan. Expenses for transactions which are specifically attributable to a participant's account are charged directly to the participant's account. These expenses are paid to service providers of the Plan and therefore qualify as party-in-interest transactions. All other expenses are paid by the Company, and the Company does not expect reimbursement from the Plan for these expenses.

## 2. Summary of Significant Accounting Policies

### Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting.

### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

### Contributions

Participant contributions are considered payable to the Plan when withheld from the participant's paycheck. Company discretionary matching contributions are considered payable to the Plan when approved by the Company. Any unfunded participant or Company discretionary contributions are included in participant or employer contributions receivable on the statements of net assets available for benefits as of December 31, 2024 and 2023.

In accordance with the Financial Accounting Standards Board's (FASB) Accounting Standards Codification 326, *Financial Instruments - Credit Losses*, the Company estimates the current credit risk associated with employer contribution receivables. The Company determined that no allowance for credit losses is necessary as of December 31, 2024 and 2023.

### Valuation of Investments and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Net change in fair value of investments includes interest, dividends, and realized and unrealized gains and losses on those investments. Interest is recorded when received.

### Notes Receivable from Participants

Notes receivable from participants are carried at their outstanding balance. Interest income is recognized when received. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make note repayments and the plan administrator deems the participant note to be in default, the participant note balance is reduced and a benefit payment is recorded. Notes receivable from participants also qualify as party-in-interest transactions.

### Payment of Benefits

Benefits are recorded when paid.

### Subsequent Events

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through October 7, 2025, which is the date the financial statements were available to be issued.

### 3. Information Certified by the Qualified Institution

All investment information in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants as of December 31, 2024 and 2023, and the net change in fair value of investments and interest income for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by T. Rowe Price Trust Company (T. Rowe Price), the Plan's qualified institution.

### 4. Investments

Certain Plan investments include mutual funds, common/collective trust funds, and a stable value fund that are managed by T. Rowe Price. Accordingly, transactions in these investments qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net change in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment.

Investments are exposed to various risks, such as market, currency, interest rate and credit risks. Market risks include U.S. and global events which could impact the value of Plan investments. Such events would include a healthcare crisis, such as a pandemic, international conflicts, supply chain disruptions, global monetary policy decisions, significant exogenous economic influences, significant cyber security attack, or other similar events. It is at least reasonably possible that changes in their fair value will occur in the near term and that such changes could materially affect participants' account balances.

The Financial Accounting Standards Board established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into three levels. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities, and the lowest priority to unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 – unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access

Level 2 – other observable data, including quoted prices for identical assets or liabilities in inactive markets

Level 3 – unobservable inputs

Observable inputs are those based on market data obtained from sources independent of the Plan, and unobservable inputs reflect the Plan's own assumptions based on the best information available. The input levels are not necessarily an indication of the risk or liquidity associated with financial instruments at that level but rather the degree of judgment used in determining those values.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Investments in mutual funds are stated at quoted market prices for the identical security in an active market (Level 1).

The Plan invests in a stable value fund held in a common/collective trust. The stable value fund invests in fully benefit-responsive guaranteed investment contracts (GICs), which are general obligations of the insurance companies that issue the contracts, as well as synthetic GICs. The stable value fund trades at the net asset value (NAV), which is based on the contract value of the underlying investments (Level 1). Participants transact at NAV daily in an active market. The stable value fund includes certain redemption restrictions. If the Plan chooses to redeem all or a significant portion of the stable value fund, the issuer may require a 12-month wait period to redeem.

Fair value of the common/collective trust funds is determined by prices published daily by the trust manager, which is the NAV of the common/collective trust fund (Level 1). Net asset value is determined by the fair value of the mutual funds, stocks, and other securities in the common/collective trust funds. Participants can trade the common/collective trust funds daily at the published NAV.

Investments in the self-directed brokerage accounts include mutual funds, money market funds, and common stock. All assets are traded through a broker and are considered Level 1 assets.

### 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their Company contributions.

### 6. Income Tax Status

The Plan uses a prototype plan document prepared by T. Rowe Price Retirement Plan Services, Inc. (TRPRPS), an affiliate of T. Rowe Price. The Internal Revenue Service has provided an opinion letter dated August 19, 2020, stating that the prototype plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has not obtained an individual determination letter and has been amended since TRPRPS has received the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. The Plan's income tax returns for the past three years are subject to examination by taxing authorities and may change upon examination.
