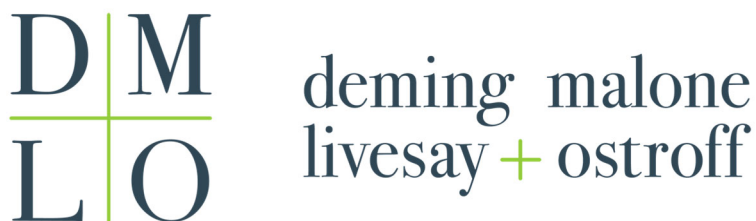

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Abound Federal Credit Union Defined Benefit Pension Plan and Trust (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Abound Federal Credit Union Defined Benefit Pension Plan and Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. - the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Abound Federal Credit Union Defined Benefit Pension Plan and Trust and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Abound Federal Credit Union Defined Benefit Pension Plan and Trust's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditors' Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Abound Federal Credit Union Defined Benefit Pension Plan and Trust's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Supplemental Schedules Required by ERISA**

The supplemental schedules of Schedule of Assets (Held at End of Year) and Schedule of Reportable Transactions as of or for the year ending December 31, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- the form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**NOTES TO FINANCIAL STATEMENTS**

**Note 1. Description of Plan**

The Abound Federal Credit Union Defined Benefit Pension Plan and Trust sponsor, Abound Federal Credit Union (Employer), is a cooperative association organized in accordance with the provisions of the Federal Credit Union Act for the purpose of promoting thrift among, and creating a source of credit for, its members. The credit union's members consist of current and former military, civil service and retired employees, and local educational, medical, manufacturing and government employees and their families.

The following description of the Plan provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions and definitions of terms.

**General:**

The Plan is a defined benefit plan providing retirement, disability, and death benefits to all eligible employees and was established effective January 1, 1975. The Plan includes all employees of the Employer who are 20 years of age or older and have worked at least 1,000 hours in the calendar year. Employees become participants in the Plan on the first day of the plan year coincident with, or next following, attainment of the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The Plan is administered by the plan trustees. The plan trustees have overall responsibility for the operation and administration of the Plan. The plan trustees determine the appropriateness of the Plan's investment offerings, monitor investment performance, and report to the Employer's Board of Directors.

**Funding policy:**

The Employer will contribute an amount which will meet or exceed the annual ERISA minimum funding requirement as determined by the plan actuary. During 2024, the Employer made a contribution of \$7,000,000 to the Plan, which exceeded the minimum funding requirement of ERISA. During 2023, the Employer did not make and was not required to make a contribution to the Plan, which met the minimum funding requirement of ERISA.

Although it has not expressed any intention to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA.

## NOTES TO FINANCIAL STATEMENTS

### **Pension benefits:**

Plan participants are eligible for benefits after terminating employment with vested rights. Participants become vested in the Plan upon completion of 5 or more years of service or upon attainment of early retirement age, at death, or if the participant becomes totally and permanently disabled. If employees terminate before becoming vested, they forfeit the right to receive the portion of their accumulated benefits attributed to the Employer's contributions.

Employees with 5 or more years of vested service are entitled to a monthly pension benefit at normal retirement age (65) equal to 1.85% of their final 5-year average annual compensation for each year of service to a maximum of 83% of their final 5-year average annual compensation for individuals participating in the Plan as of December 31, 1997 and a maximum of 55% for participants entering the Plan on or after January 1, 1998. The Plan permits early retirement at ages 55-64, with other special early retirement provisions for employees hired prior to January 1, 1980. Upon termination of employment, participants taking early retirement will have their vested accrued benefit reduced based on the number of months that their early retirement date precedes their normal retirement. Participants may elect to receive the value of their accumulated plan benefits as a one-time lump-sum distribution, or they may elect to receive their benefits as a monthly annuity payable for their lifetime. No distribution may be made until a participant has reached their early or normal retirement age.

### **Death and disability benefits:**

If a participant dies and is married at the time of their death, a death benefit equal to the actuarial equivalent of the amount that would have been paid to the spouse had the participant begun receiving distributions under a joint and 50% survivor annuity will be paid to their spouse. If a participant is married at the time of their death, their spouse signed a waiver of beneficiary rights, and other beneficiaries are named, benefits may be paid to those beneficiaries. If a participant is not married at the time of their death, benefits may be paid to those named beneficiaries equal to a minimum spouse benefit. Participants that become totally disabled are entitled to disability benefits equal to the early retirement benefits that have accumulated as of the date that they become disabled without regard to age and service requirements, and disability benefits are payable on the date that participant would have been eligible for early retirement.

### **Note 2. Summary of Significant Accounting Policies**

This summary of significant accounting policies of the Plan is presented to assist in understanding the Plan's financial statements. The financial statements and notes are representations of the Plan's management who is responsible for the integrity and objectivity of the financial statements. These accounting policies conform to accounting principles generally accepted in the United States of America and have been consistently applied in the preparation of the financial statements.

## NOTES TO FINANCIAL STATEMENTS

### **Basis of accounting:**

The accompanying financial statements are prepared on the accrual basis of accounting.

### **Use of estimates:**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, disclosure of contingent assets and liabilities, and the actuarial present value of accumulated plan benefits at the date of the financial statements; and changes therein. Actual results may differ from those estimates.

### **Investment valuation and income recognition:**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Pension and Benefits Committee determines the Plan's valuation policies utilizing information provided by its investment advisers, the custodian, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Payment of benefits:**

Benefit payments to participants are recorded upon distribution.

### **Administrative expenses:**

The Plan's expenses are paid either by the Plan or the Employer, as provided by the plan document. Expenses that are paid directly by the Employer are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation in fair value of investments presented in the accompanying statements of changes in net assets available for benefits.

### **Subsequent events:**

Subsequent events have been evaluated through September 29, 2025, which is the date the financial statements were available to be issued.

## NOTES TO FINANCIAL STATEMENTS

### Note 3. Certified Investments

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedules, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Matrix Trust Company and CMFG Life Insurance Company, qualified institutions.

### Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Deposit Administration Group Annuity Contract – The fair value is equivalent to contract value because the discount rate equals the current interest rate. Contract value represents contributions made, plus interest at the contract rate (2.05% for 2024 and 2023), less benefits paid to participants and administrative expenses charged by CMFG Life Insurance Company. In the event of termination of the Deposit Administration Group Annuity Contract with CMFG Life Insurance Company, the amounts withdrawn are subject to certain fees. At December 31, 2024 and 2023, there were no restrictions on the contract.

## NOTES TO FINANCIAL STATEMENTS

Mutual Funds – valued at the daily closing price as reported by the fund.

Collective Funds – valued daily based upon the collective value of the underlying securities held in the fund.

#### Note 5. Actuarial Present Value of Accumulated Plan Benefits

Accumulated plan benefits are those future periodic payments, including lump-sum distributions that are attributable under the Plan's provisions to the service participants have rendered. Accumulated plan benefits include benefits expected to be paid to:

- a. Retired or terminated employees or their beneficiaries,
- b. Beneficiaries of employees who have died, and
- c. Present employees or their beneficiaries.

Benefits under the Plan are accumulated based on employees' compensation during each year of credited service. The accumulated plan benefits for active employees will equal the accumulation, with interest, of the annual benefit accruals as of the benefit information date.

Benefits payable under all circumstances – retirement, death, disability, and termination of employment – are included, to the extent that they are deemed attributable to participant service rendered to the valuation date. Benefits to be provided via annuity contracts excluded from plan assets are excluded from accumulated plan benefits.

## NOTES TO FINANCIAL STATEMENTS

The actuarial present value of accumulated plan benefits is determined by an independent actuary and is that amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal or retirement) between the valuation date and the expected date of payment.

The aggregate method is used to determine plan funding costs.

The interest rate used to discount the obligation for 2024 and 2023 was 6.50%.

The foregoing actuarial assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of accumulated plan benefits. The computations of the actuarial present value of accumulated plan benefits were made as of January 1, 2025 and 2024. Had the valuations been performed as of December 31, 2024 and 2023, there would be no material differences.

### Note 6. Income Tax Status

The Plan operates under a standardized volume submitter plan designed to be in compliance with the applicable requirements of the Internal Revenue Code (IRC). The volume submitter plan has received an opinion letter from the Internal Revenue Service (IRS) dated February 28, 2023, in which the IRS stated the Plan, as then designed was in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for the tax periods in progress.

## NOTES TO FINANCIAL STATEMENTS

### Note 7. Plan Termination

In the event the Plan terminates, the net assets of the Plan will be allocated, as prescribed by ERISA and its related regulations, generally to provide the following benefits in the order indicated:

- a. Benefits attributable to employee contributions, taking into account those paid out before termination.
- b. Annuity benefits that former employees or their beneficiaries have been receiving for at least three years or that employees eligible to retire for that three-year period would have been receiving if they had retired with benefits in the normal form of annuity under the Plan. The priority amount is limited to the lowest benefit that was payable (or would have been payable) during those three years. The amount is further limited to the lowest benefit that would be payable under plan provisions in effect at any time during the five years preceding plan termination.
- c. Other vested benefits insured by the Pension Benefit Guaranty Corporation (PBGC) (a U.S. government agency) up to the applicable limitations.
- d. All other vested benefits (that is, vested benefits not insured by the PBGC).
- e. All non-vested benefits.

Certain benefits under the Plan are insured by the PBGC if the Plan terminates. Generally, the PBGC guarantees most vested normal age retirement benefits, early retirement benefits, and certain disability and survivor's pensions. However, the PBGC does not guarantee all types of benefits under the Plan, and the amount of benefit protection is subject to certain limitations. Vested benefits under the Plan are guaranteed at the level in effect on the date of the Plan's termination.

Whether all participants receive their benefits should the Plan terminate at some future time will depend on the sufficiency, at that time, of the Plan's net assets to provide for accumulated benefit obligations and may also depend on the financial condition of the Plan's sponsor and the level of benefits guaranteed by the PBGC.

### Note 8. Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in value of investment securities will occur in the near term and those changes could materially affect the amount reported in the statements of net assets available for benefits.

Plan contributions are made, and the actuarial present value of accumulated plan benefits are reported, based on certain assumptions pertaining to interest rate, inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

### **Note 9. Related Party and Party in Interest Transactions**

MEMBERS Capital Advisors, Inc. (MCA) is an investment management service company wholly owned by Trustage, who is the actuary of the Plan. MCA provides certain investment management services to the Plan, and therefore transactions with MCA qualify as party-in-interest transactions. Fees paid by the Plan for these services amounted to \$33,099 and \$29,369, for the years ended December 31, 2024 and 2023, respectively, and are recorded as administrative fees on the statements of changes in net assets available for benefits.

CMFG Life Insurance Company (CMFG) is the insurance company of the Plan, and therefore transactions with CMFG qualify as party-in-interest transactions. Fees paid by the Plan to CMFG amounted to \$49,649 and \$44,053 for the years ended December 31, 2024 and 2023, respectively, and are recorded as administrative fees on the statements of changes in net assets available for benefits.

Fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. If the revenue received from the investments exceeds the amount owed to the service provider, the excess is remitted to the Plan's trust and is included in other income. During the years ended December 31, 2024 and 2023, the excess amounts amounted to \$10,522 and \$13,895, respectively.
