Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Alcon Industries, Inc. & Affiliated Companies Incentive Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statement section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Basis for Opinion

NOTES TO FINANCIAL STATEMENTS

Note 1. Description of Plan

The following is a summary of certain provisions of the Alcon Industries, Inc. & Affiliated Companies Incentive Savings Plan (the "Plan"). Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan established as of January 1, 1986 covering all eligible employees of Alcon Industries, Inc. (the "Company"). Employees become eligible to participate in the Plan and receive employer contributions provided that they are at least 21 years of age and have completed 60 days of service. The employee enters the Plan on the first day of the month following or coincident with the date he or she has satisfied the conditions of eligibility. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. The Plan is sponsored and administered by the Company.

Contributions – Plan participants may make pre-tax or Roth contributions up to 100% of their eligible compensation as defined in the Plan, subject to certain limits imposed by the Internal Revenue Service ("IRS"). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Plan also provides that participants who are projected to be age 50 or older by the end of the calendar year and who are making deferral contributions to the Plan may also make catch-up contributions, subject to certain IRS limitations. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in accordance with the Plan's investment policies. All contributions are participant-directed.

Effective January 1, 2024, the Plan was amended to require an employer safe harbor non-elective contribution of not less than 3% of a participant's eligible compensation. The Company may also make a discretionary employer matching contribution, which was 50% of a participant's contributions up to 2% of a participant's eligible compensation for 2024. The Company may also make discretionary non-elective contributions to the Plan, although no such contributions were made for 2024.

Participant Accounts – Each participant's account is credited with the participant's contribution, any Company contribution, and an allocation of Plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable From Participants – Participants are permitted to borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates determined by the plan administrator. Principal and interest is paid ratably through payroll deductions.

Note 1. Description of Plan (Continued)

Vesting – Participants are immediately vested in their contributions, employer safe harbor non-elective contributions, and employer qualified non-elective contributions plus actual earnings thereon. The Company's discretionary employer matching contributions and other employer non-elective contributions become vested in accordance with the following schedule:

1 year	20%
2 years	40%
3 years	60%
4 years	80%
5 or more years	100%

A participant is 100% vested in the event of attaining normal retirement age as defined by the Plan, in the event of death or disability, or attaining early retirement age as defined by the Plan.

Payment of Benefits – Upon termination of employment, retirement, or death, a participant may elect to receive a lump sum or installments equal to the value of the participant's vested interest in his or her account. The Plan also provides for in-service distributions upon attaining age 59½ and hardship withdrawals, subject to certain limitations.

Forfeited Accounts – Any forfeited non-vested accounts may be used to reduce future employer contributions or to pay Plan expenses. Forfeited non-vested accounts totaled \$8,077 and \$7,523 at December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, \$6,650 of forfeitures was used to pay Plan expenses.

Termination Provisions – Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting – The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Investment Valuation and Income Recognition – Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by Empower Annuity Insurance Company of America ("Empower") and Empower Trust Company, LLC, the Custodians of the Plan. See Note 4 for a discussion of fair value measurements.

Investment Valuation and Income Recognition (Continued)

Purchases and sales of securities are recorded on a settlement-date basis. Interest and dividend income are recorded when received. There is no significant difference between this methodology and the accrual basis of accounting for the periods presented. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon terms of the plan document.

Payment of Benefits – Benefits are recorded when paid.

Use of Estimates – The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Administrative Expenses – Fees of the Plan are paid by the Company or the Plan at the discretion of the Company, or are offset with revenue sharing payments made to the Plan by investment fund managers. In addition, certain transaction and account maintenance fees are charged to the affected participants. Expenses offset with revenue sharing payments totaled \$11,362 for the year ended December 31, 2024, which is recorded on a net basis with administrative expenses.

Subsequent Events – The Plan has evaluated subsequent events through October 13, 2025, the date on which the financial statements were available to be issued.

Note 3. Unaudited Information

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, management received certifications from Empower Annuity Insurance Company of America and Empower Trust Company, LLC acknowledging the completeness and accuracy of all investments and notes receivable from participants reflected in the statements of net assets available for benefits at December 31, 2024 and 2023, the supplemental schedule of assets (held at end of year) at December 31, 2024, the related investment and loan interest activity reflected in the statement of changes in net assets available for benefits for the year ended December 2024, and the investment related information in the accompanying notes to the financial statements. This information is unaudited by independent accountants.

Note 4. Fair Value Measurements

The Plan estimates the fair value of financial instruments using available market information and other generally accepted valuation methodologies. The inputs used to measure fair value are classified into three levels:

- Level 1 – Quoted market prices in active markets for identical assets and liabilities
- Level 2 – Observable market-based inputs or unobservable inputs that are corroborated by market data
- Level 3 – Unobservable inputs in which little or no market data exists

The following is a description of the valuation methodologies used for plan assets measured at fair value:

- The fair value of the money market fund and mutual funds is determined based on their quoted closing market prices in active markets for identical investments, and is classified as Level 1.
- The fair value of investments in the collective trust funds and pooled separate account is based on their reported net asset value ("NAV"). The NAV is based primarily on observable inputs and the market value of the underlying investments, and is classified as Level 2.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. There have been no changes in the methodologies used from 2023 to 2024. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Group Annuity Contract

The Plan holds an investment contract which meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan.

Investments in the EI Fixed Account - Series Class I are reported at contract value as determined by Empower, which represents contributions plus interest at a specified rate, less participant withdrawals and fees. Empower maintains the investments in a general account. All transactions within this contract are executed at contract value including full liquidation of the account. Empower is contractually obligated to repay the principal and a specified rate that is guaranteed to the Plan. Empower has indicated that the guaranteed interest rates are reset quarterly.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on several factors, including the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, and prevailing market conditions. The average yield earned by the Plan during 2024 was 1.44%.

The EI Fixed Account - Series Class I does not permit the insurance company to terminate the agreement prior to the scheduled maturity date. Certain events may limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

Note 6. Income Tax Status

The Plan has adopted a pre-approved plan document. This plan document has obtained an opinion letter dated June 30, 2020 from the IRS in which the IRS stated that the document, as then designed, was in compliance with applicable requirements of the Internal Revenue Code ("IRC"). Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes that the Plan is designed and is currently being operated in compliance with applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

The Plan's management has analyzed tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require such recognition or disclosure in the financial statements.

Note 7. Party-in-Interest Transactions

Certain Plan investments are held in a pooled separate account and a group annuity contract of Empower. In addition, administrative expenses were paid to the Custodians or their affiliates during the year ended December 31, 2024. These transactions qualify as party-in-interest transactions.

Note 8. Risks and Uncertainties

The Plan holds various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
