## **INDEPENDENT AUDITOR'S REPORT**

To the Trustee of the

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the Screen Engine/ASI LLC 401(k) Profit Sharing Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

**NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of the Screen Engine/ASI LLC 401(k) Profit Sharing Plan and Trust (the Plan) provides only general information. The Plan name was changed in 2017 due to a change in ownership at the Plan sponsor. There was no change to the terms of the Plan. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**(a) GENERAL**

The Plan is a defined contribution 401(k) plan which covers all full-time employees of Screen Engine/ASI LLC (the Company), who have attained 21 years of age and have completed at least 2 months of service by the next Plan entry date. The Plan is subject to ERISA. The Plan became effective on January 1, 2010, and was amended on October 10, 2022 to implement certain provisions of the Bipartisan Budget Act of 2018.

**(b) CONTRIBUTIONS**

Per the stipulations outlined in the Plan Adoption Agreement, the Company does not make any matching contributions. A participant may elect to make pre-tax contributions up to 90% of annual compensation and post-tax Roth 401(k) contributions up to a maximum combined amount of \$23,000. Participants who have attained the age of 50 by the Plan year end may also make catch-up contributions up to a maximum of \$7,500 during the year ended December 31, 2024. The Company will make Safe Harbor Matching Contributions to participants equal to 100% of the first 3% of eligible earnings that the participant has elected to defer, and an additional matching contribution of 50% of the next 2% of eligible earnings deferred. In addition, the Company may elect to make contributions at year-end on a discretionary basis on behalf of all eligible employees. The Company made a safe harbor matching contribution to the Plan for the year ended December 31, 2024 of \$509,011.

**(c) PARTICIPANT ACCOUNTS**

Each participant's account is credited with the participant's contribution, an allocation of the Company's discretionary contribution and Plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance. Forfeitures of terminated participants' non-vested accounts are used to reduce employer contributions for the Plan year. During the year ended December 31, 2024, the Company did not utilize any forfeitures to reduce employer contributions. As of December 31, 2024 and 2023, there was \$13,008 and \$12,731 of available forfeitures, respectively.

**(d) VESTING**

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the remainder of their account increases by 20% after completion of two years of continuous service. A participant is 100% vested after six years of continuous service.

**(e) NOTES RECEIVABLE FROM PARTICIPANTS**

Participants may borrow up to 50% of their vested account balance subject to a minimum loan amount of \$500 and a maximum loan amount of \$50,000. Notes receivable from participants bear interest at the prime rate, as determined in the Wall Street Journal on the day of the loan request, plus 2.00%. The prime rate was 7.50% at December 31, 2024. The notes receivable are secured by the participants' vested interest in the Plan. Notes receivable from participants must be paid back within five years unless the notes are for the purchase of a principal residence. At December 31, 2024, interest rates on notes receivable are 5.25% to 10.50%. Principal and interest are paid through payroll deductions.

**(f) PAYMENT OF BENEFITS**

On termination of service, a participant may elect to receive a single lump-sum payment of the value of his or her account, equal installments or an annuity for a period not exceeding life expectancy. Benefits are recorded when paid. There were no benefit claims for participants separated from service that have not yet been paid as of December 31, 2024.

**(g) ADMINISTRATIVE EXPENSES**

The Company incurs certain expenses in administering the Plan, which are not passed on as expenses of the Plan. Transaction charges are paid by the participants.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**(a) BASIS OF ACCOUNTING**

The financial statements of the Plan are prepared under the accrual method of accounting.

**(b) USE OF ESTIMATES**

The preparation of financial statements in accordance with generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions. Those estimates and assumptions affect the reported amounts of assets and liabilities, and the reported revenues and expenses during the reporting period. Although the Plan Administrator believes its estimates are appropriate, changes in assumptions utilized in preparing such estimates could cause these estimates to change sometime in the future.

**(c) RISKS AND UNCERTAINTIES**

The Plan utilizes various investment instruments, including mutual funds and collective investment trusts. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect amounts reported in the financial statements.

**(d) VALUATION OF INVESTMENTS AND INCOME RECOGNITION**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**(e) NOTES RECEIVABLE FROM PARTICIPANTS**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and expensed when they are incurred. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

**(f) SUBSEQUENT EVENTS**

The Plan has evaluated events and transactions occurring subsequent to the statement of net assets available for benefits date of December 31, 2024, for items that should potentially be recognized or disclosed in these financial statements. The evaluation was conducted through October 7, 2025, the date these financial statements were available to be issued. No such material events or transactions were noted to have occurred.

**NOTE 3 - INVESTMENTS**

The Plan's funds were maintained by Reliance Trust Company (Reliance Trust), the custodian of the Plan. The funds are credited with contributions and actual earnings on the underlying investments are charged for Plan withdrawals. The Plan's funds in the financial statements as of December 31, 2024 and 2023 are the values as reported to the Plan by Reliance Trust.

The following was certified as to being complete and accurate by Reliance Trust:

- Investments and Notes Receivable from Participants as shown in the statement of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, dividends, interest on notes receivable from participants and transfers into plan as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Supplementary schedule of assets (held at end of year).

The Plan's independent auditors did not perform any auditing procedures with respect to this information, except for comparing such information to the related information included in the statements of net assets available for benefits and statement of changes in net assets available for benefits and the supplementary schedule of assets (held at end of year).

Participants may change their investment options at their discretion.

**NOTE 4 - FAIR VALUE MEASUREMENT**

The Plan adopted the fair value accounting standard for those assets that are re-measured and reported at fair value at each reporting period. This standard establishes a single authoritative definition of fair value, sets out a framework for measuring fair value based on inputs used, and requires additional disclosures about fair value measurements. This standard applies to fair value measurements already required or permitted by existing standards.

The three levels of the fair value hierarchy under the standard are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The NAV is based on the value of the underlying assets owned by the fund, less its liabilities, and then divided by the number of shares outstanding. There are no redemption restrictions or unfunded commitments. The investment strategy is to mirror the performance of mutual funds of the same name.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 - TAX STATUS**

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated October 6, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with applicable requirements of the IRC, and therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 6 - EXEMPT PARTY-IN-INTEREST TRANSACTIONS**

Certain investment instruments may be managed by Reliance Trust. Reliance Trust is a custodian as defined by the Plan; therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund.

**NOTE 7 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon Plan Termination, participants become 100% vested in employer contributions, if any.

In the event the Plan is terminated, the assets will be allocated to each participant in the proportion each account balance bears to the total of all account balances.
