Independent Auditor's Report

To the Trustees of
Mackin & Son Automotive, Inc. Profit Sharing Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Mackin & Son Automotive, Inc. NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Mackin & Son Automotive, Inc. Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all non-union employees of Mackin & Son Automotive, Inc. Profit Sharing Plan who have at least 90 days of service and have reached the age of eighteen. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute up to 90% of their annual compensation subject to IRS limitations, as defined by the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Catch-up contributions are permitted for eligible participants age 50 or older by the end of the calendar year.

The Company makes Employer Matching Contributions up to 25% of salary deferrals, not exceeding 4% of compensation for such period..

The Company may also make discretionary profit sharing contributions on behalf of the participants. Participants are eligible for profit sharing when they have attained the age of 18 and completed 1 year of service, as defined. There were no discretionary profit sharing contributions for plan years ended December 31, 2024 and 2023.

Vesting

Participants are fully vested immediately in their contributions, plus actual earnings thereon. Employer's matching contributions and profit sharing contributions are subject to a six year vesting schedule (0%, 20%, 40%, 60%, 80%, 100%)

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the plan earnings (losses). Participant's accounts may be charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant account balances or equal dollar amount based on the number of participants in the Plan, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTE 1 - DESCRIPTION OF THE PLAN (CONTINUED)

Notes Receivable from Participants

Participants may borrow from their account balances a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined monthly, is set at 1 percent above the prime rate, as defined in the Plan Document. Loans must be repaid within five (5) years unless the proceeds are used to acquire a principal residence, in which case the plan administrator may permit a longer repayment period. A participant may only have one (1) loans outstanding at any time. Principal and interest is paid ratably through payroll deductions.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Fees related to the administration of notes receivable from participants are charged directly to the participant's account. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant may receive benefit payments in the form of a lump-sum equal to the vested value of his or her account, or in installments over a period of not more than the participant's assumed life expectancy. Any participant who terminates from the Plan with a vested balance less than \$5,000 will receive a distribution of their vested balance automatically within a reasonable time after employment is terminated. Participants are also permitted to make hardship withdrawals if certain criteria, as defined in the Plan Document, are met.

Benefits are recorded when paid. As of December 31, 2024, there were no pending distribution requests.

Forfeitures

The non-vested portion of participant account balances are forfeited during the Plan year in which the participant is no longer an employee and has received their vested benefit. Forfeitures may be used to pay Plan expenses or to reduce the amounts otherwise to be contributed to the Plan.

During the years ended December 31, 2024 and 2023, there was \$9,220 and \$3,820, respectively, of monies of non-vested account balances, used towards employer contributions. At December 31, 2024 and 2023, forfeited non-vested accounts available to offset future employer contributions or plan expenses totaled \$1,767 and \$256, respectively.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA. In the event of plan termination, no further contributions will be made to the Plan and all amounts credited to participant accounts will become 100% vested.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual amounts could differ from these estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company's management determines the Plan's valuation policies utilizing information provided by the trustee.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Fair Value Measurements

Financial assets and liabilities valued using Level 1 inputs are based on unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 unobservable inputs have the lowest priority. Level 2 inputs are based on quoted market prices for substantially similar assets in active markets. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. There are no Level 2 or 3 investments in the Plan.

Tax Status

The plan sponsor adopted a prototype document which obtained an opinion letter dated October 6, 2020, in which the Internal Revenue Service stated that the form of the Plan was in compliance with the applicable requirements of the Internal Revenue Code (Code). Although the Plan has been amended since adoption of the prototype document receiving the opinion letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Code and, therefore, the Plan is qualified, and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan's information return filings are subject to audit by the Internal Revenue Service and the Department of Labor. The years ending before December 31, 2022 are no longer subject to audit.

Plan Administrative Expenses

Certain expenses specifically incurred by, or attributable to a particular participant, may be paid directly by this participant's account. Other expenses related to the administration of the Plan not specifically incurred by, or attributable to a particular participant, may be paid from the Plan's assets and allocated to participant accounts. All other administrative expenses of the Plan are paid by the Company. The Plan's administrative expenses paid by the Company for the years ended December 31, 2024 and 2023, were approximately, \$14,000 and \$15,000, respectively.

Related Party and Party in Interest Transactions

Reliance Trust Company is the trustee of the Plan. ADP is a subservicer to the trustee and provides recordkeeping services to the Plan. Fees incurred by the Plan for the investment management services are included in administrative expenses. The Company pays directly any other fees related to the Plan's operations, as disclosed.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

Subsequent Events

The plan evaluated events through the date that the financial statements were available to be issued. The Plan is not aware of any significant events that occurred subsequent to the statement of net assets available for benefits date, but prior to October 9, 2025, that would have a material impact on the financial statements.
