Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Apex Logistics International 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Apex Logistics International 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section -

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Apex Logistics International 401(k) Profit Sharing Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Note 1 - Description of Plan

The following description of Apex Logistics International 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan documents for a more complete description of the Plan’s provisions.

General

The Plan is a 401(k) plan covering all employees of Apex Logistics International and its affiliates (the “Company”). There is no age requirements to participate in the Plan. Employees who are covered by a collective bargaining agreement are excluded from employer non-elective contributions, employer matching contributions and employee elective deferrals. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees is responsible for the oversight of the Plan, determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

Contributions

For 2024, participants could contribute 100% of pre-tax annual compensation, as defined in the Plan, up to \$23,000. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions up to \$7,500. Participants may also contribute funds from another qualified retirement plan or qualified individual retirement account (“rollover contributions”), subject to certain requirements. Participants direct the investment of their contributions into various investment options offered by the Plan.

In addition, the Company may make a profit sharing and matching contribution at their discretion. To be eligible to receive a profit-sharing contribution, the participant must complete 1,000 hours of service during the Plan year and be employed on the last day of the Plan year. The matching contribution is allocated proportionately to the amount of the participant salary deferral and the profit-sharing contribution is allocated based on a percentage of compensation. For 2024, the Company made contributions totaling \$1,111,146 consisting of \$305,581 matching contributions and \$805,565 safe harbor matching contributions.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and an allocation of Plan earnings (losses) and charged with an allocation of administrative expenses. Allocations are based on participant’s earnings or account balances, as defined. Forfeited balances of terminated participant’s non-vested accounts are used to reduce Company’s future contributions. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in prevailing wage, safe harbor, and their own contributions plus actual earnings thereon. Vesting in the Company’s matching and non-elective contributions portion of their accounts plus actual earnings thereon is determined under the following schedule:

A participant is also 100% vested under any of the following conditions:

- Death before retirement date;
- Disability before retirement date

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 9.5%, which are commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through semi-monthly payroll deductions. Loans must be repaid within 5 years unless the loan is used to purchase the participant's primary residence.

Payment of Benefits

On termination of service due to death, disability or retirement, or any other reason, a participant or his or her beneficiaries may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or rolled over to another qualified retirement plan or to an individual retirement account. In-service withdrawals or hardship withdrawals are permitted by the Plan.

Forfeitures

As of December 31, 2024 and 2023, forfeited nonvested accounts held totaled \$128,374 and \$71,241, respectively. These accounts will be used to reduce future employer contributions or pay administrative expenses of the Plan. In 2024, there were no employer contributions used to reduce employer contributions or pay administrative expenses.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared under the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The Plan's net appreciation in the fair value of its investments consists of realized gains and losses and unrealized appreciation and depreciation on investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees charged directly to the borrowing participant's account are included in administrative expenses when incurred. As of December 31, 2024, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Payments of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Company pays administrative expenses associated with the management of and professional services for the Plan. Certain administrative fees, including fees for hardship withdrawals, are paid by the participants.

Subsequent Events

In April 2025, the Plan transferred all assets and liabilities to the Principal Life Insurance Company.

The Plan's management has evaluated subsequent events through October 7, 2025, the date the financial statements were available to be issued.

Note 3 – Information Prepared and Certified by Capital Bank and Trust Company, LLC

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on note receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Capital Bank and Trust Company, LLC (the trustee of the Plan).

Note 4 – Fair Value Measurements

FASB ASC Topic 820, Fair Value Measurements, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in markets that are not active;
- Inputs other than quoted prices that are observable for the asset or liability and;

- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

Money Market Fund and Mutual Funds

Investments in a money market fund and mutual funds are valued based at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. The fair values of receivables approximate their carrying values.

Note 5 – Party-In-Interest Transactions

The Plan issues loans to participants, which are secured by the balances in participants’ accounts. These transactions qualify as party-in-interest transactions.

Additionally, fees paid to the trustee for other administrative expenses, management services, and bookkeeping services qualify as party-in interest transactions.

Note 6 – Termination of Plan

Although it has not expressed any interest to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provision of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 7 – Tax Status

The IRS has determined and informed the Company by a letter dated August 31, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan’s tax counsel believe the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

Note 8 – Prohibited Transactions

During 2024, the Company inadvertently failed to make deposits of \$118,507 of participant deferrals and \$2,381 of loan repayments within the timeframe as required by the DOL. Participant accounts were credited with the late deferral amounts in 2024, but these accounts were not credited with the amount of investment income which would have been earned had the participant contributions remitted on a timely basis. Lost earnings were calculated and remitted to the participants during 2024.

Note 9 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
