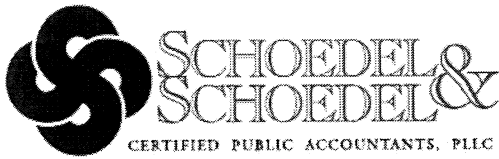

## INDEPENDENT AUDITOR'S REPORT

To the Board of Directors of the

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of the Skills'kin 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of May 30, 2025 and December 31, 2024, and the related statements of changes in net assets available for benefits for the period ended May 30, 2025 and year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of May 30, 2025 and December 31, 2024, and for the period ended May 30, 2025 and year ended December 31, 2024, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Emphasis of Matter - Plan Termination**

As discussed in Note 1 to the financial statements, the plan's sponsor (Skils'kin) merged with Tessera (formerly Skookum) effective July 1, 2024. As a result, Skils'kin's board of directors decided to terminate and liquidate the Skils'kin 401(k) Plan. The Plan's liquidation was finalized May 30, 2025. Our opinion is not modified with respect to this matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audits.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Skills'kin 401(k) Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

### **Other Matter—Supplemental Schedules Required by ERISA**

The supplemental schedules of Assets (Held as of December 31, 2024) and Reportable Transactions for the period ended May 30, 2025 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. NOTE 1 - DESCRIPTION OF THE PLAN:

The following description of the Skils'kin 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document, summary plan description and other descriptive plan literature for a complete description of the provisions of the Plan.

General - Effective January 1, 2004, the plan sponsor (Skils'kin) adopted a prototype, defined contribution, qualified retirement plan commonly referred to as a "401(k) plan." The Plan, which is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and all subsequent statutory revisions thereto, was created for the benefit of all eligible employees.

Eligibility - Employees are eligible for salary deferral contributions if they are age eighteen or older, with the exception of leased employees, nonresident aliens, highly compensated employees or an employee category identified by the plan sponsor as unable to participate in the Plan.

Contributions - Skils'kin makes prevailing wage contributions, including corrective prevailing wage contributions into the Plan as required by the Service Contract Act, based on rates determined by the governmental agency responsible for the individual contracts. During the period ended May 30, 2025, and year ended December 31, 2024, prevailing wage contributions, including corrective prevailing wage contributions totaled \$306 and \$188,625, respectively.

Additionally, eligible employees may contribute (through an elective deferral of compensation) up to the lesser of 100% of their qualified compensation, or the amount determined by the Plan's discrimination tests. In any case, employee contributions cannot exceed the amount allowed under the Internal Revenue Code. Employee contributions are fully vested. In the absence of an election to the contrary, participants will automatically have 2% of their eligible compensation deferred and contributed to the Plan. Participants may also contribute rollover contributions from other qualified defined benefit or contribution plans.

Skils'kin may also elect to make discretionary matching contributions to the Plan. Any matching contributions are allocated to the participants in the same proportion as their pro-rata share of all participants' compensation. During the period ended May 30, 2025, and year ended December 31, 2024, matching contributions totaled \$-0- and \$53,107, respectively.

Participant Accounts - The administrator of the Plan maintains a separate account for each participant. Participants may direct contributions to any investment option approved by the plan administrator. Each participant account is credited with the participant's contribution, an allocation of contributions by the sponsor (if any), investment earnings (losses), and an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan agreement. The benefit to which a participant is entitled is limited to the benefit that can be provided from the participant's vested account.

NOTE 1 - DESCRIPTION OF THE PLAN (Continued):

Vesting - A participant is 100% vested in employee contributions, rollover contributions, and qualified matching contributions. A participant is 100% vested in other employer contributions after 3 years of service. However, if participants reach normal retirement age, die, become disabled, or if the Plan is terminated, then the balance of their funds immediately become 100% vested.

Forfeitures - A participant who has terminated employment forfeits the non-vested portion of his/her account. Forfeitures are retained in the Plan and are first used to pay Plan administrative expenses, with any remaining amounts used to reduce future employer contributions. For the period ended May 30, 2025, and year ended December 31, 2024, there were no forfeitures.

Distribution of Benefits - Participants are eligible to receive lump-sum or annual installment distributions from the vested portion of their account upon separation from service, death, disability, or the attainment of age 59½. Distributions of employee elective deferral contributions can occur if the Plan is terminated and there is no successor plan, if most of the company's assets are sold to an unrelated company, if the company sells its interest in a subsidiary to an unrelated company, or if the employee is suffering from financial hardship. Benefit distributions are recognized when paid.

Administration of the Plan - The Plan is sponsored and administered by Skills'kin, who has the sole and ultimate responsibility to interpret Plan provisions and determine Plan benefits. Funds of the Plan are held in trust, and plan benefits are distributed from the trust. The Trustees of the Plan are responsible for the safekeeping of Plan assets. To assist the Trustees, Plan assets are managed under a recordkeeping service agreement with John Hancock Life Insurance Company. Neither the administrator nor the Trustees are responsible for providing investment advice. Most administrative costs of the Plan are absorbed and paid by the plan sponsor.

Termination of the Plan - The sponsor of the Plan has the right to amend or terminate the Plan in whole or in part subject to the provisions of ERISA. Effective July 1, 2024, Skills'Kin resolved to terminate the plan due to its merger with Tessera (Formerly Skookum). All assets were distributed to the participants or transferred to the Tessera plan prior to May 30, 2025.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

The summary of significant accounting policies of the Plan is presented to assist in understanding the Plan's financial statements. The financial statements and notes are representations of the Plan's trustees, who are responsible for the integrity and objectivity of the financial statements. These accounting policies conform to accounting principles generally accepted in the United States of America and have been consistently applied in the preparation of the financial statements.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued):

Basis of Accounting - The financial statements of the Plan are prepared using the accrual method of accounting.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Mutual Funds Held by John Hancock Life Insurance Company - Mutual funds held by John Hancock Life Insurance Company (John Hancock) are unsegregated investments of John Hancock. Such investments are valued at fair value using the specific fund's net asset value (NAV). The NAV is based on the fair value of the underlying assets and liabilities of the specific fund. Investment transactions are recorded on a trade-date basis. Earnings from the mutual funds include: fund distributions and realized and unrealized holding gains and losses. For a further discussion of fair value measurements, see Note 6.

Contribution Recognition - As of May 30, 2025, and December 31, 2024, the employer was liable for prevailing wage and matching contributions based upon time worked prior to the end of the period. Such estimated contributions have been recorded as receivable.

Valuation of Other Financial Instruments - The Plan recognizes other financial instruments at historical cost, which approximates fair value, due to the short maturities of those instruments.

Net Asset Restrictions - All net assets are restricted to providing benefits and related administrative expenses.

Payments of Participant Distributions - Distributions to or for participants are recognized when paid.

NOTE 3 - TAX STATUS:

The Plan is intended to be exempt from federal income tax under current provisions of the Internal Revenue Code. The Plan is based on the John Hancock Insurance Life Company Volume Submitter Plan - Skils'kin 401(k) Plan. The Volume Submitter obtained its latest determination letter on March 31, 2008, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code.

NOTE 3 - TAX STATUS (Continued):

The Plan has been amended since receiving the determination letter. The Plan administrator believes the Plan and related trust are designed and have been operated through May 30, 2025, in accordance with applicable provisions of the Internal Revenue Code.

The Plan is subject to audit or examination by various regulatory jurisdictions. As of September 23, 2025, there were no audits or examinations in progress.

NOTE 4 - RISKS AND UNCERTAINTIES:

In determining the fair value of financial instruments, the plan administrator uses a variety of methods and assumptions that are based on market conditions and risks existing at the date of the Statement of Net Assets Available for Benefits. All methods of assessing fair value result in a general approximation of value, and such value may never actually be realized.

The Plan invests in mutual funds which in turn hold various investment securities. Investment securities are exposed to various risks including interest rate fluctuations, market fluctuations and credit risks. Due to the level of risk associated with certain types of investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

NOTE 6 - FAIR VALUE MEASUREMENTS:

Fair value estimates are made at a specific point in time, based on available market information and judgments about the financial instruments, including estimates of timing, amount of expected future cash flows and the credit standing of the issuer. In some cases, the fair value estimates cannot be substantiated by comparison to independent markets. In addition, the disclosed fair value may not be indicative of net realizable value or reflective of future fair values. Furthermore, although management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Various inputs may be used to determine the value of the Plan's investments. These inputs are summarized in three broad levels for financial statement purposes. The three-level hierarchy is used to maximize the use of observable market data and minimize the use of unobservable inputs and to establish classification of fair value measurements for disclosure purposes. The valuation inputs or methodologies used to value investments are not necessarily an indication of the risk or liquidity associated with investing in those investments.

The three levels of the fair value hierarchy are described as follows:

- Level 1: Unadjusted quoted market prices in active markets, for identical investments;
- Level 2: Other significant observable market inputs (including quoted prices for similar investments, interest rates, credit risks, etc.); and
- Level 3: Significant unobservable inputs (including the Plan's own estimates and assumptions in determining the fair value of investments).
