## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of

### REDAPT, INC. PLAN

We have performed the audits of the financial statements of **Redapt, Inc. Plan** (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

### (1) Description of the Plan

The following description of the *Redapt, Inc. Plan* (the “Plan”) provides only general information. Participants should refer to the Plan agreement, as amended, for a more complete description of Plan provisions.

- A. **General** – The Plan is a 401(k) salary deferral and profit sharing plan covering substantially all employees of Redapt, Inc., and is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Redapt, Inc. (the “Company”) is the Plan’s sponsor and serves as Plan administrator.
- B. **Eligibility** – Employees of the Company are eligible to participate in the Plan upon hire. Participants can enter the Plan on the 1st day of the first, fourth, seventh, or tenth month of the Plan year. Participants must complete at least 1,000 hours of service during the Plan year to be eligible to receive any employer paid matching or profit-sharing contributions.
- C. **Contributions** – Each year, participants may contribute up to 75% of pretax annual compensation, as defined in the Plan. Participants may also elect to make Roth contributions utilizing after-tax contributions. Participants may also have rollover amounts from other qualified plans. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Company may elect to make discretionary matching and profit sharing contributions to the Plan. The Plan sponsor implemented a discretionary employer match effective April 1, 2017, equal to 2% of eligible compensation for participants who defer a minimum of 3%. Profit sharing contributions are allocated to participants in the same proportion as a participant’s compensation bears to the total of all participants’ compensation. There were no profit-sharing contributions for the year ended December 31, 2024.

Contributions are subject to regulatory limitations.

- D. **Participant accounts** – Each participant’s account is credited with the participant’s contributions, rollover contributions and Company matching contributions as well as allocations of the Company’s profit sharing contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Participants direct the investment of their contributions into various investment options offered by the Plan.
- E. **Vesting** – Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company’s contribution portion of their accounts is based on years of continuous service. Participants fully vest in employer contributions after one year of service.
- F. **Forfeitures** – Forfeitures are the nonvested portion of a participant’s account that is lost upon termination of employment. Forfeitures are retained in the Plan and can be used to pay Plan administrative expenses or to reduce future Company matching contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$635 and \$1,651, respectively. During the year ended December 31, 2024, forfeitures totaling \$29,234 were used to reduce the employer match.

### (1) Description of the Plan (continued)

**G. Notes receivable from participants** – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are issued by the Plan and secured by the balance in the participant's account. All loans must be repaid within a period of five years, unless the loan is used to purchase a principal residence, in which case, the loan must be repaid within a reasonable period of time not to exceed ten years. Under the terms of the Plan agreement, Plan loans will bear a reasonable rate of interest determined by the Plan administrator. Principal and interest is paid ratably through bi-weekly payroll deductions. As of December 31, 2024, the rate of interest on outstanding loans was 4.25% with various maturities through May 2031.

**H. Payment of benefits** – On termination of service, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Participants over 59 ½ may elect to receive in-service withdrawals of all vested account balances. A participant may elect to receive a minimum \$500 in-service lump sum distribution for an immediate and heavy financial need. For terminated employees with balances less than \$1,000, the participant's vested balance will automatically be distributed.

### (2) Summary of significant accounting policies

The significant accounting policies followed by the Plan are as follows:

**Basis of accounting** – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America, using the accrual method of accounting.

**Management's use of estimates** – The preparation of financial statements in accordance with generally accepted accounting principles requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

**Investment valuation and income recognition** – The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See "Note 3 Fair Value Measurements" for discussion of Fair Value Measurements. In accordance with the policy of stating investments at fair value, the Plan presents, in the statement of changes in net assets available for benefits, the net appreciation in the fair value of its investments, which consists of the realized gains or losses and the unrealized appreciation on those investments. Dividends are recorded on the ex-dividend date. Interest income is recorded on an accrual basis. Purchase and sales of securities are recorded on a trade-date basis.

**Notes receivable from participants** – Notes receivable from participants are measured at amortized cost, which represents unpaid principal balance plus accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions upon the occurrence of a distributable event, based on the terms of the Plan Agreement. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

**Benefits paid to participants** – Benefits paid to participants are recorded in the period in which they are paid.

**Expenses** – Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment management, distribution and loan transaction fees are paid by the Plan participants and are included in administrative expenses. Certain investment related expenses are included in net appreciation in fair value of investments.

### (2) Summary of significant accounting policies (continued)

**Subsequent events** – The Plan has evaluated subsequent events through October 10, 2025, which is the date the financial statements are available to be issued.

Effective May 30, 2025, employees may make voluntary, non-deductible, after-tax contributions on behalf of an active employee each payroll period. Such contributions, plus the employee's deferral contribution, shall not exceed 75% of compensation. In addition, employees who are still employed may elect to have in-plan rollover contributions and conversions.

### (3) Fair value measurements

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023.

Mutual funds – Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission.

### (4) Income tax status

The Plan document is a volume submitter defined contribution plan that received a favorable opinion letter from the Internal Revenue Service on June 30, 2020 which stated that the Plan, as then designed, was in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been restated since the date of the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

In accordance with guidance on accounting for uncertainty in income taxes, the Plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### (5) Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. It is reasonably possible, given the level of risk associated with investment securities, that changes in the values of the investments in the near term could materially affect a participant's account balance and the amounts reported in the statements of net assets available for benefits.

### (6) Information certified by the trustee

The Plan Sponsor has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, the Plan's trustee has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Fair value of investments
- Notes receivable from participants
- Interest and dividends
- Interest income on notes receivable from participants
- Net appreciation in fair value of investments
- Schedule of assets (held at end of year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

(7) **Related party and party-in-interest transactions**

Plan investments include shares of mutual funds managed by Fidelity Investments. Fidelity Investments is an affiliate of Fidelity Management Trust Company and, therefore, transactions with these entities qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment management services to Fidelity Investments and recordkeeping related fees totaled \$40,655 for the year ended December 31, 2024.

(8) **Plan termination**

Although it has not expressed any intention to do so, the Company has the right to terminate the Plan and discontinue its contributions at any time. If the Plan is terminated, amounts allocated to a participant's account become fully vested.
