Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Oregon Brewing, Co. 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion on the 2024 and 2023 financial statements.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

1. DESCRIPTION OF THE PLAN

The following description of the Oregon Brewing, Co. 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement and summary plan description for more complete information.

General – The Plan is a defined contribution profit sharing plan covering substantially all employees of Oregon Brewing, Co. (the “Company”) who are age 21 or older. The Plan provides participants with a salary deferral option pursuant to Section 401(k) of the Internal Revenue Code (“IRC”).

The Plan is a safe harbor plan which exempts the Plan from anti-discrimination requirements on the accounts of highly compensated employees, while mandating that the Company make minimum contributions to all participant accounts making elective contributions. The Plan engages Reliance Trust Company (“Trustee”) to hold and invest Plan assets and execute Plan transactions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

Eligibility – Employees may enter the Plan and make elective contributions after completing three months of service and reaching age 21. Eligible employees can enter the Plan as a participant on the first day of the month following the date that service entry requirements are met.

Contributions – Eligible employees may contribute a portion of their pre-tax annual compensation to the Plan up to the maximum allowed each calendar year under the IRC of \$23,000 and \$22,500 in 2024 and 2023, respectively, or after-tax Roth contributions, or a combination of both. Participants who have attained the age of 50 before the end of the plan year are eligible to make additional catch-up contributions up to \$7,500 in 2024 and 2023. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions).

The Plan also offers a “Save Smart” feature where participants can elect to automatically increase contributions by 1%, 2%, or 3% per year, on the date chosen by the participant.

The Company will make a safe harbor matching contribution equal to 100% on the first 3% of eligible earnings that a participant defers and an additional 50% on the next 2% of eligible earnings that the participant defers. The Company may also provide a discretionary profit sharing contribution, which is determined by the Board of Directors of the Company. Eligible employees who have completed three months of service are eligible to receive the discretionary profit-sharing contribution. There were no profit sharing contributions made in 2024 and 2023.

Participants Accounts – The Plan offers various registered investment companies (mutual funds) as investment options for participants. Each participant’s account is credited with the participant’s contribution, an allocation of the Company’s safe harbor matching contribution, the Company’s discretionary profit sharing contributions, if any, and their share of Plan earnings and expenses. Allocations are based on participant earnings or account balances, as defined by the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

1. DESCRIPTION OF THE PLAN - Continued

Vesting – Participants are immediately vested in their voluntary contributions and safe harbor matching contributions plus actual earnings thereon. Participants must have a minimum of 1,000 hours to earn a year of service. Vesting in discretionary and profit sharing contributions by the Company is based on years of service as follows:

<u>Years of Service</u>	<u>Vesting</u>
Less than 2 years	0%
2 years	20%
3 years	40%
4 years	60%
5 years	80%
6 years or more	100%

Participants become 100% vested upon attainment of normal retirement age (65 years), death, or permanent disablement.

Notes Receivable from Participants – Participants may borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years, or up to 30 years for the purchase of a principal residence. Principal and interest is paid ratably through payroll deductions. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus two percentage points. The interest rates were 5.25% to 10.50% for the years ended December 31, 2024 and 2023.

Payment of Benefits – On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of his or her account, substantially equal installments, or partial withdrawals of at least \$500. Participants also may withdraw a lump sum distribution up to 100% of their elective deferral contributions to pay for certain financial hardships as defined by the Plan.

Forfeitures – At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$7,931 and \$7,541, respectively.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The financial statements of the Plan are prepared under the accrual method of accounting.

Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - Continued

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Investment Valuation and Income Recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisors, and the Trustee.

Purchases and sales of securities are recorded on a trade-date basis. Interest income and other income are recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits – Benefits are recorded when paid.

Expenses – Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to distributions and the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Certain investment related expenses are included in net depreciation of fair value of investments. Investment advisor fees are charged to participant accounts based on the balance of the account as a percentage of the total Plan balance.

Contributions Receivable – Represents the amount that the employees have had withheld from their wages that had not been remitted to the Plan by December 31 and any amounts the employer is obligated to contribute for work that participants performed during the years ended December 31, 2024 and 2023. The Plan's management considered all employer contributions receivable to be fully collectable. Accordingly, there is no allowance for expected credit losses.

3. INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE

The Plan's investments are held by Reliance Trust Company, the Trustee of the Plan. Investment decisions are made at the direction of the participants. The investments are credited for earnings thereon and charged for withdrawals and expenses as charged by the Trustee. The Plan Administrator has obtained a certification from the Trustee as of December 31, 2024 and 2023, and for the year ended December 31, 2024 that the following information provided to the Plan Administrator by the Trustee is complete and accurate:

- Investments, at fair value
- Notes receivable from participants
- Net appreciation (depreciation) in fair value of investments
- Interest and dividends
- Interest income on notes receivable from participants

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observed for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies (mutual funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Changes in Fair Value Levels – The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported on the actual date of the event or change in circumstances that caused the transfer.

The Plan's management evaluates the significant transfers, if any, between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the years ended December 31, 2024 and 2023, there were no significant transfers in or out of levels 1, 2 or 3.

5. INCOME TAX STATUS

The Internal Revenue Service has determined and informed the Plan that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code. The Plan may be amended from time to time, however; it is the Trustees' and the Plan's tax counsel's intent to maintain the Plan so that it is designed and operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

9. DELINQUENT EMPLOYEE DEFERRAL TRANSMITTALS

During the year ended December 31, 2021, the Company failed to remit certain employee deferrals and the related Company match totaling \$34,126 to the Plan in the time period described in 29 CFR 2510.3-102. The Company made corrective contributions to the Plan during the year ended December 31, 2023, and lost earnings were corrected in October 2024.

During the year ended December 31, 2024, the Company failed to remit certain employee deferrals and the related Company match totaling \$11,755 to the Plan in the time period described in 29 CFR 2510.3-102. The Company made the contributions to the Plan in January 2025, and is in the process of making corrections for lost earnings. The Company will also file the required Form 5330, Return of Excise Taxes Related to Employee Benefit Plans with the IRS, and pay the appropriate excise taxes.

10. PLAN TERMINATION

Although they have not expressed any intention to do so, the Company has the right under the Plan to agree to discontinue contributions and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

11. SUBSEQUENT EVENTS

Management of the Plan has evaluated events and transactions occurring after December 31, 2024 through October 10, 2025, the date the financial statements were available for issuance, for potential recognition or disclosure in the financial statements and concluded that no subsequent events have occurred that would require recognition in the financial statements or disclosure in the notes to the financial statements.

12. RECENTLY ADOPTED ACCOUNTING GUIDANCE

In June 2016, the FASB issued guidance (FASB ASC 326) Allowance for Credit Losses. The Plan adopted the standard effective January 1, 2023. The impact of the adoption was not material to the financial statements.

13. OTHER INCOME – REPAYMENT OF EXCESS CONTRIBUTIONS

In January 2024, the \$29,068 of excess contributions that had been remitted to the Plan in 2021 was returned. However, since several of the related participants had left the Plan, and their account balances had already been distributed out prior to the return of these contributions, only \$20,650 was able to be returned. The remaining amount of \$8,418 has been written off to other income for the year ended December 31, 2024.

In addition, another amount of \$12,105 related to the excess contributions was returned in October that should not have been returned. That amount, along with the \$11,755 that were remitted late as seen in Note 9, make up the \$23,860 in contributions receivable as of December 31, 2024.
