Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### ***Opinion***

### ***Basis for Opinion***

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

***Other Matter — Supplemental Schedules Required by ERISA***

The supplemental schedules, Schedule H, Line 4i – Schedule of Assets (Held at End of Year) and Schedule H, Line 4a – Schedule of Delinquent Participant Contributions as of or for the year ended December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

**DECEMBER 31, 2024 AND 2023**

**NOTE 1 – DESCRIPTION OF PLAN**

The following description of The Parr Company 401(k) Savings and Profit Sharing Plan (the Plan) provides general information only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution 401(k) plan covering substantially all employees of Parr Lumber Company and Subsidiaries (the Company) who have met eligibility requirements. The Plan Administrative Committee manages the operation and administration of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions** - Contributions consist of pre-tax and Roth employee elective deferrals and employer discretionary matching and profit sharing contributions. Employee elective deferrals and the employer discretionary matching contributions are recorded in the year in which the employee contributions are withheld from compensation. Participants may voluntarily contribute any full percentage of their compensation, limited to \$23,000 and \$22,500 in 2024 and 2023, respectively, as prescribed by the Internal Revenue Code (IRC). Participants age 50 and older may elect to make an additional catch-up contribution limited to \$7,500 annually. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Plan also includes an auto-enrollment provision whereby 6% of the compensation of newly eligible participants will be automatically deferred into the Plan unless the participant affirmatively elects not to participate in the Plan or elects to contribute a different amount. Company matching and profit sharing contributions are determined annually by the Administrative Committee for each participating employer. The Company's matching contributions were \$2,304,606 and \$2,410,947 for 2024 and 2023, respectively. The Company's profit sharing contributions were \$2,656,072 and \$2,718,153 for 2024 and 2023, respectively.

**Participant Accounts** - A separate account is maintained for each participant which records the participant's contributions, the Company's matching and profit sharing contributions, account earnings and an allocation of Plan expenses. Company matching and profit sharing contributions are based on eligible compensation. Plan expenses are allocated, in part, based on participant account balances. The benefit to which a participant is entitled is their vested account balance.

**Vesting** - Participants are immediately vested in their voluntary contributions and actual earnings thereon. The Company's matching and profit sharing contributions to the Plan, that are credited to participants' accounts, become 100% vested and non-forfeitable after three years of service. Participants are also 100% vested upon death, total and permanent disability or retirement.

**Payment of Benefits** - Prior to termination, the Plan provides for hardship distributions and participant loans. Hardship distributions are only available for the purpose of meeting immediate and heavy financial needs including medical expenses, purchase of principal residence, payment of post-secondary education tuition or to prevent eviction or foreclosure on the participant's principal residence. The participant must have exhausted all other available resources to qualify for a hardship distribution. Upon termination of employment, a participant may receive a lump sum amount equal to their vested account value, installment or Ad-Hoc distributions.

**ERISA Fee Account** - The ERISA Fee Account accumulates amounts from the participant accounts and from revenue sharing that the Plan uses to fund administrative expenses. The ERISA Fee Account paid \$126,809 and \$155,482 in administrative fees in 2024 and 2023, respectively. The balance is unallocated and generally used in the succeeding plan year. The balance in the ERISA fee account was \$8,930 and \$21 at December 31, 2024 and 2023, respectively.

**Expenses** - Administrative expenses of the Plan may be paid by the Company. Plan administrative expenses not paid by the Company or from the ERISA Fee Account are paid from revenue sharing income or from forfeitures. Revenue sharing income generally consists of 12(b)1 fees and sub-transfer agency fees and is used by the Plan to pay plan expenses. Investment management expenses are deducted from investment earnings before allocation to participants' accounts. Loan and distribution administration expenses are charged to the participant's account. In addition, certain expenses of plan administration, including computer services, some professional fees, office supplies and payroll expenses of administrative and clerical personnel are provided by the Company without charge to the Plan.

**Forfeited Accounts** - The balances of terminated participants' non-vested accounts are forfeited and used to pay Plan administrative expenses or fund employer matching or profit sharing contributions. The Plan administrative expenses were reduced by \$42,306 and \$0 from the use of forfeited nonvested accounts in 2024 and 2023, respectively. The employer matching and profit sharing contributions were reduced by \$28,460 and \$31,391 from the use of forfeited nonvested accounts in 2024 and 2023, respectively. The balances of forfeited accounts as of December 31, 2024 and 2023 were \$40,366 and \$28,460, respectively.

## **NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting** - The financial statements of the Plan are prepared under the accrual method of accounting.

**Investment Valuation and Income Recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year, and management and operating expenses associated with the Plan's investments in mutual funds.

**Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded at December 31, 2024 or 2023. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit loan payment is recorded.

**Benefit Payments** - Benefits are recorded when paid. Accordingly, benefits payable to persons that have elected to withdraw from the Plan but are not yet paid at year-end have not been accrued. At December 31, 2024 and 2023, there were \$41,665 and \$3,971, respectively, in benefits payable to participants.

**Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

**Subsequent Events** - The Plan's management has performed an evaluation of subsequent events through October 13, 2025, which is the date these financial statements were available to be issued.

### **NOTE 3 – FAIR VALUE MEASUREMENTS**

Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

#### **Basis of Fair Value Measurement**

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access at the measurement date.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets in active markets;
- Quoted prices for identical or similar assets in inactive markets;
- Inputs other than quoted prices that are observable for the asset; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Money market mutual fund:* Valued using the amortized cost method or penny rounding method as permitted by Rule 2a-7 under the Investment Company Act of 1940.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumption to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan administrator has obtained a certification from the custodian indicating that such information is complete and accurate.

#### **NOTE 5 – NOTES RECEIVABLE FROM PARTICIPANTS**

The Plan makes loans to participants based on their vested balances. Loans must be repaid within five years unless the proceeds are used to purchase the participant's primary residence. Loans are payable through payroll deductions with monthly payments required. At December 31, 2024, interest rates ranged from 5.25% to 10.50%. Loans are secured by the vested account balances of the participant.

#### **NOTE 6 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in Company contributions.

#### **NOTE 7 – CONCENTRATIONS, RISKS AND UNCERTAINTIES**

The Plan provides for investments that are exposed to various risks. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits, and therefore participants' account balances. There are three investments that represent more than 10% of investments held as of December 31, 2024 and 2023. See the supplemental Schedule of Assets (Held at End of Year) for the complete listing of investments held as of that date.

#### **NOTE 8 – INCOME TAX STATUS**

The Plan has adopted a pre-approved defined contribution plan sponsored by Eisenhower Carlson PPLC. An opinion letter was received on June 30, 2020, in which the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## NOTE 9 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The non-interest bearing cash and certain Plan investments are shares of a money market mutual fund managed by Charles Schwab Trust Bank, the custodian, therefore, these transactions qualify as party-in-interest transactions. There is no fee related to the non-interest bearing cash. The fee for investment management services for the money market mutual fund managed by Charles Schwab Trust Bank was 0.21% in 2024 and 2023, and is netted against Plan earnings.

## NOTE 10 – RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500
