Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Virginia Eagle Distributing 401(k) Plan, ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTE 1 - PLAN DESCRIPTION

The following description of the Virginia Eagle Distributing (the Company) 401(K) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan includes eligible employees of Virginia Eagle Distributing Company, LLC and Arkansas Distributing Company, LLC. As of August 31, 2020, the assets of Arkansas Distributing Company, LLC were sold. No additional employee or employer contributions will be made for Arkansas Distributing Company, LLC going forward.

General

The Plan is a defined contribution plan covering all employees of the participating employers who have completed three consecutive months of service and are age eighteen or older and are not governed by a collective bargaining agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees is responsible for oversight of the Plan.

Contributions

Participants may defer up to 100% of pretax annual compensation, as defined in the Plan. Participant deferrals are subject to a maximum annual cap of \$23,000 for 2024, as defined Internal Revenue Code Section 402(g). Additionally, participants who have obtained the age of 50 before the end of the Plan year are eligible to make catch-up contributions as allowed under the Internal Revenue Code 401(k). Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company contributes 100% of the first 3% and 50% of the next 2% of eligible compensation that a participant contributes to the Plan to satisfy the "safe harbor" contribution requirements of Internal Revenue Code Section 401(k)(12)(c). Additional employer matching and profit sharing amounts may be contributed at the option of the Company's Board of Directors. Employer contributions totaled \$820,845 and \$806,425 for the years ended December 31, 2024 and 2023, respectively.

NOTE 1 - PLAN DESCRIPTION (continued)

Participant Accounts

Each participant's account is credited with the participant's contribution, employer matching, and an allocation of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon and in the Company safe harbor matching contributions. The Plan was amended October 1, 2018, to provide six-year graded vesting for discretionary employer matching and profit-sharing contributions, with participants being 20% vested after two years and every year thereafter with 100% vested after six years. Prior to this date, participants were 100% vested in these discretionary contributions after five years. See the Plan agreement for a more complete description of the vesting policies.

Investment Options

Upon enrollment in the Plan, a participant may direct employee and employer nonelective contributions to a variety of investment options with various objectives and degrees of financial risk. The Plan currently offers approximately thirty-five pooled separate account funds and an interest-bearing fixed account as investment options for participants.

Participants may change their investment option at any time.

Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account for amounts not exceeding \$5,000. If the participant's vested account balance exceeds \$5,000, and he or she has attained age 65 (normal retirement age), the participant may elect to receive a single lump-sum payment, installments over a period of not more than the participant's assumed life expectancy or partial withdrawals.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$1,322 and \$1,247 , respectively. These accounts may be used to reduce future employer contributions and pay Plan expenses. During 2024, \$0 of forfeited non-vested accounts were used; during 2023, \$0 of forfeited non-vested accounts were used.

Secure 2.0 Act

The Secure 2.0 Act was signed into law on December 29, 2022. This legislation contains numerous significant changes for retirement plans, plan sponsors, and retirement plan providers. For example, the SECURE 2.0 Act contains provisions related to, among many other things, increasing the required minimum distribution age, reducing required minimum distribution penalties, and removing required minimum distribution barriers for annuities. Many of the provisions in the SECURE 2.0 Act are effective in 2024, but the SECURE 2.0 Act will not be completely implemented until 2027. Plan management is currently in the process of evaluating the impact of SECURE 2.0 on the Plan and its participants.

NOTE 2 - SUMMARY OF ACCOUNTING POLICIES

Date of Management's Review

The Company has evaluated subsequent events through October 14, 2025, the date which the financial statements were available to be issued.

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for Plan benefits and changes therein. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisors and Trustees. See NOTE 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2

Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts are valued based upon the units of such pooled separate accounts held by the Plan at year end multiplied by the respective unit value. As of December 31, 2024 and 2023, pooled separate accounts held by Voya are valued at their "accumulation unit value" (AUV). These are valued daily as the number of accumulation units held multiplied by the AUV. The AUV is determined daily based on the net asset value of shares of the underlying fund, the fund's dividends and the contract's separate account charges. Investments in the pooled separate accounts are measured at fair value using the net asset value per share. The Plan has concluded that the net asset value as adjusted and reported by the insurance company denotes readily determinable fair value and are included in the fair value hierarchy as Level 1 and categorized as the underlying investments.

Due to the nature of the pooled separate accounts discussed above, there are no unfunded commitments or redemption restrictions.

The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future

fair value. The Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Transfers between Levels

For years ended December 31, 2024 and 2023, there were no significant transfers between Levels 1 and 2 and no transfers in or out of Level 3.

NOTE 5 - INVESTMENT CONTRACT WITH INSURANCE COMPANY

In 2018, the Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Voya Retirement Insurance and Annuity Company (Voya). The contract value of the investment contract at December 31, 2024 and 2023 totaled \$668,734 and \$647,807, respectively. Voya maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment

contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Interest is added daily to amounts held in the Fixed Account at a guaranteed annual rate of no less than 1.00%. The crediting rate is based on a formula established by the contract issuer. The minimum credit rate is reviewed on an annual basis of resetting and will apply to all amounts held in the Fixed Account during the calendar year. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the Trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to contract at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds and a fully benefit-responsive investment contract managed by Voya Financial. Voya Institutional Plan Services, LLC, a subsidiary of Voya Financial, is the record-keeper as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management and other services amounted to \$101,060.

For the years ended December 31, 2024 and 2023, the Plan held 139.119 and 137.956 units of Voya Financial investments, respectively, at a current market value of \$1,664 and \$1,572, respectively. Also, for the years ended December 31, 2024 and 2023, the Plan's fully benefit-responsive contract had a current contract value of \$668,734 and \$647,807, respectively.

A portion of the Plan's assets is invested in this entity's mutual funds and a fully benefit-responsive investment contract. Because of the relationships described in the above paragraphs, both the sales and purchases of Voya Financial mutual funds qualify as party-in-interest transactions. All of these transactions are exempt from the prohibited transaction rule.

NOTE 7 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

NOTE 8 - INCOME TAXES

The Plan Sponsor has adopted a prototype plan which received a favorable determination from the Internal Revenue Service. The Plan itself has not separately applied for recognition of tax-exempt status. Although the Plan has been amended since receiving the determination record, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with applicable requirements of the Internal Revenue Code, therefore, believes the Plan is qualified, and the related Trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
