Report on the Audit of the Financial Statements

Opinion

We have audited the accompanying financial statements of American Senior Communities, LLC Master Welfare Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits (cash basis) as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits (cash basis) for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of the Plan (cash basis) as of December 31, 2024 and 2023, and the changes in its net assets available for benefits (cash basis) for the years then ended, in accordance with the cash basis of accounting described in Note 2.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Emphasis of Matter – Basis of Accounting

We draw attention to Note 2 to the financial statements, which describes the basis of accounting. The financial statements are prepared on the cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the cash basis of accounting as described in Note 2; and for determining that the cash basis of accounting is an acceptable basis for the presentation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

Supplemental Schedules Required by ERISA

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental schedules of assets (held at end of year) (cash basis) and of reportable transactions (cash basis) as of or for the year ended December 31, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental schedules (cash basis), we evaluated whether the supplemental schedules (cash basis), including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedules (cash basis) is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 DESCRIPTION OF PLAN

The following description of American Senior Communities, LLC Master Welfare Plan (the Plan) provides only general information. Participants should refer to the Plan document and Summary Plan Description for a more complete description of the Plan's provisions.

General

The Plan has been established to provide health and other benefits to eligible employees of American Senior Communities, LLC and affiliated employers (collectively, the Company) and covered dependents. Plan assets are held in a voluntary employees' beneficiary association (VEBA) trust. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan has been amended to comply with the provisions of the Affordable Care Act (ACA).

In general, all employees and employee owners scheduled to work at least 30 hours per week on a regular basis are eligible to participate in the Plan.

Contributions

Participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections. These amounts are in addition to deductibles and copayments which participants may be required to pay to providers for rendering care. Participants pay the full cost of supplemental and dependent life insurance, short-term disability insurance, critical care insurance, accidental benefits, and accidental death and dismemberment insurance based on the current group rate premium costs. The Company pays the full cost of basic life insurance, long-term disability, and stop-loss insurance. The Company also contributes specified monthly premium amounts based upon the benefit elections of participants. The Company may also make contributions to the Plan as needed to fund claims in excess of participants' contributions.

Benefits

The Plan provides benefits after 60 days of employment for full-time employees. The Plan provides health benefits (medical, vision, dental, and prescription drugs), life insurance, short and long-term disability benefits, critical care benefits, accident benefits, and accidental death and dismemberment benefits to eligible members and to their dependents. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Insured Benefits

The Plan fully insures the dental benefits, vision benefits, life insurance benefits (basic, supplemental, and dependent), short- and long-term disability benefits, critical care benefits, and accidental death and disability benefits (basic, supplemental, and spousal). The Company purchases annual insurance contracts for these insured benefits. Premiums for basic life insurance, long-term disability, and all supplemental and dependent coverages are paid to the insurance companies from the general assets of the Company. Premiums for all other insured benefits are paid from the assets of the VEBA trust. Regardless of whether amounts are paid from the general assets of the Company or the VEBA trust, the amounts are recognized in the financial statements of the Plan as contributions to and insurance premium expenses of the Plan.

Stop-Loss Coverage

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount). The specific stop loss limit was \$300,000 for both 2024 and 2023.

Self-Insured Benefits

Medical and prescription drug benefits are self-insured. The claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative services only (ASO) arrangements. The claims processors pay claims directly to or on behalf of participants and then are reimbursed from the Plan's VEBA trust. Despite the Plan's utilization of third-party claim's processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

The Plan utilizes a pharmacy benefit manager (PBM) which periodically secures rebates for the Plan based on the Plan's actual utilization pattern of specific drugs.

The Plan offers a flexible spending account (FSA) reimbursement arrangement under the provisions of Section 125 of the Internal Revenue Code (IRC) that is funded solely through participant pre-tax withholdings. The FSA allows eligible participants to be reimbursed tax free for qualified medical expenses subject to a specified ceiling and limited to the amount withheld for contribution to the FSA during the Plan year. Amounts remaining at the end of the year are forfeited to the VEBA trust to offset reasonable administrative expenses and future costs of providing the FSA benefit. The Company is not permitted to refund any part of the balance to the participant; the account cannot be used for anything other than reimbursements for qualified medical expenses; and any amounts withheld and not claimed for reimbursement are not portable upon termination once the employee leaves the Company.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. Under that basis, the only asset recognized is cash, and no liabilities are recognized. All transactions are recognized as either cash receipts or disbursements. Noncash transactions are not recognized in the financial statements.

Use of Estimates

The preparation of financial statements in conformity with the cash basis of accounting requires the Plan administrator to make estimates and assumptions that affect certain reported disclosures. The Plan's estimates are limited to the disclosure of benefit obligations in Note 3 to the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The ASC Employee Benefits Plans Committee determines the Plan's valuation policies utilizing information provided by the financial institution. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a cash basis. Investment income is recorded on the cash basis.

Concentration of Credit Risk

The Plan's cash balances are held at a single financial institution. Accounts at this institution are insured by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000. The balances in these accounts routinely exceed this FDIC insurance coverage limit; however, the Plan does not anticipate nonperformance by the institution.

Administrative Expenses

The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party claims administrators and commissions to brokers. These expenses are reported on the statements of changes in net assets available for benefits as administrative expenses. Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements.

Payment of Benefits

Claim payments are recorded when reimbursed to the third-party claims processors. These payments are recorded as claim payments in the accompanying statements of changes in net assets available for benefits. Premiums paid by either the Company or the VEBA trust are recorded as insurance premium payments in the accompanying statements of changes in net assets available for benefits.

Stop-Loss

Premiums paid for stop-loss insurance are presented in the accompanying statements of changes in net assets available for benefits. Stop-loss refunds totaling \$774,527 and \$1,579,096 have been netted with claims paid in the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, respectively.

Rebates

Rebates arising from the Plan's use of a PBM are recorded when received. Such rebates totaling \$1,490,109 and \$1,382,285 have been netted with claims paid in the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, respectively.

Subsequent Events

The Plan has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.

NOTE 3 BENEFIT OBLIGATIONS

The Plan "self-funds" the Plan's self-insured benefits. As of each December 31, there are self-funded claims that have been incurred on which benefit payments will be made subsequent to that date. The Plan administrator estimates the Plan's obligation for claims payable based on actual claims adjudicated prior to December 31 but paid after December 31. The obligation for claims incurred but not reported (IBNR) was estimated by Plan management using Plan provisions, the number of eligible participants, and the actual lag patterns of the Plan. These amounts are paid by the Plan only if claims are submitted and approved for payment.

NOTE 4 FAIR VALUE OF INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value as of December 31, 2024 and 2023.

Interest-Bearing Cash: Investments in interest-bearing cash are valued based on cost, which approximates fair value in a noninflationary economy and is protected by the FDIC.

NOTE 5 TAX STATUS

The VEBA trust funding certain benefits of the Plan received an exemption letter from the Internal Revenue Service dated March 28, 1978, stating that the trust is tax-exempt under the provisions of Section 501(c)9 of the IRC. However, as a result of the Plan's funding level, from time to time the trust may be subject to income taxes. For the years ended December 31, 2024 and 2023, the Plan was subject to federal and state income taxes for unrelated business taxable income (UBTI). The Plan paid \$100,000 in federal and state taxes during the year ended December 31, 2024 (2023; \$7,500), related to interest income recognized for the years ended December 31, 2024 and 2023, respectively. Income tax expense is included in administrative expenses on the statements of changes in net assets available for benefits.

UBTI is generated as a result of VEBA trust assets which exceed the amount reasonably necessary to cover unpaid accrued claims and premiums to insurance carriers, resulting in the excess accumulations being subject to UBTI. The tax is assessed on the lesser of the VEBA's income or excess assets in the qualified asset account. For UBTI purposes, the VEBA's income is equal to interest income, less bank fees associated with those earnings.

NOTE 5 TAX STATUS (CONTINUED)

In addition, the Plan and VEBA trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The Plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related VEBA trust is tax-exempt.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to, and contributions required of participants, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits or for on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

NOTE 7 PARTY-IN-INTEREST TRANSACTIONS

As described in Notes 1 and 2, the Plan has several arrangements with service providers. These transactions are party-in-interest transactions under ERISA. For the years ended December 31, 2024 and 2023, amounts incurred by the Plan are as follows:
