INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of
Assumption University Defined Contribution Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Assumption University Defined Contribution Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR-2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the investment information is prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements is complete and accurate.

Opinion on the Financial Statements

In our opinion, based on our audits and the procedures performed as described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report

- The amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the Financial Statements

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of the financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedule Required by ERISA

The following description of Assumption University Defined Contribution Retirement Plan (“the Plan”) is provided for general purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General – The Plan, adopted in 1958, and amended January 1, 2009, is a 403(b) plan sponsored by Assumption University (the “University” or the “Employer”) covering all employees of the University who are age 21 or older. Employees are eligible to join the Plan on the first day of the month coinciding with or next following their date of hire and are eligible for the Employer Match at the same time as long as they are expected to complete 1,000 hours of service in their first year. Non-faculty participants must have one year of service to receive the Employer Match. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Retirement Plan Oversight and Investment Committee (“the Committee”) is responsible for the oversight of the Plan, determines the appropriateness of the Plan’s investment offerings, and monitors investment performance.

Contributions – Participants may contribute up to 100% of their pretax annual compensation, as defined in the Plan, subject to IRS limitations. Participants who are at least age 50 may make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers traditional fixed annuity contracts, insurance company separate accounts and variable annuities, and mutual funds as investment options for participants.

Employer Match – The University makes a discretionary contribution based on the percentage of base pay that a participant contributes as follows:

Participant	Employer
1%	5%
2%	6%
3%	7%
4%	8%
5% or more	9%

Participant Accounts – Each participant’s account is credited with the participant’s contributions and allocations of (a) the University’s contribution and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

1. DESCRIPTION OF PLAN (CONTINUED)

Vesting – Participants are vested immediately in their contributions plus actual earnings thereon. All participants hired prior to February 1, 2020, are also 100% vested in the University’s contribution portion of their accounts and any earnings thereon. Effective February 1, 2020, the Plan was amended to introduce a vesting schedule based on years of continuous service for all employees hired after the amendment date. Vesting in the University’s contribution portion of their accounts is based on the following:

<u>Years of University Service</u>	<u>Percent Vested</u>
Less than 2 years	0%
2 years or more, less than 3 years	25%
3 years or more, less than 4 years	50%
4 years or more, less than 5 years	75%
5 years or more	100%

Notes Receivables from Participant – Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the participant’s vested account balance. Loans are secured by the balance in the participant’s account and bear interest at a rate of prime plus 1%, as determined by the plan administrator. Loans must be repaid over a period not to exceed five years unless the loan proceeds are used for the purchase of a primary residence, in which case a longer repayment period is allowed. Principal and interest are paid by individual bank transfers outside of the payroll system. Notes receivables from participants outstanding at December 31, 2024 and 2023 are \$324,852 and \$250,306, respectively.

Plan Loans – Prior to January 1, 2022, participants invested in fixed annuity contracts were able to borrow amounts from TIAA up to a maximum equal to the lesser of \$50,000 or an amount which provides a sufficient remaining balance to cover 110% of the loan balance. Loans are secured by the balance in the participant’s account and bear interest based on the interest rate of the underlying contract. Such loans are issued as separate contracts by TIAA as contemplated under IRC section 72(p)(5) and do not represent Plan assets. Amounts borrowed under this arrangement totaled \$52,901 and \$59,928 at December 31, 2024 and 2023, respectively, and are secured by participant balances of approximately \$58,000 and \$66,000 at December 31, 2024 and 2023, respectively. Investments underlying defaulted loan balances are reflected in the statements of net assets available for benefits until a distribution event occurs. The TIAA Traditional Annuity balance includes \$23,734 and \$22,535 of defaulted loans at December 31, 2024 and 2023, respectively.

Payment of Benefits – Benefits may be distributed to participants upon termination of employment by reason of retirement, disability, death or other separation from service. Participants who terminate employment and have a vested account balance of less than \$1,000 will receive lump sum distribution of 100% of their vested benefits. Terminated participants who have a vested account balance in excess of \$1,000 may leave their funds invested in the Plan, may elect annual installments, or may elect a lump sum distribution. Upon retirement, disability, or death, a participant or his or her beneficiary may elect a lump sum distribution, annual installments or a joint and survivor annuity. Fixed annuity contracts are subject to restrictions for withdrawals.

A participant may also request a withdrawal from his or her account upon attainment of age 59 ½ or upon demonstration by the participant to the plan administrator that the participant is suffering from financial hardship.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The accompanying financial statements have been prepared using the accrual method of accounting.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participant would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates – The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits – Benefits are recorded when paid.

Other Income and Plan Expenses – Other income is revenue service credits generated by Plan investments, and is available to pay Plan expenses. All expenses not paid by revenue credits in the administration of the Plan are paid by the University. Unused revenue credits remain in the Plan to be available for future Plan expenses.

Investment Valuation and Income Recognition – The Plan’s investments are reported at fair value, except for fully benefit-responsive contracts that are recorded at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Committee determines the Plan’s valuation policies utilizing information provided by investment advisors, custodians, and investment companies. See Note 6 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

3. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

4. INFORMATION CERTIFIED BY THE QUALIFIED INSTITUTIONS

Certain information related to investments and notes receivables from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivables from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividend income, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by TIAA, CREF, TIAA on behalf of TIAA, FSB, and Voya Retirement Insurance and Annuity Company (qualified institutions).

5. TIAA TRADITIONAL ANNUITY

The TIAA Traditional Annuity is an unallocated fixed annuity contract available as an investment option to plan participants. Each contract is fully and unconditionally guaranteed by TIAA. The Traditional Annuity is offered through a variety of contract types, with certain distinct features such as guaranteed minimum interest rate, additional interest declarations, the degree of liquidity of the participants' accounts, and the options for receiving income upon retirement. Certain traditional annuity contracts with no liquidity restrictions are considered fully-benefit responsive. Such contracts amounted to \$6,736,477 and \$7,614,669 at December 31, 2024 and 2023, respectively, and are reported at contract value in the accompanying financial statements.

When participants choose to allocate a portion of their retirement savings to TIAA Traditional Annuity during the accumulation phase of the contract, their contributions purchase a specific amount of lifetime income based on the contractual rate schedule in effect at the time the premium is paid. The participant's principal, plus a specified minimum rate of interest, is guaranteed by TIAA's claims-paying ability. The traditional annuity provides the potential for additional interest if declared by TIAA's board of trustees. Together, the guaranteed minimum and additional amounts make up the crediting interest rate. The crediting interest rate was 3% in 2024 and 2023, and the average yield based on actual earnings was 3.35% and 3.71% for fully-benefit responsive contracts for the years ended December 31, 2024 and 2023, respectively, and 4.45% and 4.64% for non-benefit responsive contracts for the years ended December 31, 2024 and 2023, respectively.

Contracts with restrictions on withdrawals or transfers may prohibit lump-sum withdrawals and require withdrawals in annual installments over ten years (five years after termination of employment). When a participant's accumulation in the TIAA Traditional Annuity is converted to a lifetime annuity, the present value of the stream of payments is equal to the accumulated balance, and the entire amount is recorded as a distribution in the statement of changes in net assets available for benefits. The subsequent stream of annuity payments occurs outside the Plan and does not represent an obligation of the Plan.

There are no reserves against contract value for credit risk of the contract issuer or otherwise.

6. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation method include: quoted prices for similar assets and liabilities in active markets, quoted prices for identical or similar assets and liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3: Inputs to the valuation method are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for Plan assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Non-Benefit Responsive Fixed Annuity Contracts – The non-benefit responsive TIAA fixed annuity contracts are reported at contract value, which approximates fair value. The contract value equals the accumulated cash contributions and interest credited to the plan's contracts, less any withdrawals or transfers. The fixed annuity contracts are not available for sale or transfer on any securities exchange. Accordingly, transactions in similar investment instruments are not observable. The TIAA fixed annuity contracts are considered Level 3. The crediting rate is supported by the investment performance of a large, diversified portfolio (TIAA's general account), is correlated with the highest quality debt security yields, and is adjusted for contract liquidity. A twenty-year analysis of crediting rates for TIAA Traditional annuity contracts suggests a rate of return that is representative of a market rate for this product type. Thus application of observed rates would yield a discounted cash flow which approximates contract value.

Real Estate Separate Account – Reported at a unit value calculated based on the fair value of the underlying investments. The real estate separate account generally invests in real estate properties and real-estate-related investments. The fair value is principally derived from the market value of the underlying real estate holdings or other real-estate-related investments. Real estate holdings are valued principally using external appraisals, which are estimates of property values based on a professional's opinion. The real estate separate account sometimes holds securities as well. These are generally priced using values obtained from independent pricing sources. Unit values are calculated each day. Although the underlying assets of this account cannot be quickly sold and converted to liquid assets, TIAA provides a liquidity guarantee to ensure the account has funds available to meet participant withdrawals at quoted unit values. These investments may be redeemed quarterly with one day's notice. Transfers in or out of this account are restricted to one per calendar quarter. There

are no unfunded commitments related to these investments. The real estate separate account is listed on the NASDAQ website, and its unit value is updated overnight for each day that NASDAQ is open.

Other pooled separate accounts – Valued daily based on the market values of the underlying assets in each pooled separate account. The majority of the underlying net assets have observable Level 1 and/or 2 quoted pricing inputs which are used to determine the unit value of the pooled separate accounts, which are not publicly quoted. These securities are classified as Level 2. The redemption frequency of each of these pooled separate accounts is daily, and there are no redemption restrictions.

Variable annuities – Variable annuities holding CREF accounts are valued at the net asset value of the shares held by the Plan at year end, based on the fair values of the underlying investments. The accounts invest in equity securities, fixed income instruments and short-term investments in accordance with each portfolio's investment objectives. Investments are primarily valued using market quotation or prices obtained from independent pricing sources. Shares are redeemable on a daily basis and net asset value is determined each business day. There are no unfunded commitments related to investments in these variable annuities. The CREF accounts are listed on the NASDAQ website, and their unit values are updated overnight for each day that NASDAQ is open.

Mutual funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value and to transact at that price. Mutual funds offered by TIAA-CREF are generally redeemable every 30 days. Some of the mutual fund offerings incur a 2% fee if redeemed in less than 60 days from purchase.

7. RELATED PARTY TRANSACTIONS

The Plan invests in insurance contracts, annuities and mutual funds sponsored by the Plan's insurance companies, TIAA, CREF, TIAA, FSB and Voya. These transactions qualify as party-in-interest transactions. Management fees charged to the Plan for investments in mutual funds are deducted from income earned on a daily basis and are reflected as a reduction of net appreciation in fair value of investments.

8. PLAN TERMINATION

Although the Plan was established with the intention that it will continue indefinitely, the University retains the right to discontinue its contributions at any time or to terminate the Plan, subject to the provisions of ERISA. However, no such action may deprive any participant or beneficiary under the Plan of any vested right.

9. TAX STATUS

The Plan was established with the adoption of the Volume Submitter 403(b) Plan document issued by TIAA. TIAA has received an opinion letter from the IRS dated August 7, 2017 which stated that the form of the plan document is acceptable under Section 403(b) of the Internal Revenue Code (IRC) for use by employers for the benefit of their employees. The Plan administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

10. SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.
