## Independent Auditor's Report

### The Plan Administrator RMB Products, Inc. 401(k) Plan

#### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of RMB Products, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

#### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

**NOTE 1      DESCRIPTION OF THE PLAN**

The following brief description of the RMB Products, Inc. 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

**General**

The Plan was established on January 1, 1997. The Plan is a defined contribution plan covering all eligible employees of RMB Products, Inc. (the Company or Plan Sponsor). In August 2024, the Plan Sponsor was acquired by Integrated Polymer Solutions. The Plan continues to operate in accordance with its existing provisions and no changes have been made to the terms, operations, or sponsorship of the Plan as a result of the acquisition. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective July 31, 2022, the Plan was amended and restated to comply with legislative and regulatory changes set forth in Internal Revenue Service (IRS) for the Cycle Three restated non-standardized pre-approved profit-sharing plan adoption agreement.

**Eligibility**

An employee is eligible to become a participant in the Plan following the attainment of age 18, as defined by the Plan document. There is no eligibility service requirement for participation in pre-tax elective deferrals, Roth deferrals, matching contributions, and safe harbor contributions. However, an employee must complete one year of service to be eligible for employer profit-sharing contributions.

Certain employees of the Company are excluded from participation in the Plan in accordance with the Plan's provisions. Excluded employees are: (1) employees covered by the terms of a collective bargaining agreement; (2) nonresident aliens who received no earned income from sources within the United States; (3) leased employees; and (4) individuals who were incorrectly determined not to be employees of the Company.

**Entry Date**

Employees may enter the Plan on the first day of the month coinciding with or following the date they satisfy the Plan's eligibility requirements.

**Contributions**

Each year, participants may contribute up to 100% of their pretax annual compensation, as defined in the Plan. Contributions are subject to certain Internal Revenue Code (IRC) limitations. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan allows participants to designate contributions as Roth contributions. Participants may also contribute amounts representing rollovers from other qualified plans. The Company makes a safe harbor matching contribution of 100% of the first 3% of employee deferral and 50% of the excess of 3% not exceeding 5% of employee deferral, whichever is lower, that a participant contributes to the Plan.

**NOTE 1      DESCRIPTION OF PLAN (CONTINUED)**

**Contributions (Continued)**

In addition, the Company may make discretionary matching contributions and discretionary profit-sharing contributions for participants who contribute to the Plan. Discretionary profit-sharing contributions will be allocated pro-rata based on the ratio of the participant's compensation to the total compensation of all qualified participants for the plan year. During the year ended December 31, 2024, the Company made no discretionary matching and profit-sharing contributions.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 1% of eligible compensation, with no automatic escalation of deferral amount, and their contributions are invested in a designated fund until changed by the participant.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, actual earnings thereon and allocations of the employer's contributions and Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Investment Options**

The Plan is intended to comply with Section 404(c) of ERISA. Accordingly, the participants, rather than the Plan Administrator, are responsible for making investment decisions for their accounts. Participants direct the investment of their account balances into various investment options offered by the Plan. Upon enrollment in the Plan, a participant may make direct contributions in any increments into any of several investment options. All the accounts are in custody of the third-party administrator. Participants may change their investment options inside the platform at any time.

**Vesting**

Participants are immediately vested in their elective deferral, any rollover contributions made to the Plan and safe-harbor employer base contributions, plus actual earnings thereon. Vesting in the employer matching contributions and employer profit-sharing contributions portion of their accounts is based on years of continuous service. The following table sets forth the Plan's vesting schedule for employer contributions:

Participants are fully vested upon retirement, death, disability, or Plan termination.

**NOTE 1      DESCRIPTION OF PLAN (CONTINUED)**

**Forfeitures**

Amounts forfeited from terminating participants' non-vested portion of the Company's contributions and earnings thereon are used to reduce the Company's contributions for the Plan year in which such forfeitures occur. At December 31, 2024 and 2023, the forfeiture account balance was \$1,123 and \$1,087, respectively. There were no forfeitures that were used in 2024 and 2023. In line with IRS proposed regulations, the Plan expects to use any forfeitures that arose prior to 2024 by December 31, 2025.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account. The loan interest rate is set at 2% above the prime rate.

Principal and interest are paid ratably through payroll deductions over a period not to exceed five years, unless the proceeds of the note were used to acquire the participant's primary residence. A participant may have no more than two outstanding notes at any one time. Principal and interest are repaid through biweekly payroll deductions.

**Payment of Benefits**

Participants may elect to receive either a lump-sum amount equal to the value of their vested interest or partial withdrawal as defined in the Plan document upon retirement, termination of service, death or disability. A terminated participant with a balance of less than \$5,000 may be automatically paid out by the Plan upon termination. Participants with account balances of \$1,000 or less who are eligible for rollover distributions must take a lump-sum distribution as soon as practicable following termination.

Participants who are at least 59 ½ years of age may take an in-service distribution of their vested account balance. The Plan allows in-service distribution in cases of financial hardship.

**NOTE 2      SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

**Use of Estimates**

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

**NOTE 2      SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and the trustees. See Note 3 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable are reclassified as distributions based on the terms of the Plan Document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

**Contributions and Contributions Receivable**

Contributions from Plan participants and the matching contribution from the Plan Sponsor are recorded in the year in which the participant contributions are withheld from amounts paid, which is the pay date. Profit-sharing contributions are recognized upon authorization and recorded in the year in which the underlying compensation is recognized. All participant and employer contributions are participant directed. The Plan records receivables for contributions based upon the contributions recognized, less amounts received by the Plan as of the last day of the Plan year.

**Payments of Benefits**

Benefit payments to participants are recorded upon distribution.

**Administrative Expenses**

The Plan's expenses are paid either by the Plan or the Company, as provided by the Plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying Statements of Changes in Net Assets Available for Benefits. In addition, certain investment-related expenses are included in the net appreciation (depreciation) in fair value of investments presented in the accompanying Statements of Changes in Net Assets Available for Benefits.

**NOTE 3      FAIR VALUE MEASUREMENT**

The Plan has adopted Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*. This framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurement).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the plan are deemed to be actively traded.

**NOTE 3 FAIR VALUE MEASUREMENT (CONTINUED)**

Common collective trusts: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. These investments may be redeemed on a daily basis, with settlement generally occurring on the next business day. There are no redemption restrictions or gates under normal market conditions. Were the Plan to initiate full redemption of the collective trust, the trustee may delay distribution as necessary in order to ensure that security liquidations will be carried out in an orderly manner. The Plan has no unfunded commitments related to these investments.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 4 FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE**

The Plan's asset information as of December 31, 2024 and 2023, and for the years then ended, included throughout the Plan's financial statements and ERISA-required supplemental schedule, were obtained by management and agreed to or derived from information certified by Ascensus Trust Company (Ascensus), the trustee of the Plan as of and for the years ended December 31, 2024 and 2023. The Plan Administrator has obtained certifications from the trustee that information provided to the Plan Administrator by the trustee related to the assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and ERISA-required supplemental schedule related to the following:

- Investments and notes receivable from participants, as reflected in the Statements of Net assets Available for Benefits as of December 31, 2024 and 2023;
- Investment activity, as reflected in the Statements of Changes in Net Assets Available for Benefits for the years ended December 31, 2024 and 2023;
- Investment information disclosed in Note 3 to the Plan's financial statements; and
- Investments, as reflected in Schedule H, Part IV, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024.

**NOTE 5 RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

The Plan allows for transactions with certain parties-in-interest, as defined by ERISA. Certain Plan investments are managed by Ascensus. Ascensus is the trustee for the Plan and, therefore, these transactions qualify as party-in-interest transactions. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activities to various service providers. These transactions are exempt party-in-interest transactions under ERISA. Total fees paid by the Plan for administration services amounted to \$12,314 and \$11,177 for the years ended December 31, 2024 and 2023, respectively.

**NOTE 6 INCOME TAX STATUS**

The Plan Sponsor adopted a non-standardized profit-sharing plan sponsored by Ascensus, which obtained an opinion letter dated June 30, 2020, from the IRS stating that the Plan was in compliance with the applicable sections of the IRC. The Plan has been amended and restated since receiving the opinion letter. The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. No provision for income taxes has been included in the Plan's financial statements.

**NOTE 6 INCOME TAX STATUS (CONTINUED)**

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**NOTE 8 RISK AND UNCERTAINTIES**

The Plan invests in various types of investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur, in the near term, and that such changes could materially affect participants' accounts balances and the amounts reported in the Statements of Net Assets Available for Benefits.

**NOTE 10 QUALIFIED NONELECTIVE CONTRIBUTIONS**

In 2025, the Plan Sponsor identified operational errors related to the application of automatic enrollment provisions and the correction of participant deferral elections for the 2022 through 2024 Plan years. Specifically, certain eligible employees were not automatically enrolled in the Plan, and incorrect deferral percentages were applied to some participants' contributions. These errors also resulted in missed employer matching contributions for the affected participants.

In accordance with IRS and Department of Labor correction guidance, a Qualified Nonelective Contribution (QNEC) is required to compensate affected participants for missed deferral opportunities and related employer matching contributions.

Accordingly, corrective contributions totaling \$31,243 and \$20,729, along with the related lost earnings of \$2,146 and \$3,414 for the years ended December 31, 2024 and 2023, respectively, were deposited into the Plan on June 30, 2025. These amounts have been recognized as other employer contributions receivable in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, respectively. The corresponding addition to other employer contributions and investment income have been recorded in the Statements of Changes in Net Assets Available for Benefits. These QNEC amounts and associated lost earnings are fully vested upon contribution and are intended to restore the benefits of participants impacted by the identified operational errors.

**NOTE 11      NEW LAWS AND REGULATIONS**

On December 29, 2022, the Setting Every Community Up for Retirement Enhancement 2.0 Act of 2022 (SECURE 2.0) became law. The new law makes changes to include provisions intended to expand coverage, increase retirement savings, and simplify and clarify retirement plan rules. SECURE 2.0 changed the retirement plan rules for long-term, part-time employees. The 401(k) plan requirement to allow employees to contribute elective deferral was expanded to 403(b) plans.

For plan years beginning in 2024, if an employee has three consecutive 12-month periods with more than 500 hours of service in each, the employee must be eligible to enter the plan, and the period of service was reduced from three to two consecutive 12-month periods, for plans years beginning after December 31, 2024. The Plan will implement this legislative change and plans to formally execute the required plan amendments reflecting their implementation by the deadline, which is December 31, 2026.

The IRS issued proposed regulations in February 2023 addressing the use and timing of forfeitures in qualified retirement plans. These regulations apply to plan years beginning on or after January 1, 2024. The regulation states that forfeitures must be used no later than 12 months after the end of the plan year in which the forfeitures were incurred. However, the transition rule also provides that any forfeitures that were incurred in any plan year beginning before 2024 are treated as having been incurred in the first plan year that begins on or after January 1, 2024, and, thus, must be used no later than December 31, 2025, for a calendar year plan. The Plan will ensure that all forfeitures from years prior to 2024 are used by December 31, 2025, to comply with this requirement.

For plan years beginning in 2026, catch-up contributions for participants age 50 or older earning more than \$145,000 annually will be required to be made on a Roth (after-tax) basis. Management is monitoring regulatory guidance and evaluating administrative updates required to comply with this provision.

**NOTE 12      SUBSEQUENT EVENTS**

The Plan Administrator has evaluated events or transactions that occurred subsequent to December 31, 2024 through September 25, 2025, the date the accompanying financial statements were available to be issued, for potential recognition or disclosure in the financial statements and determined that no subsequent events occurred that required disclosure or adjustment to the accompanying financial statements other than the matter described below:

During 2025, the Plan Sponsor identified the need to fund a QNEC related to operational errors from 2022 through 2024 Plan years. The QNEC and associated lost earnings were accrued in the accompanying financial statements and were deposited into the Plan on June 30, 2025. See Note 10 for details.
