INDEPENDENT AUDITOR'S REPORT

**To the Plan Administrator of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of American Orthopedic Partners LLC 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements (financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

NOTES TO FINANCIAL STATEMENTS **DECEMBER 31, 2024 AND 2023**

1. DESCRIPTION OF PLAN

The following description of the American Orthopedic Partners LLC 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was established effective February 1, 2021, and was most recently restated effective January 1, 2024 (“Restatement Date”). The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan covers all eligible employees of American Orthopedic Partners LLC and its affiliated companies: Hand Surgery Associates, SC; McCulloch Orthopedic Surgical Services, PLLC; Orthopaedic Spine Specialists of NJ, LLC; and as of the Restatement Date, Premier Orthopaedic & Sports Medicine Associates of Southern New Jersey LLC (“POA”); Premier Orthopaedic Associates Surgical Center, LLC; Surgical Studios, LLC (the three new entities are collectively referred to as the “POA Entities”) (all entities collectively, “the Company” or “Employer”) who have attained the age of 21 and completed three months of service, as defined. Eligible employees include all employees except those that are collectively bargained employees, non-resident aliens, and leased employees. The effective date of participation is the first day of each calendar month coinciding with or next following the date the eligibility requirements are met.

Plan Mergers

Effective January 1, 2024, merger agreements were executed by the Plan and the POA Entities’ three defined contribution plans, POA 401(k) Plan #1, POA 401(k) Plan #2, and POA Profit Sharing Plan, (collectively, the "POA Plans"). In connection with the mergers, approximately \$11,995,000 in plan assets and related participant accounts from the POA Plans at John Hancock Life Insurance Company were merged into the Plan on January 1, 2024. The transfer of plan assets and participant accounts to Ascensus Trust Company was completed on April 4, 2024. In connection with the transfer to Ascensus Trust Company, there was a blackout period beginning on March 28, 2024.

Contributions

The Plan allows for both pre-tax and Roth elective deferrals. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Rollover contributions are subject to the terms of the Plan and are fully vested and non-forfeitable.

Effective July 1, 2023, the Plan includes an automatic enrollment feature whereby new employees who meet the eligibility requirements will be automatically enrolled into the plan

with an elective deferral rate of 3% of eligible compensation, as defined, unless the employee makes an affirmative election otherwise. Automatically enrolled participants will have their deferral rate automatically increased in increments of 1% per year up to a maximum of 6%, unless a participant affirmatively elects otherwise. The automatic increase provision takes effect January 1st, 2025.

As of the Restatement Date, profit sharing contributions are no longer permitted, and the related vesting schedule was removed from the Plan document.

The Company makes safe harbor contributions to the Plan equal to 3% of the participant's eligible compensation, as defined. For the year ended December 31, 2024, the Company made safe harbor contributions of \$995,663 to the Plan. Contributions are subject to certain statutory limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and employer safe harbor contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their accounts into various investment options offered by the Plan. If participants do not select an investment option, their accounts under the Plan are automatically invested in the Plan's Qualified Default Investment Alternative ("QDIA"), unless the employee elects otherwise. The Plan has elected the Vanguard Target Retirement Date Fund series as its QDIA.

Vesting

Participants are vested immediately in their contributions and employer safe harbor contributions plus actual earnings thereon.

Vesting in the profit sharing contribution portions of accounts merged into the Plan from the POA Plans follow a 6 year graded vesting schedule.

Prior to the Restatement Date, vesting in the Company's profit sharing contributions followed a 6 year graded vesting schedule.

Notes Receivable from Participants

New participant loans are not permitted by the Plan.

In connection with the merger of the POA Plans, participant loans of approximately \$80,000 were transferred into the Plan. Notes receivable from participants are secured by the balance in the participant's account. The interest rate on outstanding loans at December 31, 2024 ranged from 4.25% to 9.50%. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability, retirement or other reasons, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. Participants shall be entitled to receive in-service withdrawals upon attainment of age 59 ½ or as a hardship distribution, as defined in the Plan document.

Forfeitures

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$41,243 and \$1,445, respectively. The Company may use forfeitures to reduce employer contributions or pay Plan expenses. For the year ended December 31, 2024, the Plan did not use any forfeited non-vested accounts to reduce employer contributions or pay Plan expenses.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net

change in fair value of investments includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are recorded as distributions based on the terms of the Plan document.

Contributions

Contributions from Plan participants are recorded in the year in which the participant contributions are withheld from compensation. Employer contributions from the Company are based off compensation paid to the participants during the year.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net change in fair value of investments.

3. CERTIFIED INFORMATION

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments, at fair value, and notes receivable from participants held at December 31, 2024 and 2023, and net change in fair value of investments, interest and dividends, and interest income from notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus, LLC acting as an agent for Ascensus Trust Company (a wholly owned subsidiary), the trustee of the Plan.

In connection with the Plan Mergers discussed in Note 1, investment income related to the merged assets from the POA Plans was certified as complete and accurate by John Hancock Life Insurance Company during period January 1, 2024 through April 4, 2024.

The Plan includes a self-directed brokerage option (“SDB”). The underlying investments held in the SDB and related investment income are not certified by Ascensus, LLC. At December 31, 2024 and 2023, investments in the SDB totaled \$91,755 and \$53,420 respectively, and are included in investments, at fair value on the statements of net assets available for benefits. For the year ended December 31, 2024, the SDB had \$35,648 of investment income which is included in net change in fair value of investments on the statement of changes in net assets available for benefits.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds

Valued at the daily closing price as reported by the fund. The mutual funds held by the Plan are deemed to be actively traded.

Self-directed brokerage accounts

Accounts primarily consist of common stock, exchange traded funds, and money market funds that are valued on the basis of readily determinable quoted market prices.

5. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments are shares of mutual funds managed by The Vanguard Group, Inc ("Vanguard"). During the year ended December 31, 2024, the Plan paid approximately \$33,000 in administrative fees to Vanguard. Vanguard is the Plan's recordkeeper and therefore certain transactions qualify as exempt party-in-interest transactions.

Alliant Insurance Services Inc. (“Alliant”) is the advisor of the Plan, and therefore certain transactions qualify as exempt party-in-interest transactions. Advisory fees of approximately \$36,000 were paid from the Plan to Alliant during the year ended December 31, 2024.

Participant contributions not transmitted by the Company within the time period set forth in the Department of Labor’s regulation CFR 2510.3-102 are considered nonexempt prohibited transactions under ERISA. Participant contributions remitted during the year that constitute nonexempt prohibited transactions are reported by the Plan in the accompanying supplemental schedule as required.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

7. TAX STATUS

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (“IRS”) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (“IRC”). Although the Plan has been amended since adopting the pre-approved plan document, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

9. SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

Effective September 30, 2025, the Plan was amended to remove Premier Orthopaedic Associates Surgical Center, LLC and Surgical Studios, LLC as participating employers in the Plan.


