Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Community Labor Administrative Services, Inc. 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and December 31, 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Opinion

Note 1 – Description of the Plan

General

The following description of the Community Labor Administrative Services, Inc. 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

The Plan is a defined contribution plan covering all eligible employees of Community Labor Administrative Services, Inc. (the “Organization”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). All employees of Community Labor Administrative Services, Inc. (the “Organization”) who reached the age of 21 and have completed one year of eligible services are eligible to participate in the Plan. A participant is credited with one year of eligible service when they complete at least 1,000 hours of services by the anniversary of their hire date. The Organization is responsible for oversight of the Plan, determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

Contributions

Participants may contribute a portion of their pre-tax annual compensation subject to certain limitations in the Internal Revenue Code (“IRC”). Roth deferrals may be made to the Plan. The Organization makes a safe harbor enhanced matching contribution equal to 100% of participants’ salary deferrals not to exceed 6% of their compensation. The Organization may also make a discretionary matching contribution equal to a uniform percentage of participants’ salary deferrals.

Participants may also contribute rollover amounts representing distributions from other eligible retirement plans.

Investment options

Each participant may direct the investment of their account into investment options offered by the Plan. The assets of the Plan are allocated to the applicable funds at the direction of the participants.

Participant accounts

Each participant’s account is credited with the (a) participant’s contribution, (b) allocations of the Organization’s safe harbor and discretionary contribution, if any, and (c) Plan earnings net of an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Note 1 – Description of the Plan (continued)

Vesting

Participants are immediately vested in their and the Organization's contributions plus actual earnings thereon.

Forfeitures

As of December 31, 2024 forfeited accounts totaled \$4,606 and included in U.S Government cash reserve. Forfeited accounts may be used to reduce future employer contributions and/or to pay administrative expenses of the Plan, as determined by the Organization, at its sole discretion. For the year ended December 31, 2024, no forfeitures were used to reduce Plan expenses.

Notes receivable from participants

Under the terms of the Plan, participants may borrow from their accounts a minimum of \$1,000 up to a maximum of the lower of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates equal to the prime rate plus 1%. Principal and interest is paid ratably through payroll deductions or payment by check over no longer than a five-year period. The five-year period may be extended to a longer term if the participant is borrowing to purchase a principal residence. Participants are limited to one outstanding loan at a time. As of December 31, 2024, interest rates on the outstanding notes receivable from participants range from 4.25% to 9.50% and the outstanding participant notes receivable totaled \$181,233. No allowance for credit losses has been recorded as of December 31, 2024 and December 31, 2023.

Payment of benefits

On termination of service due to death, disability, retirement, or separation from service, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, partial withdrawals or periodic payments as further outlined in the Plan document.

In addition, participants may elect in-service withdrawals of their elective deferral account balance upon attainment of age 59½ or may elect a distribution in the case of a financial hardship. Minimum required distributions for participants who have reached an age established by the Internal Revenue Service ("IRS") also apply.

Note 2 – Summary of significant accounting policies

Basis of accounting

The Plan's financial statements are prepared on the accrual basis of accounting, except for benefits paid which are recorded on a cash basis.

Investment valuations and income recognition

The Plan's investments are reported at fair value.

Investment valuations and income recognition (continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividends are recorded when received. Realized and unrealized gains and losses from the investments in each account are credited to or charged against each account.

Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Fair value measurements

For assets measured at fair value on a recurring basis, Accounting Standards Codified Topic *Fair Value Measurements* requires quantitative disclosures about the fair value measurement separately for each major class of assets. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and the lowest priority to unobservable inputs. The three levels of the fair value hierarchy are as follows:

Level 1 - Unadjusted quoted prices in active markets for identical assets.

Level 2 - Quoted prices for identical assets in markets that are not active, quoted prices for similar assets in active markets, inputs other than quoted market prices, and inputs derived principally from observable market data.

Level 3 - Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024:

- *Mutual Funds*: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Administrative expenses

Substantially all of the administrative expenses of the Plan are paid by the Organization and are not reflected in the accompanying financial statements. Certain other transaction-related participant expenses, such as those associated with loan maintenance and administration, are paid by the Plan and are included in the accompanying financial statements.

Certain administrative functions are performed by officers or employees of the Organization. No such officer or employee receives compensation from the Plan.

Contributions

Contributions from participants are recorded as they are withheld from the participants' wages. Contributions from the Organization are recorded when earned.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and December 31, 2023.

Payment of benefits

Benefit payments to participants or their beneficiaries are recorded when paid.

Risks and uncertainties

The Plan's investments are exposed to various risks such as interest rate, market, credit and liquidity. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits as of December 31, 2024. The Plan's investments are not insured or protected by the Pension Benefit Guaranty Corporation, or any other governmental agency, accordingly, the Plan is subject to the normal investment risks associated with investments. Any default on notes receivable from participants would be treated as a taxable distribution to the participant.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the amounts reported in the financial statements. Actual results could differ from these estimates.

Subsequent events

Note 3 – Information certified by the Plan’s Trustee

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Trust Company, LLC, the Trustee of the Plan, has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and December 31, 2023, the Supplemental Schedule H – Part IV – Line 4(i) – Schedule of Assets (Held at End of Year) as of December 31, 2024 and the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

Note 4 – Party-in-interest transactions

Empower Trust Company, LLC, is the Trustee as defined by the Plan. Transactions with the Trustee qualify as party-in-interest.

Certain investment and administrative fees related to the Plan were paid by the Plan or by the Organization. These transactions also qualify as party-in-interest.

Note 5 – Plan termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to terminate the Plan, subject to the provisions of ERISA.

Note 6 – Tax status

The IRS has determined and informed the Plan that the Plan is designed, in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified.
