Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Post University, Inc. 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). NOTE 1 – DESCRIPTION OF THE PLAN

The following description of Post University, Inc. 401(k) Retirement Plan (the Plan) is provided for general information purposes only. More complete information regarding the Plan's provisions may be found in the Plan document.

General

The Plan is a defined contribution plan which was established on October 23, 2004 and most recently amended on May 11, 2023. The Plan is sponsored by Post University, Inc. (the Company). Substantially all employees of the Company who have reached age 21 are eligible to participate in the Plan. Employees may enter the Plan on the first day of the month after meeting the age requirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration

The Plan is administered by both the Company and Vanguard Fiduciary Trust Company (Vanguard). Among other duties, it is the responsibility of the administrators to interpret the Plan, decide on questions of eligibility, determine the amount and manner of benefit payments and maintain administrative records of the Plan. The Plan's custodian for all assets as of December 31, 2024 and 2023 and for the year ended December 31, 2024, was Vanguard.

Trustee

The trustee of the Plan is Vanguard. The primary duties of the trustee are to authorize investments and monitor payment of contributions, loans and benefits as directed by the Plan administrators.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's contributions, as well as an allocation of Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Notes Receivable from Participants

The Plan permits participants to borrow from their fund accounts up to a maximum amount equal to the lesser of \$50,000 or 50 percent of their vested account balance. Such borrowings are secured by the balance in the participant's account and bear interest at rates ranging from 4.25 to 9.5 percent. Principal and interest is paid ratably through bi-weekly payroll deductions.

Contributions

Participants – The Plan permits each participant, at their option, to elect to contribute 1 to 100 percent of pretax compensation as a basic contribution or after-tax compensation as a Roth contribution to the Plan, not to exceed the Internal Revenue Service (IRS) limitations. For the year ended December 31, 2024, the maximum pretax salary deferral was limited to \$23,000. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-

up contributions. Participants may also contribute amounts representing distributions from other qualified defined contribution plans (rollovers). The Plan currently offers various mutual funds and a common/collective trust as investment options for participants. Participants are fully-vested immediately in their contributions plus actual earnings thereon.

Employer – Participants are eligible to receive fully-vested safe harbor matching contributions under the Plan once they have completed one year of service and have reached the age of 21. Safe harbor matching contributions are equal to 100 percent of participant’s annual contribution up to the first 4 percent of the participant’s eligible Plan compensation. Total contributions for each participant are subject to certain IRS limitations. Company contributions vest in-full immediately.

Payment of Benefits

Participants may receive distributions from their accounts upon attainment of age 59½, retirement as a result of disability, incurrence of a financial hardship (as defined), termination of their employment with the Company, death, or termination of the Plan. The participant may elect to receive either a lump-sum amount equal to the value of the participant’s account balance, or installments over a period not to exceed the participant’s assumed life expectancy. For eligible participants receiving a required minimum distribution, the vested balance will be paid out in installments over a period not to exceed the participant’s assumed life expectancy.

Forfeitures

Forfeitures are created when a participant terminates employment before becoming entitled to 100 percent of the amounts derived from the employer’s contributions. The Plan provides 100 percent vesting at all times and therefore, no forfeitures will arise upon a participant’s termination.

Plan Termination

Although the Company has not expressed any intent to discontinue the Plan, the Company may do so at any time subject to the provisions of ERISA. In the event of termination, assets of the Plan would be allocated to all participants and distributed in lump sum payments.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the cash basis of accounting. Contributions by the participants and the employer are recognized when received by the trustee and withdrawals from the Plan are recognized when paid to the participants. Therefore, these financial statements are not intended to be a presentation in conformity with accounting principles generally accepted in the United States of America.

Investment contracts held by a defined-contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan does not have any fully benefit-responsive investments.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value as determined by Vanguard. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the cash basis. Dividends are recorded on the ex-dividend date. Net increase in fair value includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance. No allowances for credit losses have been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrators deem the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Administrative Expenses

Plan investments are subject to certain investment fees based on a percentage of invested assets. Such fees are included within the net increase in fair value of mutual funds on the accompanying statement of changes in net assets available for benefits. The Plan also incurred record-keeping fees which are allocated to participant accounts on a pro-rata basis and are reflected as administrative expenses on the accompanying statement of changes in net assets available for benefits. Participant loan accounts are assessed separate fees for the administration of loans which are paid directly by the participant through proceeds of the loan and are excluded from these financial statements. All other administrative expenses related to the Plan are paid by the Company.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Subsequent Events

Plan management has evaluated subsequent events through the date of the auditors' report, October 8, 2025 which is the date the accompanying financial statements were available to be issued.

NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. That framework gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under the Financial Accounting Standards Board's *Accounting Standards Codification (ASC) 820* are described as follows:

- a) Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- b) Level 2 Inputs to the valuation methodology include:
- quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- c) Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for investments measured at fair value at December 31, 2024 and 2023. There was no change in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trust: Valued at the NAV of units of a collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of a collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidation will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of a different methodology or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following tables set forth by level, within the fair value hierarchy, the Plan's investments at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

NOTE 4 – TRUST CERTIFICATION

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, net increase in fair value of investments, dividends from investments and interest income from notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Vanguard.

NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS

Certain of the Plan's investments are managed by Vanguard, and therefore, these transactions also qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net increase in fair value of investments on the accompanying statement of changes in net assets available for benefits.

The Plan also paid fees to Vanguard for administrative services which amounted to \$10,854 for the year ended December 31, 2024, which are reflected as administrative expenses on the accompanying statement of changes in net assets available for benefits.

NOTE 6 – TAX STATUS

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust has been designed in accordance with the applicable sections of the Internal Revenue Code. Although the Plan has been amended since receiving the advisory letter, the Plan administrators believe that the Plan is currently being operated in compliance with the applicable requirements of the Internal Revenue Code, and therefore believe that the Plan is qualified and the related trust is tax-exempt.

NOTE 7 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8 – NON-EXEMPT PROHIBITED TRANSACTIONS

During the year ended December 31, 2024, the Company inadvertently failed to deposit \$3,633, in employee contributions and loan repayments within the required timeframe as required by the DOL. These amounts were deposited beyond the earliest expected date on which assets could be segregated from the Company' assets. The DOL considers late deposits to be prohibited transactions. The lost earnings related to the late deposits will be calculated and remitted to the Plan during the year ending December 31, 2025.
