INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees
Channellock, Inc. 401(k) Plan for Non-Bargaining Unit Employees
Meadville, Pennsylvania

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Channellock, Inc. 401(k) Plan for Non-Bargaining Unit Employees (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



1. Description of Plan

General

The following description of the Channellock, Inc. 401(k) Plan for Non-Bargaining Unit Employees (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan, established September 1, 1996, covering all employees of Channellock, Inc. (the Plan Sponsor) who are not covered under the United Steelworkers or the International Association of Machinists Unions. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was most recently restated effective January 1, 2021.

Effective at the close of business on July 29, 2022, Tamarack Packaging Limited was acquired by an unrelated party. As a result, net assets totaling \$1,292,558 were transferred to the control of the acquirer's 401(k) plan on January 31, 2023.

Contributions

Each year, participants may contribute any amount up to the maximum percentage or dollar amount as permissible by the Internal Revenue Service (IRS).

The Plan Sponsor has reserved the right to make matching contributions, according to a discretionary formula (not to exceed 100% of each participant's maximum contribution). During the years ended December 31, 2024 and 2023, of the first 6% deferred by the participant, the Plan Sponsor elected to make a matching contribution equal to 50% of a participant's deferral, not to exceed 3% of the participant's compensation, which totaled approximately \$151,000 and \$162,000, respectively. Additionally, the Plan Sponsor elected to make a discretionary contribution of \$300,000, allocated to participants based on their salary, during the year ended December 31, 2023.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocation of the Plan Sponsor's contribution and Plan earnings. Allocations are based on participant earnings or account balances, as defined. The participants may direct the choice of investments within their account based on the investment funds offered by the Plan. The benefit to which a participant is entitled is limited to the amount that can be provided from the participant's vested account. Any related forfeitures may be used to reduce Plan Sponsor contributions for the succeeding Plan year or be applied towards the Plan's administrative expenses.

Payment of Benefits

On termination of service due to death, disability, separation of service or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount, or elect to rollover the balance directly to another qualified plan. Benefit payments to participants are recorded upon distribution.

Withdrawals

Hardship and in-service withdrawals are permitted by the Plan, following certain guidelines detailed in the Plan document.

Forfeitures

Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. These forfeited amounts are used at the Plan Sponsor's discretion, principally to reduce the Plan Sponsor's matching contribution and non-elective contributions, or to pay administrative expenses of the Plan. For the years ended December 31, 2024 and 2023, the Plan Sponsor used forfeitures totaling \$70,214 and \$110,766, respectively, to offset Plan Sponsor contributions to the Plan and pay administrative expenses. At December 31, 2024 and 2023, the forfeiture balance totaled \$6,971 and \$39,778, respectively.

Vesting

Participants are immediately vested in their contributions, plus earnings thereon. Vesting in the Plan Sponsor's discretionary matching and other discretionary contributions plus actual earnings thereon is based on the following vesting schedule for years of continuous service:

<u>Years of Service</u>	<u>Vested Percentage</u>
Less than 2 years	0%
2 years but less than 3 years	20%
3 years but less than 4 years	40%
4 years but less than 5 years	60%
5 years but less than 6 years	80%
6 years or more	100%

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, not to exceed 100% of the participant's contributions. The maximum amount is reduced by the excess of the Participant's highest outstanding balance of all loans on any day during the one year period ending on the day before the loan is made, over the outstanding balance of loans from the Plan on the date the Participant's loan is made. The maximum number of outstanding loans that a Participant can have at one time is two. Loan transactions are treated as a transfer to (from) the investment fund from (to) the Participant Loans fund. Loan terms range from 1 to 5 years with longer terms available at the discretion of the Plan Administrator for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a reasonable rate commensurate with interest rates charged for similar loans. Principal and interest are paid ratably through payroll deductions.

Administrative Expenses

For both years ended December 31, 2024 and 2023, the administrative costs for investment advisory, recordkeeping, accounting and auditing fees, which are not material, were paid by the Plan. These fees are reflected in the Plan's financial statements.

Plan Termination

Although it has not expressed any intention to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions set forth under ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements and accounting records of the Plan are presented on the accrual method of accounting, which recognizes additions to and deductions from net assets when the contributions are withheld, income is earned, and liabilities are incurred.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts. Contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Because the group annuity contract is fully benefit-responsive, it is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by the custodians, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Transactions with Channellock, Inc. 401(k) Plan for Bargaining Unit Employees (Union Plan)

Transfers between the Plan and the Union Plan occur when a Plan participant ceases (agrees) to be bound by the collective bargaining agreement. Investments transferred between the plans are valued using the methods described above and are recognized at the time of transfer.

Subsequent Events

The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.

3. Investments

For the years ended December 31, 2024 and 2023, the Plan Administrator elected the method of compliance permitted under ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, all investment information disclosed in the accompanying financial statements and supplemental schedules, including investments held at December 31, 2024 and 2023, net realized and unrealized appreciation in fair value of investments, interest and dividend income, and administrative expenses for the years ended December 31, 2024 and 2023, were obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by the custodian, Empower Trust Company, LLC.

4. Fair Value Measurements

Investments are recorded at their estimated fair value, in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) *Fair Value Measurements and Disclosures* topic. This topic establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under this topic are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

4. Fair Value Measurements (continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds – registered investment companies: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. The following tables set forth by level, within the fair value hierarchy, the Plan's investments at fair value as of December 31, 2024 and 2023:

5. Investment Contract with Insurance Company

The Plan holds a group annuity contract with Empower Annuity Insurance Company of America. The group annuity contract, Key Guaranteed Portfolio Fund, is part of the general account of Empower Annuity Insurance Company of America. The methodology for calculating the interest credit rate is based on the earnings of the underlying assets in the entire medium long-term new portfolio compared to the minimum interest crediting rate (which will never be less than 0% as stated in the contract), and prevailing market conditions. The interest crediting rate is reset quarterly. The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount recognized by participants if they were to initiate permitted transactions under the terms of the Plan. At December 31, 2024 and 2023, the Key Guaranteed Portfolio Fund's contract value totaled \$642,994 and \$624,422, respectively.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The fixed annuity investment contract issuer is contractually obligated to repay the principal at a specified interest rate that is guaranteed to the Plan.

5. Investment Contract with Insurance Company (continued)

Certain events limit the ability of the Plan to transact at contract value. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required transaction under ERISA. The Plan Administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

6. Plan Administrator

The Plan provides for appointment of a committee to act as the Plan Administrator, and a custodian to receive contributions and to hold and invest them exclusively for the benefit of participants and beneficiaries.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. Income Tax Status

The Plan, established as a non-standardized plan, is designed to comply with the applicable requirements under Section 401 of the Internal Revenue Code (IRC) and is, therefore, not subject to tax under present income tax law. The Plan has been amended since receiving its original determination. The Plan Administrator is not aware of any course of action or series of events that might adversely affect the Plan's qualified status other than late filing of the 2023 final 5500.

During 2024, the Plan Sponsor failed to remit to the Plan in a timely manner certain participant elective deferral contributions totaling \$95. The Plan Sponsor funded these late remittances to the Plan during the year ended December 31, 2024. The Plan Sponsor is still evaluating lost earnings on the late remittances and expects to remit lost earnings to affected participants during the year ended December 31, 2025. These matters are deemed to be "self-corrected" under the IRS SCP; therefore, the Plan Sponsor believes that no formal corrective notification to the IRS or the DOL is required. The Plan Administrator believes the necessary steps were taken to properly correct the error in order to maintain the Plan's qualified status and operate in compliance with the IRC.

During 2023, several participants required corrective contributions as their contribution balances did not match payroll. The deficiency in deposits totaled \$150. The Plan Administrator evaluated the error and remitted the late contributions and reimbursement for lost earnings or profits on January 15, 2025. These matters are deemed to be "self-corrected" under the IRS SCP; therefore, the Plan Sponsor believes that no formal corrective notification to the IRS or the DOL is required. The Plan Administrator believes the necessary steps were taken to properly correct the error in order to maintain the Plan's qualified status and operate in compliance with the IRC.

8. Income Tax Status (continued)

The FASB issued guidance on accounting for uncertainty in income taxes. During the years ended December 31, 2024 and 2023, management evaluated the Plan’s tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Sponsor believes it is no longer subject to income tax examinations for years ended prior to December 31, 2021.

9. Related-Party Transactions

For the years ended December 31, 2024 and 2023, certain Plan investments are shares of funds managed by Empower Trust Company, LLC. This entity represents the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services, which are not material, are charged directly to Plan participant accounts. These fees are not prohibited as payments are for reasonable compensation for the operation of the Plan.
