Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Kern Radiology Medical Group, Inc. 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.



Notes to Financial Statements

Note 1. Plan Description

The following description of the Kern Radiology Medical Group, Inc. 401(k) Retirement Plan (the Plan) provides only general information with regard to the Plan. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution 401(k) profit sharing plan covering all full-time employees of Kern Radiology Medical Group, Inc. (the Company), who have attained the age of 18 and completed three months of service. An employee is not eligible if the employee is a union employee, nonresident alien or a leased employee. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Company uses the time elapsed method for crediting service. Under the time elapsed method of crediting service, the Plan is generally required to take into account the period of time that elapses while the employee is employed with the employer regardless of the actual number of hours the employee completes during such period.

Contributions:

Each year, participants may contribute up to 50% of pre-tax annual compensation, as defined in the Plan or the amount allowed by the Internal Revenue Service (whichever is less) through payroll deductions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled unless they elect to not participate in Plan. The initial deferral begins at 6% of eligible compensation and increases automatically on an annual basis by 1%, up to a maximum of 10%. The Company may make discretionary employer matching contributions and discretionary employer nonelective contributions. Effective January 1, 2023, the Plan makes safe harbor nonelective contributions of 3% of a participant's compensation. For the year ended December 31, 2024, the employer profit sharing amount was \$246,979 and the safe-harbor non-elective contribution was \$227,331. Contributions are funded annually.

Participant accounts:

Separate accounts are kept for each participant. Each participant's account is credited with the Company's contributions, the employee's contributions, Plan forfeitures, and allocation of Plan earnings and losses and expenses. Allocations of earnings are based on account balances as defined by the Plan. All amounts in participant accounts are participant directed; participants direct the investment of their contributions into various investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes to Financial Statements

Vesting:

Participants are immediately vested in their contributions and safe harbor contributions plus actual earnings thereon. Vesting in the Company's employer contributions plus earnings thereon is based on continuous years of service based on a graded schedule. A participant is 100% vested after 6 years of credited service.

Notes receivable, participants:

A participant may obtain one loan for a minimum of \$1,000 and cannot exceed 50% of their non-forfeitable account balance or \$50,000, whichever is less. The loan bears interest at prime plus 1%. Principal and interest are paid ratably through monthly payroll deductions. The loan is secured by the participant's vested interest in the Plan.

Benefit payments and withdrawals:

Upon retirement, death, disability or termination, a participant may elect to receive a distribution equal to the vested portion of their account balance. Distributions are paid as soon as administratively practicable after the end of the quarter in which the participant terminates. Participants automatically become 100% vested upon death or termination due to disability.

Participants may request for an in-service withdrawals if the participant has reached age 59 ½ and may elect to withdraw all or a portion of the entire vested account while the participant is still employed by the Company. The participant may also request for hardship withdrawals in which the participant may withdraw pre-tax contributions to satisfy specific and heavy financial needs in accordance with Internal Revenue Service Regulations.

Amounts allocated to accounts of persons who, at December 31, 2024, have elected to withdraw from the Plan but have not been paid are \$-0-.

Forfeited accounts:

Forfeitures result from nonvested benefit payments remaining in the Plan for all terminated employees. Upon reaching the break-in-service requirement, as defined in the Plan agreement, forfeitures generated are added to the forfeiture reserve balance. These accounts can be used to reduce future employer contributions, pay Plan fees or be reallocated to participant accounts. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1,271 and \$-0-, respectively. During the year ended December 31, 2024 the Plan used \$7,248 in forfeitures to pay plan expenses.

Note 2. Significant Accounting Policies

Basis of accounting:

The financial statements of the Plan are prepared on the accrual basis of accounting.

Notes to Financial Statements

Use of estimates:

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Investment valuation and income recognition:

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Purchases and sales of investments are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that the changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Notes receivable, participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of 2024 or 2023.

Benefits:

Benefits are recorded when paid.

Plan expenses:

During the year ended December 31, 2024, certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Tax status:

The Plan has been qualified under Section 401(a) of the Internal Revenue Code and, accordingly, income of the Plan is exempt from Federal and state income taxes. The volume submitter Profit Sharing Plan has received a favorable opinion letter from the

Notes to Financial Statements

Internal Revenue Service dated June 30, 2020, in which the Internal Revenue Service stated that the Plan and related trust, as then designed, were in compliance with the applicable requirements of the Internal Revenue Service Code. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

Note 3. Plan Termination

Although it has not expressed intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

Note 4. Fair Value Disclosure

The Financial Accounting Standards Board (FASB) provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB are described as follows: Level 1 - inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access; Level 2 - inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means; Level 3 - inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Registered investment companies (mutual funds): The fair values of mutual funds are valued at quoted market prices which represent the net asset value of shares held by the Plan at year-end.

Common/collective trusts: The fair value of the common/collective trusts are from broker quotations from market makers, original transaction price and recent transactions in recent or similar instruments.

The preceding methods described may produce a fair value calculation that may not be indicative of net realized value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
