December 31, 2024

1. Description of the Plan

The following description of Nippon Shokubai America Industries, Inc. Retirement and 401(k) Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions. Copies of this publication are available from Nippon Shokubai America Industries, Inc. (the “Plan Sponsor”).

General

The Plan is a defined contribution plan covering substantially all employees of the Plan Sponsor who are at least 20½ years of age and have completed six months of qualifying service. Eligible employees can begin making elective deferrals and receive matching and discretionary contributions on the first day of the month following the date eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Contributions

Participants may elect to defer a maximum of 100% of compensation to the Plan, subject to certain Internal Revenue Service (IRS) limitations. Effective April 1, 2023, the Plan was amended to allow Roth contributions. In addition, participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. Participants can change the investment options previously elected at any time.

The Plan Sponsor made matching contributions equal to 100% of the employee’s elective deferral up to 5.5% of the employee’s compensation in 2024 and 2023. The Plan Sponsor may also make discretionary profit-sharing contributions to employees who have completed at least 1,000 hours of service during the plan year and who are employed on the last day of the plan year. No such discretionary profit-sharing contributions were made in 2024 or 2023.

Participant contributions to the Plan are made through periodic payroll deductions. Plan Sponsor matching contributions are remitted to the Plan after each payroll period. Plan Sponsor discretionary profit-sharing contributions, if any, are remitted annually after the end of the plan year. Cash contribution receivables, if any, from the Plan Sponsor are unsecured.

Notes to Financial Statements (continued)

1. Description of the Plan (continued)

Participant Accounts

Individual accounts are maintained for each participant to reflect the participant's contributions, Plan Sponsor contributions, and investment earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions and related earnings thereon. Vesting in the Plan Sponsor's matching and discretionary profit-sharing contributions portion of their accounts plus related earnings thereon is based on years of service, as follows:

Forfeitures

Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Forfeitures totaled \$22,058 in 2024 and \$5,519 in 2023. As of December 31, 2024 and 2023, the Plan has a forfeiture balance (all invested in Stable Value Core Account) of \$1,383 and \$830, respectively, available to reduce Plan Sponsor contributions or pay expenses of the Plan. During 2024 and 2023, \$12 and \$770, respectively, was used to pay expenses of the Plan. During 2024 and 2023, \$21,532 and \$9,197, respectively, was used to reduce Plan Sponsor contributions.

Notes Receivable from Participants

Subject to approval by plan management, participants may borrow from their fund accounts. The minimum amount of the loan is \$1,000, and the maximum amount is the lesser of one-half of the participant's vested account balance or \$50,000. One loan may be outstanding at a time per participant, and the loans generally bear interest at the prime interest rate plus 1%. The loans are generally repayable in level periodic payments over various terms of up to five years. The loans are secured by the balance in the participant's account. Principal and interest are paid ratably through payroll deductions.

1. Description of the Plan (continued)

Payment of Benefits

At any time on or after the age of 59½ or upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount or installments equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. In-service hardship withdrawals are available in certain circumstances.

Termination of the Plan

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, participants will become 100% vested in their accounts.

2. Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP), as are the annual returns filed under applicable provisions of ERISA and the Internal Revenue Code (IRC).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts in the Plan's financial statements. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are invested in funds offered by Transamerica Financial Life Insurance Company, Inc. (Transamerica). The maximum loss, if any, that would be incurred by the Plan if the counterparties to the Plan's investments failed to perform is the recorded amount of such investments. The investments, with the exception of its fully benefit-responsive contract, are stated at fair value. Fully benefit-responsive contracts are valued based on contract value.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

2. Significant Accounting Policies (continued)

Contributions

Contributions from participants, and the related Plan Sponsor matching contributions, are recorded in the year in which the participants' contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Upon default of notes receivable from participants, the entire outstanding principal and interest shall be immediately due and payable. If a distributable event, as defined by the IRC, has occurred, the note receivable will be foreclosed on and be offset against the participant's account balance. If a participant's note receivable is in default, the participant shall be treated as having a taxable deemed distribution whether or not a distribution event has occurred.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain plan administrative expenses are paid by the Plan Sponsor and are excluded from these financial statements. Fees related to administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Certain investment related expenses are included in net realized and unrealized appreciation or depreciation in the fair value of investments.

Subsequent Events

In preparation of the accompanying financial statements, the Plan's management has evaluated subsequent events that have occurred since December 31, 2024 through October 9, 2025, the date the financial statements were available for issuance.

3. Tax Status

The Plan Sponsor adopted a prototype plan sponsored by ERISA Services, Inc., which received a favorable opinion letter from the IRS dated June 1, 2021, which states the prototype plan is designed in accordance with applicable sections of the IRC. The Plan has been amended since the latest opinion letter date; however, the Plan Administrator believes that the Plan is being operated in accordance with applicable requirements of the IRC and, accordingly, remains exempt from income taxes.

4. Certified Information (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held as of December 31, 2024 and 2023, and net realized and unrealized appreciation in the fair value of investments, investment income from stable value core account, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Transamerica.

5. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820, *Fair Value Measurement (Topic 820)*, are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets the Plan has the ability to access.
- Level 2 Inputs to the methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

5. Fair Value Measurements (continued)

The fair value measurement level of the asset or liability within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes to the methodologies used as of December 31, 2024 and 2023

Pooled separate accounts are valued daily at the net asset value (NAV) practical expedient or equivalent based on units of the pooled separate accounts. The NAV, as provided by the Custodian, is used to estimate fair value. The NAV is generally based on the fair value of the underlying investments held by the pooled separate account less its liabilities.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. Stable Value Core Account

The Plan invests in a fully benefit-responsive traditional investment contract held in the Transamerica Stable Value Core Option Account. The contributions are maintained in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Transamerica is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The effective rate of interest is established every January 1 and July 1 and is based on the daily balance, at a rate that is the daily equivalent of the effective annual rate of interest applicable for the six-month period. There is no stated minimum or maximum interest rate. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Because the investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for the portion of the net assets available for benefits attributable to the investment contract. Contract value, as reported to the Plan by Transamerica, represents contributions made under the contract, plus earnings, less participant withdrawals and expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

6. Stable Value Core Account (continued)

Certain events limit the ability of the Plan to transact at contract value with Transamerica. Such events include amendments to the Plan Documents (including complete or partial plan termination or merger with another plan), changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, bankruptcy of the Plan Sponsor or other Plan Sponsor events that cause a significant withdrawal from the Plan, the failure of the trust to qualify for exemption from federal income taxes, or any required prohibited transaction exemption under ERISA or premature termination of the contract. The Plan Administrator does not believe any events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include an uncured violation of the Plan's investment guidelines, a breach of material obligation under the contract, a material misrepresentation or a material amendment to the agreement without consent of the issuer.

7. Other Related Party and Party-in-Interest Transactions

Certain investments are held and managed by Transamerica; therefore, these transactions qualify as party-in-interest transactions.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
