**NOTE 1 - DESCRIPTION OF THE PLAN**

**Plan Description**

The following description of the Transportation Commodities, Inc. 401(k) Savings Plan (the "Plan") is provided for general information purposes only. More complete information regarding the Plan's provisions may be found in the Plan document.

**A. General**

Effective November 1, 1992, Transportation Commodities, Inc. (the "Company") established the Plan as a defined contribution plan under the provisions of Section 401(a) of the Internal Revenue Code (the "IRC"), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Company. Employees who have been employed for 1 year (1,000 hours of service) and are at least 21 years of age are eligible for participation. Effective January 1, 2023, employees who have worked three months and are at least 21 years of age are eligible for participation. Plan entry is at the beginning of the third or ninth month after attaining eligibility. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**B. Contributions**

Participants may elect to defer a percentage of their compensation, as defined in the Plan, up to the maximum annual amount allowable by the IRC. Participants may make Roth contributions into the Plan. In addition, the Company may make discretionary matching contributions. Participants must be employed by the Company on the last day of the Plan year to be eligible to receive an employer matching contribution. The Company made discretionary contributions of \$546,254 for the year ended December 31, 2024.

**C. Vesting**

Participants are immediately vested in their contributions, rollover contributions and actual earnings thereon. Vesting in the Company's matching and discretionary contribution portion of their accounts plus earnings thereon is based on years of continuous service according to the following schedule:

**D. Payment of Benefits**

Upon termination of service, including termination due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Normal retirement age is 65. Early retirement is not permitted. Benefits are recorded when paid.

**NOTE 1 - DESCRIPTION OF THE PLAN (Continued)**

**E. Notes Receivable from Participants**

The Plan allows participants to borrow not less than \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance. A loan is secured by a participant's vested account balance, bears interest at available market financing rates and must be repaid to the Plan in five years unless the loan is used for the purchase of a principal residence, in which case the maximum repayment period is 10 years. The plan administrator establishes the specific terms and conditions of loans to participants. Notes receivable from participants at December 31, 2024 carry interest rates ranging from 4.25% to 9.50%.

**F. Hardship Distributions**

A participant may elect a hardship distribution if it is deemed that the participant has an immediate and heavy financial need, as described by the Plan. This distribution is subject to the applicable federal and state taxes and/or penalties.

**G. Administrative Expenses**

Most administrative expenses are paid by the Company.

**H. Forfeitures**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$22,623 and \$8,651, respectively. Forfeitures totaled \$31,087 in 2024; unapplied forfeitures totaled \$54,829 and \$22,623 for years ended December 31, 2024 and 2023, respectively.

**I. Refund of Excess Contribution**

During years 2024 and 2023, the Plan identified participant and company contributions that exceeded the allowable annual limits determined by the IRC. At December 31, 2024 and 2023, the total excess in participant and company contributions totaled \$127,321 and \$106,564, respectively. Each Plan year's refund of excess contribution is refunded in the subsequent Plan year.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**A. Basis of Accounting**

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

**B. Use of Estimates**

The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

**C. Investment Valuation and Income Recognition**

The participants select how their share of plan assets will be invested among those investment vehicles made available.

GAAP establishes a fair value hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market.

Level 1 – Inputs are quoted prices for identical securities in active markets.

Level 2 – Inputs are based on quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data.

Level 3 – Inputs are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability.

The Common/collective trust is measured at net asset value. Shares may be redeemed any time at net asset value. There are no restrictions on redemptions and no unfunded commitments to purchase additional shares.

Purchases and sales of investments are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Mutual fund capital gains distributions are included in dividends and interest. Net appreciation includes gains and losses on investments bought and sold as well as held during the year.

**D. Risks and Uncertainties**

Plan investments are exposed to various risks such as interest rate, market fluctuations and credit risks. Due to the risk associated with investments, it is at least reasonably possible that changes in market values, interest rates or other factors in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

**NOTE 3 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Information regarding investments held at December 31, 2024 and 2023, and investment income for the year ended December 31, 2024 that is disclosed in the accompanying financial statements and supplemental schedule was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Reliance Trust Company, the trustee of the Plan.

**NOTE 5 - INCOME TAX STATUS**

The Plan has received an opinion letter dated October 06, 2020 from the Internal Revenue Service ("IRC") which stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has since been amended. However, the plan administrator believes that the Plan is currently being operated in compliance with the applicable provisions of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 6 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate or amend the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will be 100% vested in their accounts and Plan assets will be distributed based upon the participants' account balances at the time.

**NOTE 7 - PLAN AMENDMENT**

Effective January 1, 2023, the Plan was amended to change to the deferral eligibility period from 1 year of service to 3 months of service.

**NOTE 8 - PLAN TRANSFER**

Effective January 1, 2024, the Elston-Nationwide Corp. Profit Sharing Plan merged into the Plan. Assets and participant accounts valued at \$843,170 were transferred into the Plan.

**NOTE 9 - SUBSEQUENT EVENTS**

Management has evaluated subsequent events through October 9, 2025, the date on which the financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosures in these financial statements.
