## INDEPENDENT AUDITOR'S REPORT

To the Participants and Plan Administrator of the Advantia Health Retirement Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Advantia Health Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year end December 31, 2024, and the related notes to the financial statements.

Plan management, having determined it is permissible in the circumstances, has elected to have the audits of the Advantia Health Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Plan management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

### Basis for Opinion

### Responsibilities of Plan Management for the Financial Statements

Plan management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Plan management's election of the ERISA Section 103(a)(3)(C) audit does not affect Plan management's responsibility for the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

**1. Description of Plan**

The following description of the Advantia Health Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions. The Plan was originally effective January 1, 2015, and was most recently amended and restated effective November 1, 2021. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

**General**

The Plan is a defined contribution plan covering substantially all employees of Advantia Health LLC and certain of its subsidiaries that have adopted the Plan (the “Plan Sponsor”). Management of the Plan Sponsor controls and manages the operation and administration of the Plan. Fidelity Management Trust Company serves as trustee of the Plan.

**Eligibility**

The Plan covers employees of the Plan Sponsor and adopting employers over the age of 18, with the exception of employees who became employees as a result of an acquisition, merger, or similar transaction. Participants are immediately eligible to make elective deferral contributions. The effective date of participation for safe harbor matching contributions, discretionary matching contributions and discretionary profit sharing contributions will be immediately following the completion of one year of service (as defined by the Plan document).

**Contributions**

Participants may elect to defer up to 90% of their eligible annual compensation, as defined by the Plan document, subject to certain Internal Revenue Code (“IRC”) limitations. Contributions may be designated as Roth 401(k) contributions. In addition, participants who have attained age 50 before the close of the Plan year are eligible to make “catch-up” contributions up to the amount allowable under the IRC. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Plan Sponsor provides safe harbor matching contributions equal to 100% of the first 3% of eligible compensation deferred into the Plan, and 50% of the next 2% calculated on an annual basis. All employees who have attained age 18 and completed one year of service (as defined by the Plan document) are eligible to receive safe harbor matching contributions.

The Plan Sponsor also has the right to make discretionary matching contributions and discretionary profit sharing contributions. All participants who have completed one year of service (as defined by the Plan document) are eligible to receive discretionary matching and profit sharing contributions. Participants must be employed on the last day of the Plan year to receive any discretionary profit sharing contributions. There were no discretionary matching or profit sharing contributions made for the year ended December 31, 2024.

**Participant Accounts**

Each participant’s account is credited with the participant’s contributions, the Plan Sponsor’s safe harbor matching contributions and discretionary matching contributions, if any, as well as allocations of the Plan Sponsor’s discretionary profit sharing contributions, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the amount that can be provided from the participant’s vested account.

**Investments**

Participants direct the investment of their contributions, safe harbor matching contributions, discretionary matching contributions, and discretionary profit sharing contributions into various investment options offered by the Plan.

**Vesting**

Participants are vested immediately in their elective deferral, safe harbor matching contributions, and employer profit sharing contributions plus actual earnings thereon. Participants are vested in discretionary matching contributions portion of their accounts based on years of service. A participant is 0% vested at less than 3 years of service and after 3 years of service, a participant is 100% vested. Participants vest in legacy plan employer sourced contributions based on the vesting schedules of their respective legacy plan provisions as defined by the Plan document.

Notwithstanding the above vesting for the Plan Sponsor's discretionary employer contributions portion of their accounts, a participant will become 100% vested in these accounts upon their attainment of normal retirement age (60) while an employee, death while an employee, or becoming disabled while an employee.

**Forfeited and Unallocated Amounts**

Forfeitures of the Plan Sponsor contributions may be used to pay administrative expenses or to reduce future employer contributions. Unallocated accounts available to the Plan totaled \$0 and \$42,977 as of December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, \$45,793 were used to reduce employer contributions and no amounts were used to pay plan expenses.

**Payment of Benefits**

Upon termination of service due to death, disability, retirement, or otherwise a participant may receive a lump-sum amount equal to the value of the participant's vested interest. Installment payments are also available. If a participant's vested account balance is less than \$7,000 (\$5,000 prior to modification allowed by the SECURE 2.0 Act of 2022) upon termination, the Plan administrator may authorize the benefit payment without the participant's consent. In circumstances when a terminated participant has a vested account balance less than \$1,000, the participant's vested account balance shall be distributed in a lump sum. In circumstances when a terminated participant has a vested account balance greater than \$1,000 but less than \$7,000, if the participant does not elect to have such distribution paid directly to an eligible retirement plan specified by the participant in a direct rollover or to receive the distribution directly, then the Plan administrator will pay the distribution in a direct rollover to an individual retirement account designated by the Plan administrator. Under terms of the Plan, hardships and in-service distributions are also available in certain limited circumstances.

**Notes Receivable from Participants**

Loans to participants are permitted under the Plan. The maximum loan available is \$50,000 or 50 percent of the participant's vested account balance. Interest rates are based on rates available for similar loans from commercial lending institutions. Loans are repayable within five years unless the loan was taken for the purpose of acquiring or rehabilitating the participant's principal residence, in which case the term of the loan may be for a longer period. Participants may only have one loan outstanding at a time. Principal and interest are paid ratably through payroll deductions. The loans are secured by the vested balance in the participant's account. Interest rates as of December 31, 2024 range from 4.25% to 9.50% with loan maturities through 2029.

**2. Summary of Significant Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for the fully benefit-responsive investment contract. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. The financial statements include the fully benefit-responsive investment contract and its related activity on a contract value basis (see Note 5).

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by trustees, custodians and investment advisors. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants (participant loans for Form 5500 reporting purposes) are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

**Contributions**

Contributions from Plan participants, Plan Sponsor safe harbor matching contributions and discretionary matching contributions, if any, are recorded in the year in which the employee contributions are withheld from compensation. Discretionary profit sharing contributions, if any, are recorded in the year in which the related participant compensation was earned.

**Payments of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

All reasonable administrative expenses and fees necessary to operate and administer the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses of maintaining the Plan that are paid directly by the Plan Sponsor are excluded from these financial statements. A participant's account may be charged for expenses associated with a specific optional feature, including administration of participant loans, elected by that participant, and are included in administrative expenses. Certain investment-related expenses are included in the net appreciation in fair value of investments.

**3. Financial Information Certified by a Qualified Institution**

The Plan administrator having determined that it is permissible in the circumstances elected to have the audits of the Plan performed in accordance with ERISA section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information included in the accompanying financial statements and ERISA-required supplemental schedule of assets (held at end of year) was obtained or derived from information obtained by the Plan administrator and certified as complete and accurate by Fidelity Management Trust Company ("Fidelity"), trustee of the Plan and a qualified institution, in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- The information for the mutual funds (registered investment companies), the fully benefit-responsive investment contract and participant loans listed in the schedule of assets (held at end of year) as of December 31, 2024 as shown in the ERISA-required supplemental schedules.

**4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used as of December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. Fully Benefit-Responsive Investment Contract**

Standard Insurance Company Capital Preservation Income Fund

The Plan has an investment in the Standard Insurance Company Capital Preservation Income Fund, a traditional investment contract. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. As of December 31, 2024 and 2023, the contract value amount of the fully-benefit responsive investment contract was \$580,361 and \$589,341, respectively. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by the participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings less participant withdrawals, and administrative expenses.

The Capital Preservation Income Fund is available through a rider to Standard Insurance Company's group annuity contract. The contract issuer is contractually obligated to repay the principal and interest at a specified rate that is guaranteed to the Plan. The Plan owns a promise to pay interest at crediting rates which are announced in advance and guaranteed for a specific period of time as outlined in the group annuity contract. The crediting rate is based on a formula established by the contract issuer but may not be less than 1%. The crediting rate is reviewed on an annual basis for resetting.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. No events have occurred or are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. There are no reserves against the group fixed annuity contract values for credit risk of the contract issuer or otherwise.

**6. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

**7. Prohibited Transactions**

During 2023, 2022 and 2021, the Plan Sponsor failed to remit to the Plan certain employee contributions and loan repayments totaling \$255,252, \$364,865 and \$131,810, respectively, within the period prescribed by the Department of Labor regulations. The Plan Sponsor has made contributions to the affected participants' accounts to compensate the participants for potential lost income due to these processing delays. The Plan Sponsor believes that these transactions do not affect the tax status of the Plan and that they have taken action prescribed by the regulations to remedy such errors.

**8. Plan Termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in any employer contributions for which they were not already vested and the trustee would distribute account balances as permitted by the Plan document.

**9. Tax Status**

Effective November 1, 2021, through the adoption of a Fidelity pre-approved defined contribution plan, the Plan was amended and restated. The Internal Revenue Service (“IRS”) issued an opinion letter dated June 30, 2020, stating that the pre-approved defined contribution plan document as then designed was in accordance with applicable Internal Revenue Code (“IRC”) requirements. Although the Plan has been amended since receiving the opinion letter, management of the Plan believes the Plan is designed and is currently being operated in compliance with applicable requirements of the IRC. Therefore, the Plan administrator believes the Plan, as amended, is qualified and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**10. Related-Party and Party-in-Interest Transactions**

Plan investments include those managed by affiliates of Fidelity Management Trust Company, the trustee of the Plan. An affiliate of Fidelity Management Trust Company provides recordkeeping services to the Plan. Certain expenses are also paid to Fidelity Management Trust Company or affiliates. Therefore, these transactions qualify as party-in-interest transactions. These transactions are not, however, considered prohibited transactions under ERISA regulations. Total administrative expenses paid by the Plan to its service providers amounts to \$110,111 for the year ended December 31, 2024. Additionally, for participants who have elected to take a participant loan, the loans are secured by the respective participant’s account balance.

**11. Subsequent Events**

Effective January 1, 2025, the Plan was amended to change the contribution period for safe harbor matching contributions from Plan year to a payroll period basis.

Management evaluated subsequent events for the Plan through October 14, 2025, the date the financial statements were available to be issued.
