Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Clinical Services Corporate Operations, Inc (CSCO) & Subsidiaries Qualified Retirement Plan (the Plan), formerly the CATO Research LLC Qualified Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

NOTE 1: DESCRIPTION OF PLAN

The following description of the CSCO & Subsidiaries Qualified Retirement Plan (the “Plan”), formerly the Cato Research LLC Qualified Retirement Plan, provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan, established February 1, 1991. During October 2019, the former Plan sponsor, Cato Research LLC, merged with Specialized Medical Services-oncology BV and changed its name to CATO SMS. CATO SMS's parent company, Clinical Services Corporate Operations, Inc. (CSCO) (the “Company”), became the Plan sponsor effective with the merger.

Effective January 1, 2023 the Plan was amended to merge with Pharm-Olam, LLC 401(k) and Profit-Sharing Plan. In addition, effective January 1, 2023, for eligibility purposes, periods of employment with Array Biostatistics, LLC; Nuventra, Inc., Pharm-Olam, LLC, Modus Outcomes, LLP; and Invibe Labs, LLC will be counted.

As a result of the mergers, net assets available for benefits of \$13,648,531 were transferred to the Plan during 2023.

Reliance Trust Company (“Reliance”) served as the Trustee, and ADP Retirement Services served as the record keeper for the Plan for 2024 and 2023. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

An eligible participant, as defined by the Plan, is eligible to participate in the Plan upon attainment of age twenty-one and the completion of one month of service.

Contributions

The Plan includes an eligible automatic enrollment contribution arrangement. Participants are automatically enrolled at a 3% pre-tax deferral contribution upon attainment of the eligibility requirements, unless the Plan receives documentation from the participant before this date to do otherwise.

Eligible employees may elect to contribute between 1% and 50% of their annual compensation on a pre-tax or Roth 401K basis or any combination of the two, as defined in the Plan, subject to certain IRC limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan utilizes a safe harbor design under Internal Revenue Service (“IRS”) regulations in which employee pre-tax, Roth and employer matching contributions are not subject to discrimination testing. Effective January 1, 2023, the Company matches 100% of a participant's contribution, not exceeding 4% of compensation. Safe harbor matching contributions of \$0 and \$53,230 are included in employer contribution receivable at December 31, 2024 and 2023.

The Company may elect to make a discretionary matching contribution equal to a uniform percentage of the participant's salary deferral, not to exceed 4% of compensation. In addition, the Company may also elect to make a profit-sharing contribution on behalf of each participant at the discretion of management. Participants must be employed on the last day of the Plan year to receive the employer profit sharing contribution.

Participant Accounts

Each participant's separate account is credited with the participant's contribution, matching contributions and profit-sharing contributions, if any, and earnings on the account. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment of Benefits

On termination of service due to separation from the Company, retirement, permanent disability or death, a participant may receive a lump-sum amount equal to the value of the participant's vested account. Retirement age is defined as 59 ½. Hardship withdrawals are allowed by the Plan in accordance with Plan provisions and Internal Revenue Service ("IRS") regulations. In-service withdrawals are allowed when the participant reaches retirement age.

Vesting

The Plan provides for full and immediate vesting of the employees and employer matching contributions. Vesting in the profit-sharing contribution portion of the participant's account plus actual earnings thereon is based on years of service. The vesting schedule is as follows:

In conjunction with the merging of the Nuventra Plan on January 1, 2022, all Nuventra employees will be 100% vested in all current and future employer contributions.

Forfeited Accounts

Forfeitures represent nonvested profit sharing contributions of participants that have terminated their employment with the Company. Forfeitures are allocated to participants in the ratio which the compensation of each participant for the plan year bears to total compensation for the plan year. As of December 31, 2024 and 2023, unallocated forfeited balances were \$27,685 and \$20,907.

Notes Receivable from Participants

Participants may borrow from their fund account balances a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. A maximum of two loans per participant may be outstanding at any one time. Loan terms cannot exceed five years unless it is towards the purchase of a principal residence. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 9.50%, which are commensurate with local prevailing rates as determined quarterly by the Plan Administrator. Principal and interest is paid ratably through bi-weekly payroll deductions.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Administrative Expenses

Administrative expenses of the Plan, other than loan processing fees, are paid by the Company.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become fully vested in their account balances.

Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation

The Plan's investments are stated at fair value, except for the common/collective trust fund which is valued at contract value as described in Note 3.

Income Recognition

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Net appreciation (depreciation) in fair value of investments consists of net realized gains and losses on the sale of investments and net unrealized appreciation (depreciation) of investments.

Notes Receivable from Participants

Notes receivable from participants are measured at amortized cost, which represents unpaid principal balance plus accrued but unpaid interest, and are classified as notes receivable from participants.

Risks and Uncertainties

The Plan's investments, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits in the future.

NOTE 3: FAIR VALUE MEASUREMENTS (continued)

A fair value hierarchy (Level 1, Level 2, or Level 3) is used to categorize fair value amounts based on the quality of inputs used to measure fair value. Accordingly, fair values determined by Level 1 inputs utilize unadjusted quoted prices in active markets for identical assets or liabilities. Fair values determined by Level 2 inputs are based on quoted prices for similar assets or liabilities in active markets, and inputs other than quoted prices that are observable for the asset or liability. Level 3 inputs are unobservable inputs for the asset or liability for which there is little, if any, market activity at the measurement date. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair values of its applicable assets and liabilities. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

The valuation methods used to measure the Plan's financial instruments at fair value are as follows:

- Mutual funds are measured at fair value using a market approach based on quotations from national securities exchanges and are categorized in Level 1 of the fair value hierarchy.
- The common/collective trust invests solely in a master trust, which primarily holds investments in fully benefit-responsive investment contracts, and is valued at the net asset value of units of the common/collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. There are no imposed restrictions as to the redemption of these investments.

NOTE 7: TAX STATUS

The Plan obtained its latest opinion letter dated October 6, 2020, in which the Internal Revenue Service stated that ADP Inc. Prototype Non-standardized Profit Sharing Plan with CODA was in compliance with the applicable requirements of the Internal Revenue Code (the “IRC”). The Plan has been amended since receiving the opinion letter. However, the Plan Sponsor and tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdiction; however, there are currently no audits for any tax periods in progress. The Plan sponsor believes the Plan is not subject to tax examinations for Plan years prior to 2021.
