### Report on the Audit of the Financial Statements

#### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of WSGR 401(k) and Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of WSGR 401(k) and Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

#### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. ### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about WSGR 401(k) and Profit Sharing Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Note 1 – The Plan and Its Significant Accounting Policies**

**General** – The following description of the WSGR 401(k) and Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan established in 1987 by Wilson Sonsini Goodrich & Rosati, Professional Corporation (WSGR or the Firm) to provide benefits to eligible employees, as defined in the Plan document. The Plan is designed to be qualified under the applicable requirements of the Internal Revenue Code (Code) and is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Firm is the Plan's sponsor and serves as plan administrator.

**Administration** – The Firm has appointed the WSGR Retirement Benefits Committee (the Committee) to manage the operation and administration of the Plan. Through March 2024, the firm had contracted with Charles Schwab Trust Bank (Charles Schwab) to act as the trustee, and designated an affiliate of Charles Schwab, Schwab Retirement Plan Services, Inc., to serve as a third-party administrator and recordkeeper for the Plan. Effective April 1, 2024, the Plan contracted T. Rowe Price Trust Company (T. Rowe Price) to act as the trustee and custodian and an affiliate of T. Rowe Price to act as a third-party administrator and recordkeeper for the Plan.

SixFifty, a subsidiary of the firm, employees were initially eligible to participate in the plan as part of a control group. Effective January 16, 2024, SixFifty employees were no longer eligible to participate in the plan and spun-off into a new and separate qualified plan. Plan assets of \$1,573,609 were transferred out of the Plan to the SixFifty 401(k) Plan in November 2024.

All reasonable expenses incurred for administering the Plan are paid from the Plan, unless WSGR elects to pay them.

**Estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Basis of accounting** – The financial statements of the Plan are prepared on the accrual method of accounting in accordance with GAAP.

**Forfeited accounts** – Forfeited accounts, under certain circumstances as specified in the Plan, may be used to pay reasonable Plan administrative expenses or reduce future employer discretionary profit sharing contributions and/or restore previously forfeited accounts.

**Investment valuation and income recognition** – The investments are reported at fair value. The Plan's trustees, Charles Schwab and on and after April 1, 2024, T. Rowe Price, certify the fair value of all investments. If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 2 for discussion of fair value measurements.

**Income recognition** – Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net appreciation in fair value of investments includes the Plan's gains and losses on investments bought or sold as well as held during the year.

**Contributions** – Contributions from participants are recorded in the year in which the employee contributions are withheld from compensation.

**Notes receivable from participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions upon the occurrence of a distributable event based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

**Payment of benefits** – Benefits are recorded when paid.

**Income taxes** – The Internal Revenue Service has determined and informed the Firm by a letter dated November 6, 2017, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

In accordance with guidance on accounting for uncertainty in income taxes, the Plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Risks and uncertainties** – The Plan provides for various investment options in any combination of investment securities offered by the Plan. Investment securities are exposed to various risks, such as interest rate, market fluctuations, and credit risks. Due to the risk associated with certain investment securities, it is at least reasonably possible that changes in market values, interest rates, or other factors in the near term would materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

#### **Note 2 – Fair Value Measurements**

The fair value measurements standard establishes a framework for measuring fair value. That framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the standard are described below:

**Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** – Inputs to the valuation methodology include:

- Quoted market prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023.

*Mutual funds* – Valued at the daily closing price as reported by the fund. The funds held by the Plan are open-ended funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

*Common/collective trusts* – Units held in common/collective trusts (CCT) are valued using the NAV practical expedient of the CCT as reported by the CCT managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the CCT, minus its liabilities, and then divided by the number of units outstanding. The NAV practical expedient of a CCT is calculated based on a compilation of primarily observable market information. These investments have daily redemption frequencies and daily redemption notice periods to accommodate distributions to participants of the Plan. Investments are redeemable on a daily basis and there are no trading restrictions outside of restrictions placed due to market timing. There were no unfunded commitments as of December 31, 2024.

*Self-directed brokerage accounts comprised of U.S. government obligations, corporate obligations, real estate investment trusts, and unit investment trusts* – Underlying securities are valued at the closing price reported on the active market on which the individual securities are traded and/or the NAV of shares held by the Plan at year end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note 3 – Related Party Transactions

Certain Plan investments were managed by Schwab Investment Management Company, an affiliate of Charles Schwab, the trustee and custodian of the Plan through March 31, 2024. Further, certain investments are managed by an affiliate of T. Rowe Price, the trustee and custodian of the Plan beginning on April 1, 2024. Transactions with these entities qualify as exempt party-in-interest transactions.

### Note 4 – Participation and Benefits

**Participant contributions** – Participants may elect to have the Firm contribute their eligible pre-tax or after-tax compensation (as Roth contributions) to the Plan up to the amount allowable under the Plan document and current income tax regulations. The Plan also provides for the automatic enrollment of eligible employees in the Plan with a pre-tax contribution of three percent (3%) of eligible compensation, unless the employee timely elects otherwise. Certain participants who are automatically enrolled in the Plan are also subject to an automatic increase in pre-tax deferrals each year by one percent (1%) up to six percent (6%) of eligible compensation, unless the employee timely elects otherwise. Participants who elect to have the Firm contribute a portion of their eligible compensation to the Plan agree to accept an equivalent reduction in taxable or taxed compensation. Contributions withheld are invested in accordance with the participant's direction and the Plan's provisions.

Participants are also allowed to make eligible rollover contributions of amounts received from other tax-qualified plans. Such contributions are deposited in the appropriate investment funds in accordance with the participant's direction and the Plan's provisions.

**Employer contributions** – The Firm may elect to make discretionary profit sharing contributions in amounts and at such times as determined by the Firm. WSGR determines the amount to be allocated among each of two employee groups, as defined in the Plan. A profit sharing eligible participant must be employed by the Firm on the last day of the Plan year and be credited with one year of service (as defined in the Plan) during that Plan year in order to receive a profit sharing contribution (unless the participant's termination of employment during the year was on or after reaching the Plan's normal retirement age, or due to death, or disability, as defined in the Plan). Eligible participants received profit sharing contributions of 13.33% or 9.50% of their eligible compensation for the 2024 Plan year, according to their rate group, not to exceed \$46,000 and \$32,775, respectively.

**Vesting** – Participants are immediately vested in their entire account, including any employer discretionary profit sharing contributions.

**Participant accounts** – Each participant's account is credited with the participant's contribution, Plan earnings or losses, and an allocation of the Firm's contribution. Allocation of the Firm's contribution is based on eligible employee compensation, as defined in the Plan.

**Payment of benefits** – Upon termination of employment with the Firm and its affiliates, participants may elect to leave their account balance in the Plan or receive their total account balance in a lump sum amount subject to the terms of the Plan. Notwithstanding the foregoing, the Plan provides allows for an automatic rollover into an Individual Retirement Account with T. Rowe Price for account balances that do not exceed \$7,000 but are greater than \$1,000. The Plan also provides for an automatic lump-sum distribution of participant account balances that do not exceed \$1,000.

Participants may elect to receive in-service withdrawals from their accounts if they incur a qualifying financial hardship, they attain age 59 1/2 or they get ordered or called to military active duty, subject to the terms of the Plan.

**Notes receivable from participants** – The Plan allows participants who are employees of the Firm or its affiliates and other parties-in-interest to the Plan to borrow not less than \$1,000 and up to the lesser of \$50,000 or 50% of their account balance. The notes receivable are secured by the applicant's account balance. Such notes receivable bear interest at prevailing market financing rates and must be repaid to the Plan within a five-year period, unless the proceeds are used for the purchase of the applicant's principal residence in which case the maximum repayment period may be extended to 15 years. The specific terms and conditions of such notes receivable are established by the Committee. Outstanding notes receivable at December 31, 2024, carry interest rates ranging from 4.50% to 7.50% and mature through August 2039.

The Firm intends to continue the Plan indefinitely for the benefit of its participants; however, it reserves the right to terminate or modify the Plan at any time by resolution of its Board of Directors and subject to the provisions of ERISA. In the event the Plan is terminated in the future, the trust assets will be distributed to participants, or their beneficiaries based on their vested account balances in accordance with Plan provisions and applicable law.

### **Note 7 – Reconciliation to Form 5500**

The Form 5500 has certain items that differ from amounts shown on the accompanying financial statements. These differences relate to classification in reporting earnings only and have no effect upon net assets available for benefits for either period.

### **Note 8 – Subsequent Events**

The Firm has evaluated subsequent events for the Plan through September 19, 2025, which is the date the financial statements were available to be issued.
