## INDEPENDENT AUDITORS' REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of **Costa Salud Savings and Retirement Plan**, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of **Costa Salud Savings and Retirement Plan's** financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ### NOTES TO FINANCIAL STATEMENTS

AS OF DECEMBER 31, 2024 AND 2023, AND FOR THE YEAR ENDED DECEMBER 31, 2024

---

#### 1. DESCRIPTION OF THE PLAN

The following description of the **Costa Salud Savings and Retirement Plan (the "Plan")** is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the **Plan's** information.

**General** — **The Plan** is a defined contribution plan covering substantially all employees of **Costa Salud Community Health Centers, Inc.** (the "Plan Sponsor") effective July 1, 2021, to covers all employees as of the effective date. Employee hired after the effective date of **the Plan** are eligible upon attained the age twenty-one (21) and six (6) months of employment. Employees may enter **the Plan** on the first day of the month coincidental with or next following the date they meet the eligibility criteria.

**The Plan** is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Funding Policy** — **The Plan's** participants cannot, realize any contribution after the payment of contribution (After-Tax). The employer will do a discretionary contribution when finalizing the year. The contribution does not depend on gains that the employer obtains.

**Participant Accounts** — Each participant's account is credited with an allocation of (a) the Company's contribution, (b) Plan earnings, and (c) forfeitures of terminated participants' non-vested accounts. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Investments** — Participants may direct the investment of their contributions and/or account balances into various investment options offered by **the Plan** and may change investments and transfer amounts between funds daily. **The Plan** offers various registered investment companies and mutual funds.

**Vesting** — Participants are vested in their employer contributions after the second year a 20%. Vesting in the Company contributions portion of their accounts plus earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service.

**Notes Receivable from Participants** — Notes receivable from Participants are not permitted.

**Payment of Benefits** — On termination of service with **the Plan** Sponsor (including termination of service due to death, disability, or retirement), a participant may generally elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments if his or her vested interest exceed \$5,000.

**Forfeited Accounts** — When certain terminations of participation in **the Plan** occur, the nonvested portion of the participant's account as defined by **the Plan**, represents a forfeiture. **The plan** document permits the use of forfeitures to either reduce future employer contributions or plan administrative expenses for **the Plan** year. However, if a participant is reemployed and fulfills certain requirements, as defined in **the Plan** document, the account will be reinstated. At December 31, 2024 and 2023, the forfeitures were \$15,002 and \$2,097, respectively.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** — The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Use of Estimates** — The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Risks and Uncertainties** — **The Plan** provides various investment options to its participants. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the value of the participants' account balances and the amounts reported in the financial statements.

**Investment Valuation and Income Recognition** — **The Plan's** investments are stated at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Notes 4 and 5 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

**Loan to Participant** — Loans to participants are not permitted.

**Administrative Expenses** — Administrative expenses of **the Plan** are paid by the Plan Sponsor as provided in the plan document. All investment management and transaction fees directly related to the Plan investments are paid by **the Plan**. Management fees and operating expenses charged to **the Plan** for investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

**Payment of Benefits** — Benefit payments to participants are recorded upon distribution. FASB ASC 962-205-50-1(i) requires disclosure for amounts allocated to accounts of persons who have elected to withdraw from **the Plan** but have not yet been paid. These amounts shall not be reported as a liability on the statement of net assets available for benefits in the financial statements. As of December 31, 2024 and 2023, amounts allocated to accounts of persons who have elected to withdraw from **the Plan** but have not yet been paid were \$10,753 and null, respectively.

**Excess Contributions Payable** — **The Plan** is required to return contributions received during **the Plan** year in excess of the PRIRC limits. There were no excess contributions as of December 31, 2024 and 2023.

**Date of Management's Review of Subsequent Events** — Subsequent events were evaluated through September 29, 2025, the date the financial statements were available to be issued. No events have occurred after December 31, 2024, but before September 29, 2025 that require consideration as adjustment to or disclosure in the financial statements.

### 4. FAIR VALUE MEASUREMENTS

ASC 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value, as follows: Level 1, which refers to securities valued using unadjusted quoted prices from active markets for identical assets; Level 2, which refers to securities not traded on an active market but for which observable market inputs are readily available; and Level 3, which refers to securities valued based on significant unobservable inputs. Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

**Asset Valuation Techniques** — Valuation technologies maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Money Market Funds* — Valued at the amortized cost which approximate fair value.

*Mutual Funds* — Valued at the daily closing price as reported by the fund. Mutual funds held by **the Plan** are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by **the Plan** are deemed to be actively traded.

**Transfers Between Levels** — **The Plan's** policy is to recognize transfers of investments into or out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the year ended December 31, 2024, there were no transfers of investments into or out of Level 3.

## 5. INVESTMENTS

During the year ended December 31, 2024, **the Plan's** investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by \$86,599.

## 6. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Certain Plan cash accounts and investments provided and managed by Banco Popular de Puerto Rico the trustee and recordkeeper, as defined by **the Plan**. Therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid for investment management services amounted to \$100 for the year ended December 31, 2024. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA

## 7. PLAN TERMINATION

Although it has not expressed any intention to do so, **the Plan** has the right under **the Plan** to discontinue its contributions at any time and to terminate **the Plan** subject to the provisions set forth in ERISA. In the event that **the Plan** is terminated, participants would become 100% vested in their accounts.

## 8. INCOME TAX STATUS

The Puerto Rico Treasury Department (PRTD) has determined and informed **the Plan** by a letter dated December 20, 2021, that **the Plan** and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). **The Plan** has not been amended since receiving the determination letter, **the Plan** administrator and **the Plan's** tax counsel believe that **the Plan** is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that **the Plan** is qualified and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in **the Plan's** financial statements.

Accounting principles generally accepted in the United States of America requires Plan management to evaluate tax positions taken by **the Plan** and recognize a tax liability (or asset) if **the Plan** has taken an uncertain position that more likely than not would not be sustained upon examination by the PRTRD. **The Plan** is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. **The Plan** administrator believes it is no longer subject to income tax.
